Fake firms import 15 consignments, face no scanning at port

The importer whose two consignments were seized at Chittagong Port on Sunday for carrying contraband products had taken delivery of 15 consignments in 11 months without facing the mandatory scanning.

These consignments of "capital machinery" in 78 containers were imported from China in the last 11 months to January this year. The two firms which brought in the consignments however don't have any office or factory at the given addresses. The firms are owned by one Khorshed Alam.

According to the data of the

scanning division of Chittagong Customs House, those 78 containers were delivered without the compulsory scanning. The scanning is mandatory when a loaded container is delivered without sealbreaking or physical inspection.

Both the Customs Intelligence Chittagong Customs House. and Investigation Directorate and Chittagong Customs House have launched investigation into the 15 sion. consignments.

Moinul Khan, director-general of the Customs Intelligence, suspects an organised syndicate of criminals was involved in importing illegal or contraband goods in the name of capital machinery.

Containers carrying capital machinery or raw materials are usually allowed on-chassis delivery without seal-breaking or physical inspection to save time for the sake of the industrial sector, said AFM Abdullah Khan, commissioner of

Khan said the culprits might have taken advantage of this provi-

During a visit on Tuesday, no office of clearing and forwarding agent Rabeya & Sons, which cleared the consignments, was found at its given address. The C&F agent has another address shown on the customs' website but that too was found fake.

According to documents, the importer of nine of those consignments was Agro BD & JP of Keraniganj, Dhaka, and the rest was imported by Henan Anhui Agro LC of Khilkhet, Dhaka. But none of the addresses is valid.

The consignments were exported by Jam Raj Industries, China.

On February 5, the customs intelligence recovered huge quantity of contraband liquor, expensive televisions, cigarettes and photocopiers from the two consignments. The estimated value of the items in the containers could be more than Tk 100 crore, officials said.

As a result, the auction prices were very low and no vehicle was released, according to NBR meeting minutes.

Khan said the NBR plans to hold the next auction in the presence of a representative of the Anti-Corruption Commission.

"We also plan to go for wider publicity to get a good response.

He said the NBR chairman may also send a "demi-official" letter to the commerce secretary to issue clearance permits to the auction winners.

"Anyone with a taxpayer's identification number will be able to participate in the auction. No trade licence will be required," he said.

Showkat Ali Saadi, additional commissioner of the customs house in Chittagong, said the date for the auction will be announced soon.

The tax administrator has given authority to the auction committee to cancel the auction, if the quoted prices in the second auction are not satisfactory as well, he said.

Since 1963, the revenue authority has allowed 245 cars under the Carnet de Passages facility. Most of the vehicles were brought in by British-Bangladeshis hailing from Sylhet, according to the NBR officials.

MCCI for raising tax rebate investment limit

It also wants authorities to abolish the scope of discretionary powers of the tax authorities.

The MCCI, citing past experience, said additional taxes were imposed to make up the gap of revenue collection shortfall.

"It is like punishing compliant taxpayers like us," said Golam Mainuddin, vice president of MCCI, at the programme.

In its budget proposal, BCI demanded raising the tax free income limit for individual taxpayers to Tk 3.5 lakh from Tk 2.5 lakh a year at present.

It urged the government to raise the surcharge-free ceiling on net wealth to Tk 5 crore from fiscal 2017-18.

The chamber also appealed the revenue administration to withdraw the advance income tax and advance trade vat on capital machinery and basic raw materials on imports by registered producers.

BCI asked to raise the upper limit on turnover tax to Tk 5 crore a year from Tk 80 lakh a year at present. It also demanded equal treatment and tax incentives for both local and foreign investors.

Weak apparel exports pare down earnings

Britons are suffering from an inflationary pressure due to a fall in the value of the pound.

Similarly, apparel export to the US, the single largest export destination for Bangladesh, declined a bit because of a volatile economy after the national elections. Of the top 10 exporters to the US,

apparel shipments of only three countries were in the negative territory in January. Among the three, Bangladesh's garment export declined 2.31 percent to \$500 million in that month.

Garment exports to the US from India, Pakistan and Vietnam, the major competitors of Bangladesh in the global apparel markets, increased in January.

"People in the western world are now spending more on smart gadgets than on clothing. This is a major reason for a fall in consumption of clothing items worldwide," Rahman said. In July-February, earning from the

garment sector was recorded at \$18.63 billion, which is 2.82 percent higher than that in the corresponding period of the last fiscal year, data showed.

The February receipt from garment export was 5.64 percent lower than the periodic target at \$19.75 billion.

"We need to grow at 12.25 percent every year to reach our export target at \$50 billion at the end of 2021. But we are growing at only 2 to 4 percent now," Rahman said.

The jute and jute goods sector was one of the top export performers in the July-February period, with shipments rising 15.28 percent year-on-year to \$646.62 million. It was also higher than its periodic target of \$626.83 million.

Shipments of leather and leather goods grew well during the eightmonth period as well. It stood at

\$827.62 million, up 9.95 percent yearon-year. This segment too hit its periodic target of \$793.30 million.

Furniture exports rose 16.84 percent to \$28.52 million and pharmaceuticals 9.94 percent to \$60.19 million.

Home textile exports increased 3.16 percent to \$500.15 million and plastic products 39.87 percent to \$82.37 million, riding on the back of a 10 percent cash incentive on shipments. Some sectors performed poorly

during the period. Exports of frozen and live fishes declined 3.89 percent to \$357.95 million. However, it was 1.75 percent higher than the target of \$351.78 million.

Exports of petroleum byproducts declined 31.40 percent to \$158.04 million.

The government has set the export target of \$37 billion for this fiscal year, which is 8 percent higher than the

receipts in fiscal 2015-16.

"It is to be noted that one of our technology partners has already successfully tested 4G in our network," he added.

In the mean time, Robi has launched a campaign on its social media platform to convert all of its SIM cards into 4G-enabled ones. Users will be charged Tk 100 to convert each SIM.

Robi is interested in introducing the service but the whole ecosystem is not yet ready as optical fibre connectivity is a main part of this service, and there is a huge gap in that connectivity, said a top official.

In the auction for 3G spectrum in 2013, the BTRC sold each megahertz of spectrum for \$21 million, and for 4G services, the floor price may be around \$25 million for

each megahertz of spectrum, said BTRC officials. There are around 6.63 crore mobile internet users in Bangladesh, of whom 3 crore use 3G services.
