

# Man kills roommate for cellphones

A man was stabbed to death allegedly by his roommate in Halishahar of Chittagong city early yesterday.  
Maksudur Rahman, 30, son of Bodiul Alam of Swandip upazila, died at Chittagong Medical College Hospital.  
Md Monir, another tenant of the six-room tin-shed house, said Maksudur told them before dying that Hossain, 20, a human hauler driver, also from Swandip, stabbed him to take away his wallet and two cell phones.  
Maksudur's brother filed a case against Hossain whom police are trying to arrest.

discussed various issues of mutual interest including preparatory aspects of the important visit.  
When asked about India's proposed defence cooperation deal with Bangladesh, Shringla said, "Well, you tell me. You are telling me. I don't know."  
Whereas Indian media reported that India is pushing Bangladesh for signing a comprehensive framework defence agreement that encompasses training, sale of military hardware, and a wide range of military to military cooperation, India also offered a supplier line of credit of \$500 million for purchase of defence hardware.  
Asked about Hasina's recent comments that India's intelligence agency RAW helped BNP come to power in 2001, Shringla said, "I cannot make any comment on that. I am sorry."  
He said the dates of the visit would be announced shortly, though officials indicated that it may be in the first half of April.  
Asked whether there would be any breakthrough on the Teesta water sharing deal, the envoy said, "We'll have to see what is possible and what is not possible."  
In another reply, he said, "cooperation in the Ganges barrage is very good and we have set up a joint technical level committee. We have shared terms of references and composition of the committee. So this is also work in progress."  
Foreign ministry officials earlier said during the visit, the prime minister would honour the Indian soldiers who fought for Bangladesh.

Shahid, 26, son of Abdur Sattar of Habirbari area in Bhaluka upazila.  
On information, law enforcers raided the area and arrested Shahid while he along with others were holding a meeting in the area, said Mamun-or-Rashid, officer-in-charge of Bhaluka Police Station.  
The other members, however, could not be arrested as they fled the scene sensing the presence of the law enforcers.  
After interrogation, the arrestee was produced before a Mymensingh court. He was later sent to jail, said Md Hazrat Ali, officer-in-charge (investigation).  
They were arrested around 5:00am, said Abdur Razzak, OC of Pabna Sadar Police Station, adding that the duo were the listed JMB operatives.  
They were accused in three cases filed with the police station for their alleged involvement in regrouping the banned Islamist outfit.  
They were earlier arrested in connection with militant activities, but were freed from jail two years ago.
