in bed fast asleep, only to find the roads deserted amid pouring rain.

A guiding angel in the guise of a police officer appeared and pulled over his vehicle. He asked them if they needed any help, Jamir Uddin, Jannat's father, told this correspondent.

"This officer not only took us on board for a lift to the hospital, but made several phone calls to ensure medical support at the time of our arrival at the hospital."

The officer took them to Shishu Matri Shastho Institute in Matuail, several kilometres away from their rental flat at Merajnagar in Kadamtoli area of the city, said Jamir, a furniture trader by profession.

After arrival, the doctors and nurses on duty gave immediate attention to their daughter while the officer stayed in the hospital till her condition became stable, he added.

The incident went viral on the social media after the officer himself -- Kazi Wazed, officer-in-charge of Kadamtoli Police Station -- posted a status about the incident on his Facebook wall.

Speaking to The Daily Star, Wazed said, "I only performed my duty of helping anyone in need. I pray that she gets well soon."

Thanks to the team of police that came as a blessing, Jannat had received urgent care that night, Jamir said, adding that she has been released from the Matuail hospital and now undergoing diagnostics at Bangabandhu Sheikh Mujib Medical University Hospital.

Prosecutor Rezia Sultana Chaman told the tribunal and prayed to it for showing him arrested in the case.

Though Badruddoza is originally from Narail Sadar, he has been living in Dhaka for many years, Rezia told The Daily Star.

Police arrested him on March 8 from Dakkhinkhan area in the capital in connection with a case filed under Special Powers Act and he is now in Dhaka Central Jail.

Among three other accused, Abdul Wahab and Omar Ali Sheikh are now in jail while Khandakar Shawkat Ali Babul is on the run. All of them were alleged members of Razakar Bahini, an auxiliary force of the Pakistani army.

Meanwhile, the tribunal deferred the closing arguments to April 16 in a case filed against six Gaibandha men over committing crimes during the Liberation War in 1971.

Yesterday was fixed for closing argument but the tribunal fixed the new date as its Chairman Justice Anwarul Haque is now abroad for treatment, Prosecutor Syed Sayedul Haque Sumon said.

Among the accused, Abu Saleh Md Abdul Aziz Mia, a former Jamaat lawmaker and alleged commander of local Razakar force; Ruhul Amin alias Manju, Abu Muslim Md Ali, Najmul Huda, and Abdul Rahim Mia, are on the run. Only Abdul Latif is in jail now.

Meanwhile, the tribunal rejected two petitions of defence counsel Gazi MH Tamim. He filed a petition seeking inspection of the investigation report while another one to cross-examine the investigation officer of the case again.

SC orders 8 including Manju's wife to surrender before courts

The Supreme Court yesterday ordered eight accused, including Environment and Forests Minister Anwar Hossain Manju's wife Tasmima Hossain, to surrender to the lower courts concerned in separate corruption cases against them.

The Anti-Corruption Commission filed the cases against them during the regime of military-backed caretaker government on charge of amassing wealth beyond known income sources.

The other accused are - former BNP foreign minister M Morshed Khan's wife Nasrin Khan, their son Faisal Morshed Khan's wife Shyama Sehzan Khan, ruling Awami League lawmaker Kamal Ahmed Maumder's wife Shahida Kamal, former BNP deputy minister Ruhul Quddus Talukder Dulu's wife Sabina Yeasmin, late BNP lawmaker Nasir Uddin Ahmed Pintu's wife Nasima Akter Kalpona, BNP leader MA Kaiyum's wife Shamim Ara Begum and Jamuna Group Chairman Nurul Islam Babul's son Shamim Islam.

The HC earlier scrapped the trial proceedings against all the accused following their writ petitions, ACC's lawyer Khurshid Alam Khan said.

After hearing separate leave to appeal petitions filed by the ACC challenging the HC verdicts, the
