Monirul Hoque Shakoo was the first mayor of the city, while Sima was elected a ward councillor. The city will go to polls for a second time on March 30. Some 2.07 lakh voters are expected to exercise their franchise.

Talking about waterlogging, Shakoo claimed during his tenure he had undertaken many development activities that include resolving the long-standing waterlogging problem.

"But I could not complete the task due to several setbacks. But I promise to finish it if I am re-elected," he said.

"I have improved the drainage system and constructed sufficient drains inside the city. But the problem is water can't recede as the exit points of many drains are blocked," Shakoo said.

It needs initiating a mega plan in and around the city to mitigate waterlogging, he said, adding that the cooperation from other govern-

ment departments is needed to implement it.

Sima, however, said a lack of monitoring by the city corporation and irresponsible behaviour of city dwellers are responsible for waterlogging.

Many city dwellers built their houses encroaching upon the city corporation drains while the city corporation officials turned a blind eye to it. Then, how would the problem be resolved? Sima questioned.

"As a former councillor, I also take some responsibilities for the waterlogging problem," she admitted, adding, "If I am elected, I will take strong measures to widen the drains, which have already been narrowed down."

Apart from waterlogging, both the candidates identified traffic indiscipline and congestion as the second worst problem in the city.

Around one lakh battery-run three-wheelers are plying in and around the city, having neither route permit nor

registration, said operators of those vehicles.

Asked by The Daily Star correspondents how they operate without having any driving licence, Mojahidul Islam, a driver of a three-wheeler, said, "If you (correspondents) want to run the service, you just buy an auto-rickshaw and start operating on the road. You require no documents."

Talking about the issue, Sima said, "These three-wheelers are increasing rapidly due to public demand. We will have to introduce an alternative transport system for people before removing these vehicles from roads."

Shakoo also echoed the same and said, "Many people eke out a living operating these vehicles. Alternative employment opportunities must be created for them before imposing a ban on these vehicles."

The duo claimed that they would take effective measures in this regard if people cast their vote for them.

crore], Unique Ceramics Industries (Pvt) Ltd [Tk 70 lakh], Unique Hotel and Resort Ltd [Tk 17.55 crore], Unique Vocational Training Centre [Tk 65 lakh], Borak Real Estate (Pvt) Ltd [Tk 7.1 crore], Easter Housing Ltd [Tk 35 crore], and East West Property Development (Pvt) Ltd [Tk 189 crore].

Over Tk 1,200 crore was reportedly realised from different companies and individuals, and was deposited to the national exchequer following anti-corruption drives during the

Cricketer Sunny gets bail

A Dhaka court yesterday granted bail to cricketer Arafat Sunny in a case filed under the Information and Communication Technology (ICT) Act, paving the way for his release from jail.

The order was passed after Nasrin Sultana, the woman who claimed to be Sunny's wife, informed it that she had no objection if Sunny gets bail.

Nasrin, the complainant, told the court that she and Sunny had reached an understanding.

On January 22, Sunny was arrested in his Aminbazar residence and was remanded for a day in the case.

According to the case filed on January 5, Sunny on last June 12 opened a fake Facebook account using his phone number and sent her indecent photos of herself on Facebook messenger, and also threatened to reveal them. He reportedly did the same on last November 25, 2016.

Nasrin also claimed to be in a relationship with Sunny for the last seven years and also said that the couple got married on December 4, 2014.

On March 9, Sunny secured a month's bail in another case filed by Nasrin for torturing her for Tk 20 lakh as dowry.

MISAPPROPRIATION OF Tk 7.8 CR

ACC okays charges against six

Anti-Corruption Commission (ACC) has approved charge sheets against six persons, including three bank officials, in three cases filed over alleged misappropriation of Tk 7.8 crore.

ACC's Public Relations Officer Pranab Kumar Bhattacharjee said they would submit the charge sheets to courts soon.

ACC gave charge sheet against Moin Uddin Ahmed and Monirul Islam for embezzling Tk 6.42 crore from the Chittagong's Khatunganj branch of Bangladesh Commerce Bank Ltd.

In another case, ACC gave charge sheet accusing bank officer Sukumar Roy and proprietor of Nafisa Traders Nur Alam Haq Pramanik for embezzling Tk 1.24 crore.

In 2013, a case was filed against former line director of Directorate General of Health Service Anwarul Islam Khan and executive director of Advance Business Center Sayeed Jamal Khan for misappropriating Tk 30 lakh.

ACC's deputy director Jahangir Hossain, who investigated the case, found that there was a campaign launched in 2009-10 fiscal to discourage mothers to use substitutes of breast milk. Though no campaign was held, Anwarul in collaboration with Jamal withdrew the money producing fake vouchers in five installments, reads the charge sheet.

Meanwhile, ACC yesterday quizzed Ashfaq Aziz Rubel, a director of Partex Group, in a case filed for obtaining two plots in Purbachal illegally.

Earlier, ACC arrested Rubel's brother Amber Group Chairman Showkat Aziz Russell and ex-chairman of Rajdhani Unnayan Kartripakkha Iqbal Uddin Chowdhury and six others in connection with the case. Showkat is now on bail.

"Bangladesh follows a counter terrorism strategy based on four pillars: prevention, disruption, capacity building and upholding respect to human rights."

Indian Vice-President Hamid Ansari inaugurated the three-day conference organised by India Foundation at a local hotel, according to a press release of Bangladesh High Commission in New Delhi.

Referring to several recent acts of terrorism in Bangladesh, the home minister said the situation was brought under control, thanks to relentless efforts by law enforcement agencies and with active cooperation from the general mass.

The home minister, however, regretted that despite stringent measures, several home-grown groups have become radicalised. "In some cases, with the connivance of a few radical political affiliations, [they] are trying to destabilise the country with their acts of terror and thus hinder the current rapid socio-economic development."

"We have also unveiled the unholy nexus between these groups and those who are against the trial of the anti-liberation war actors and perpetrators in the International Crime Tribunals," he added.

US\$ 1.2 million and US\$ 29.5 to Global ME General Trading and Semat City General Trading of the UAE respectively, while US\$ 10 million and US\$ 14.4 million to ATZ Communications Pte Limited and Eurocrats Holding Pte Ltd of Singapore respectively.

The loans were provided without scrutinising the risks and assessing business capabilities, and also against insufficient collateral and equity and others, the report read.

So far, the total due including interest has reached US\$ 38.76 million, it added.

"The four overseas organisations were asked to refund the money by September 2016. We have asked the authorities to identify and take action against the local beneficiaries..." said Abdur Razaque.

Bangladesh Bank intelligence unit reported that they were trying to identify the local beneficiaries of the money laundering, he added.

All dues from Global ME General Trading has been recovered, Razaque informed.

"It's taking time to recover the money as all the companies are located abroad," he said.


