

Seven errant businesses fined

UNB, Dhaka
A mobile court of Armed Police Battalion (APBN) yesterday fined seven businesses, including five restaurants, Tk 2 lakh in Nilkhet, Motijheel, Moghbazar and Gulshan-1 areas for various irregularities.
The court conducted a drive at Gausul Azam market in Nilkhet and fined "Bikrampur Hotel and Restaurant" Tk 25,000 and "Mama Hotel" Tk 20,000 for unhygienic environment, said senior assistant police superintendent M Saidur Rahman, also APBN's operation officer.
It also fined "Soravi Hotel and Restaurant" Tk 20,000 and "Marlin Restaurant" Tk 50,000 for the same reason in Motijheel.
The same court fined "Bekit Ben Kisar" in Gulshan-1 Tk 50,000, and "CO Jui Multi Media" in Moghbazar Tk 10,000 for violating the Graffiti Writing and Poster Sticking Control Act, 2012, and fined "3 Star Hotel and Restaurant" in Moghbazar Tk 20,000 for unhygienic environment.

Youth arrested on rape charge

A youth was arrested yesterday in Brahmanbaria's Akhaura upazila following a case filed against him for allegedly raping a teenage girl.
The 22-year-old youth developed a relationship with the girl promising to marry her, said Mosharraf Hossain, officer-in-charge of Akhaura Police Station, quoting the case statement.
When the girl became pregnant, he refused to marry her, the OC said.
Following the refusal, the girl's mother filed the case with the police station yesterday accusing the youth of raping her daughter, the OC added.

3 'Jana Sanghati' men held with Tk 11 lakh in Ctg

Rapid Action Battalion yesterday claimed to have arrested three Parbatya Chattagram Jana Sanghati Samity activists from Hathazari upazila of Chittagong on Saturday with Tk 11 lakh allegedly amassed through extortion.
The arrestees, Dhana Bikash Chakma, 60, of Khagrachhari, Prem Ranjan Chakma, 32 of Bandarban, and Rubel Babu Tanchangya, 19, of Rangamati, were arrested at a check post at Hathazari bus stand.
Rab-7 disclosed the arrest in a press conference at its headquarters.
Miftah Uddin Ahmed, commanding officer of Rab-7, said on information they searched a microbus at the check post and seized Tk 11.10 lakh from the trio. The money was collected by intimidating people, alleged the official.
He claimed, during interrogation, the three identified themselves as activists of Jana Sanghati.
The process of filing a case is underway.
