Cox's Bazar SC upholds directives to save Jhilonja from grabbing

STAFF CORRESPONDENT

The Supreme Court has upheld a High Court verdict that in 2011 directed the government to take necessary steps to protect Jhilonja Mouja, an ecologically critical area in Cox's Bazar, from encroachment.

The SC passed the order on Sunday after hearing a petition filed by the Cox's Bazar deputy commissioner. Following a writ petition

filed by Bangladesh Environmental Lawyers Association (Bela), the HC on June 8, 2011 ordered the government to take necessary steps so that the natural characteristics of Jhilonja Mouja are protected, its soil cannot be dug and structures cannot be built there.



No safety in high-rise building construction

Falling bricks injure four of a family inside room

Four people of a family, including two students, narrowly escaped death but sustained injuries as bricks from an adjacent under-construction highrise fell on them through the tin roof of their house at Dhopa Para in Chittagong city's Kazirdewri area early yesterday.

Tagor Bala Das, 70, sustained injuries to her legs and back; while Sahadeb Das, 23, Ovi Das, 19, and Arup Das, 24, to their hands and legs, said doctors at Chittagong Medical College Hospital where they were admitted.

Of them, Tagar's condition was critical, said Dr Biswajit Das.

Arup is a student of Government City College while Sahadeb of East Delta University, they told The Daily Star at the hospital.

Locals said the bricks fell from the top floor of the eight-storey building.

"At first we thought it was a sound of thunder as it was raining and we were asleep," said Aparna Das,

daughter-in-law of Tagor Bala Das.

She said, "My mother-in-law was covered with a pile of bricks and she became unconscious."

Tagar Bala's son Gopal Chandra Das alleged that there has been no safety measure around the building for about three years. "Chunks of brick often fell onto the roof. We requested the owner to cover the site with safety net but he did not pay any heed ... " Hasan Bin Shams, executive engineer of

Chittagong Development Authority, said according to the CDA building code, maintaining safety measures is a must for construction sites. When asked why no action was taken against the

building owner, Hasan said CDA chief town planner Shahinul Islam Khan would be the right person to reply to this question. Shahinul could not be contacted as his cellphone

remained switched off. The building owner Eteram Hossain said they main-

tained such "safety net", but it was removed as the construction work has been "postponed" for several months. "We will cover it up with net tomorrow."

CU medical centre off limits to female students after 6pm! CU CORRESPONDENT

In the wake of an incident of alleged sexual assault on a female student by a male physician, the Chittagong University authorities yesterday in a notice asked its female students not to visit the university medical centre after 6:00pm.

The notice, however, says only those female students will get treatment whose condition is very serious. It reads, "If any female student needs primary treatment after 6:00pm, she has to go to the medical centre along with a female house tutor and the matter must be informed to the medical centre through the respective hall's provost or house tutor".

Earlier on March 10, the residential student of CU filed a written complaint against Md Mostafa Kamal, a physician of CU medical centre, for allegedly groping her during a check-up. Later, the physician was sent into forced leave.

but he was now suffering from continuous fever. "Doctors do not see my son regularly. They instruct the nurses via the mobile phone. Is this a system? I am afraid of

my son's condition," she said. Prof Rouf Sarder, who was recently removed from his additional duty as a director by the Bangladesh Medical Studies and Research Institute (BMSRI), parent body of BMCH, said the doctors, teachers, and interns began the strike a day after transfer of Dr Saiful Islam, a medical officer of BMCH, Dhanmondi, to Uttara Adhunik Medical College Hospital on March 14.

He said around three months back, some doctors and teachers complained to the Anti-Corruption Commission (ACC) about the alleged corruption of some BMSRI staff. Transfer of Dr Saiful was a result of that, he said.

He further said the strike was triggered by a conflict Obituary between BMSRI and BMCH's governing body, which had been going on for the last three years.

Contacted, Prof Niaz Ahmed Chowdhury, honorary secretary of BMSRI, told this correspondent that if there was any allegation of corruption, there was a due process to follow. An investigation regarding this is going on, and the

health ministry has taken the probe over from ACC, and so there were no grounds for a strike that puts patients in trouble, he added.

"We have transferred Dr Saiful Islam for his unruly behaviour," he said, adding that they would take legal

action against such behaviour of a small section of doctors and teachers who wanted to control the hospital. Dr Saiful Islam, who was transferred, said as per the law,

the governing body would govern BMCH, not BMSRI.

VIOLENCE AGAINST INDIGENOUS WOMEN IN 2016

Most crimes committed by non-indigenous people: Study

Non-indigenous people were involved in 85 percent of violence committed against indigenous women and girls in 2016 while law enforcement agency members were involved in two percent of the incidents, revealed a study conducted by Kapaeeng Foundation.

Thirteen percent of the 53 offences -- took place in both hilly and plain areas of the country -- mentioned in the study the same year were committed by members of the indigenous community, according to the study.

A total of 58 indigenous women and girls were tortured in those incidents while 6 were killed.

Violence against women continues unabated in the country although the government had ratified various international conventions pledging to eradicate violence against women, many speakers said during the discussion.

The government needs to take stern actions against the perpetrators of the crimes to establish the rights of indigenous women and girls after determining the causes behind such violence, they demanded.

BIWN Coordinator and KF Member Falguni Tripura presented the keynote speech at the discussion.

Chakma said the government is not

doing enough to ensure rights of indigenous women and bring to an end to discrimination against them.

Referring to atrocities against Santals in Gobindaganj of Gaibandha, National Human Rights Commission Chairman Kazi Reazul Hoque said, "It was a pity that the Santals had to take up bows and arrows to protect them from government officials."

Romila Kisku, a Santal woman from Gobindaganj, alleged that the Santals in her village were still being harassed by members of the administration. Lawmaker Shirin Akhter said politi-

cal commitment is necessary to ensure rule of law in the country.

Bangladesh Mahila Parishad Joint General Secretary Rakhi Das Purkayastha, Sulekha Mrong of BIWN, former information commissioner Sadeka Halim, Deputy Commissioner of Dhaka Metropolitan Police Farida Yasmin and Halima Begum of Department of Women Affairs, among others, also spoke at the discussion.
