MP advocates for corrupt principal despite SC order

Ignoring a Supreme Court order, Rajshahi Awami League lawmaker Ayeen Uddin has officially requested the education ministry not to take any punitive action against a corrupt and previously sacked college principal. Ayeen sent a letter to the education

secretary, dated February 23, 2017 requesting the official not to take any punitive action against Abdul Mannan, principal of Darusha College in Poba upazila. The principal had been sacked for corrup-

tion and irregularities seven years ago, but was reinstated to the post five years later in lawmaker. In the letter, the lawmaker from Rajshahi-

3 (Poba-Mohonpur) constituency said any punitive action against Mannan would be "illogical". He made the request although only three days ago, on February 20, an Appellate Division bench of the SC rejected Mannan's appeal against his 2010 dismissal.

Following the letter, Nusrat Jabeen Banu, a deputy secretary of the ministry, wrote to the deputy secretary (legal) of Secondary and Higher Education Division on March 12,

asking for opinions in this regard.

The college governing body sacked Mannan in July 2010 after an investigation found him involved in corruption. The Board of Intermediate and Secondary Education, Rajshahi (BISER) approved his termination on December 1, 2011.

The investigation, conducted by the Rajshahi deputy commissioner's office, found that Mannan got himself promoted to principal although he had achieved third division, both in HSC and BA (honours) examinations. The probe report also said Mannan

embezzled at least Tk 1.77 lakh in 1998-2009, got her wife appointed as lecturer with 2015, following constant pressure from the fake documents, enjoyed unlawful benefits and allowances, and recruited a teacher showing fake documents.

After being sacked, Mannan filed a writ petition with the High Court in 2012, challenging the BISER approval of his termination. The HCdismissed his petition on April 9, 2015.

Six months later, on October 8, 2015, Mannan challenged the HC verdict but the SC bench of Justice Surendra Kumar Sinha, Justice Syed Mahmud Hossain, and Justice Hasan Foez Siddique SEE PAGE 4 COL 4

Removal of Bangabandhu's statue from Baker Hostel sought

All Bengal Minority Youth Federation, a Muslim youth organisation in India, has demanded removal of Bangabandhu Sheikh Mujibur Rahman's bust from Baker Hostel in Kolkata.

The Father of the Nation, Bangabandhu Sheikh Mujibur Rahman, stayed in the government dormitory as a student of Islamia College (now Maulana Azad College) in the 1940s. The statue was installed

on February 23, 2011. Earlier, rooms 23 and 24 of the hostel were recognised as Bangabandhu Memorial Museum. A section of students on

Tuesday brought out a procession towards Bangladesh deputy high commission on Bangabandhu Sarani in Kolkata and handed over a memorandum to a local police station.

Fresh scrutiny irks section of FFs

There is a "mockery" going on in the country in the name of scrutinising the list of freedom fighters, alleged an organsiation of freedom fighters.

The organsiation -- Gallantry Awarded, Martyred & War Injured Freedom Fighters Central Command -- at a press conference at Jatiya Press Club, also alleged many freedom fighters are being harassed during verification of the authenticity of their certificates.

"Even freedom fighters whose names are already included in the gazettes of armed forces, BGB (erstwhile BDR), police, Ansar and Indian authorities, were harassed in the name of scrutinising real freedom fighters," said Mahmud Parvez Jewel, president of the organisation. He termed the whole process "faulty and one-sided". "Names of war criminals and people who did not take part in the Liberation War were also included in the freedom fighter lists," Mahmud said in a written statement.

The central command demanded Prime Minister Sheikh Hasina's intervention in this matter, and suggested that the government only scrutinise those applications that have been submitted afresh to be included in the list of freedom fighters.

Talking to The Daily Star, Mahmud, a gallantryawarded freedom fighter, said at this age of 70 he has so far appeared seven times before different committees to prove himself a real freedom fighter. "When a new government comes in power, it takes initiative to prepare a list of real freedom fighters. And every time, we have to appear before the respective body to prove ourselves real freedom fighters, which is a shame on us," a lamented Mahmud said. The central command claimed the officials of Liberation War affairs ministry don't cooperate with the freedom fighters.


