# Man to die for killing female classmate

#### Mahmudul killed his classmate Mimi in 2009

A Jamalpur court yesterday sentenced a man to death for killing his female classmate at Sheikh Fazilatunnesa Mujib Fisheries College here in 2009.

District and Sessions Judge Md Sayedur Rahman pronounced the verdict in the murder case of fourth-year student Momtaj Begum Mimi, 22, said Public Prosecutor Nirmal Kanti Bhadra.

After examining the statements of 23 witnesses, the judge pronounced the verdict in presence of the accused, added Nirmal Kanti.

According to the prosecution, convict Mahmudul Hassan, now 30, son of Dr Abdul Bari of Mymensingh town, was a fourth-year student of Sheikh Fazilatunnesa Mujib Fisheries College in Jamalpur in 2009.

Mahmudul proposed love to his classmate Mimi, 22, daughter of SM Abdul Mannan of the same town, which the girl declined, said the prosecution.

Mimi's refusal made Mahmudul anger and at one stage wanted to take revenge.

Mahmudul managed to enter the girls' hostel around 5:00pm breaking open the ventilator of a bathroom and was waiting before the Mimi's room No 103, says the case statement. As soon as Mimi came out of her room,

Mahmudul pushed her down on the veranda and started stabbing her indiscriminately, leaving her critically injured. She was rushed to Melandah Upazila

Health Complex from where she was shifted to Jamalpur General Hospital where the on-duty doctors declared her dead, said the prosecution.

Prof Md Forhad Ali, also superintendent of the hostel, filed a murder case accusing Mahmudul with the Melandah Police Station on February 14 the same year.

General Secretary of Parbattya Chattagram Nari Sangha Kajali Tripura, Member Secretary of Nari Attarokkha Committee Ucraching Marma, Santi Devi Chakma of Sajek Nari Somaj and Santi Prova Chakma of Ghilachari Nari Nirjaton Protirodh Committee were present at the press conference.

Meanwhile, Parbattya Chattagram Bangali Chattra Parishad formed a human chain yesterday at Khagrachari Government College, demanding immediate arrest of the killers of Iti Chakma.

There is a bright prospect of growing crops, especially tea, in Bangladesh side of no-man's land areas, said Noor Alam, Patgram upazila agriculture officer.

"Indian farmers are benefiting by growing tea in their part of noman's land for the last several years and the same is possible in Bangladesh side. But we need a decision from the government high-ups for the purpose," said Arif Khan, project director of Bangladesh Tea Board in Lalmonirhat.

# Crab catching unabated near Sundarbans

Random catching of mother crabs in different rivers and canals in the coastal areas adjacent to the Sundarbans is going on unabated, defying a ban by the Ministry of Environment and Forests, during the ongoing breeding season.

Hunting of crabs near the Sundarbans poses threat to the species and, consequently, ecological balance in the region.

Generally, crabs lay eggs in the Sundarbans areas on a large scale in the breeding period between the months of January and March, but they fall easy prey to hunting as a section of fishermen engage in crab catching.

The authorities concerned have imposed ban on crab catching in the Sundarbans area during this time of the year to protect the species as it is their breeding period.

Environmentalists urged the authorities concerned to take immediate steps to protect and preserve the species for its economic value.

Professor Salma Begum of Environmental Science Discipline at Khulna University said crabs help to maintain ecological balance as they area used as food by different animals in the mangrove forest areas.

It has high demand as an export item but its cultivation and research have not been given due importance, she added. During a recent visit to the coastal areas, this corre-

spondent found hundreds of fishermen catching crabs and shrimps with the help of current nets and traps, defying the ongoing ban. A number of fishermen, seeking anonymity, said

they catch crabs and sell those at different areas in Khulna region due to high demand.

A fisherman can catch 3 to 4 kg of crabs daily and each kg is selling for Taka 500 to 850. Khulna District Fisheries Officer Shamim Haider

said, according to the special act, crab catching is prohibited only in the Sundarbans area.

Shamim said in absence of such law in the other parts of the country, a section of fishermen are engaged in random catching of crabs.

### Sluice gate under threat of collapse

A sluice gate on the flood control dam near Payra port in Kalapara upazila is now under threat of collapse as some structures are being built there, thanks the authorities' negligence.

Local influential people -- Gazi Sumon, Gazi Niaz, Hanif Khan and Badol -- are constructing four wooden structures on both sides of the sluice

Of them, Sumon, Niaz and Hanif are activists of the upazila unit of BNP.

The four are so influential that none can dare to raise voice against them, said local union parishad member Md Kabir Hossain.

This correspondent phoned Sumon, Niaz, Hanif and Badol several times but they declined to make any comments on construction of the structures.

Kalapara Water Development Board Executive Engineer Abul Kahyer said they are taking steps to remove all structures from there.

# No headmaster in 117 Rajbari primary schools

As many as 117 government primary schools, out of a total 481 in Rajbari district, are running without headmasters for six months to three years as the vacancies caused by transfers, retirement or death have not been filled up.

Assistant teachers are serving as acting headmasters in those schools but official and academic activities are suffering as other teachers of the same position often show reluctance to follow the acting headmasters' direction, said several teachers and guardians.


The number of schools without headmasters is 28 in Rajbari Sadar upazila, 37 in Pangsha, 21 in Baliakandi, 18 in Kalukhali, and 13 in Gualando upazila, said sources at the district primary education office. "It is very difficult for me to conduct office work and classes as there are

only three teachers against the posts of seven," said Abdul Mazid, acting headmaster of Cowakhola Government Primary School in Kalukhali upazila. Agrodut Chakrobarty, acting headmaster of Boholadanga Government Primary School in Pangsha, said, "I have been performing the duty for three

years as no regular headmaster has been posted during the period.

Obviously, I am facing various problems in running the school." Md Habibur Rahman Mollah, president of Rajbari District Primary Teachers Association and also senior vice-president of Central Primary Teachers Association, said, "We have informed the ministry concerned about our problems but no step has been taken."

Tohidul Islam, district primary education officer, said, "We have already sent the list of vacant headmasters' posts to our higher authorities. But we do not know when the problem will be solved."
