#### **ACC** arrests BJMC GM for Tk 7.43cr scam

The Anti-Corruption Commission (ACC) yesterday arrested a suspended general manager of Bangladesh Jute Mills Corporation (BJMC) in the capital's Kakrail in a case accusing him and three others of misappropriating around Tk 7.43 crore.

The embezzlement took place at Platinum Jubilee Jute Mills Ltd in Khulna from May 2, 2012 to August 12, 2014 while Jahangir Hossain was a deputy manager there, says the case statement.

The remaining three are now posted at two jute mills and are at large, said ACC Assistant Director Md Shafi Ullah, the case's investigation officer who made the arrest.

They are managers (production) Liyakat Hossain and Khandakar

### No relief for two mayors

Substances Act.

Both the charge sheets were accepted around two years ago.

Following the Apex Court verdicts in their favour last month, the mayors went to their respective offices yesterday morning.

Sylhet Mayor Ariful was lucky enough to sit in his mayoral chair for a couple of hours, but Rajshahi Mayor Bulbul found his office under lock and key. When he managed to enter the office after a five-hour wait, he was informed within minutes that he had been suspended again.

Apart from the two, Habiganj Municipality Mayor GK Gaus was suspended yesterday for the second time.

Over the last couple of years, a large number of BNP and Jamaat-e-Islamibacked mayors, chairmen and vice chairmen were suspended under two specific clauses of the Local Government (City Corporation) Act, 2009. While enforcing the Act, the LGRD ministry's Local Government Division has all along been strict about the elected representatives backed by the BNP and the Jamaat.

According to Section 12 and 13 of the Act, a mayor or a councillor, if convicted or charge-sheeted in criminal cases, can be suspended.

The Act also says any elected representative can be removed from office for skipping three consecutive general meetings without any valid ground.

Talking to The Daily Star last night, local government expert Prof Tofail Ahmed said the decision to suspend

the mayors was not a good one. "Under the 2009 Act, a mayor or a councillor, if convicted or charge-sheeted in criminal cases, can be suspended. But it is not mandatory. It was improper to suspend the mayors on the very day they resumed office following

Executive Officer's room for around five hours, as he found his office locked around 10:00am. Bulbul entered his office, having the

door lock broken at about 3:00pm. A few minutes later, ABM Sharifuddin, CEO of the RCC, informed him of the ministry's suspension order.

Contacted, Sharifuddin said, "I don't know who locked the office or when it happened."

Earlier, Bulbul was suspended on May 7, 2015 after courts accepted charge sheets against him in three cases, including one for the murder of police constable Siddhartha Sarker.

Later, Bulbul filed a writ petition with the High Court, challenging the suspension order.

The HC on March 10 last year declared the suspension illegal. The government then moved to the Supreme Court which upheld the HC verdict on March 5 this year.

Of the 11 city corporations, BNPbacked candidates won mayoral posts in six and AL-backed ones in five cities.

MA Mannan, BNP-backed mayor of Gazipur City Corporation, was suspended on August 19, 2015 after a Gazipur court accepted a charge sheet against him in a case over an arson attack on a passenger bus in the city on February 4 that year.

On November 2, 2015, BNPsupported Khulna City Corporation Mayor Moniruzzaman Moni was suspended after he had been charged with criminal offences. He regained his mayoral post early this year as the HC stayed the suspension order.

According to the LGRD ministry's data, 24 mayors of city corporations and municipalities, 28 upazila chairmen, 13 upazila vice chairmen, and over 150 union parishad chairmen and UP members were suspended till mid-last year, as they were charge-sheeted in different cases, including the ones for arson and murders between 2014 and

Almost all of them are loyal to either the BNP or the Jamaat.

In reply, Hasina said vested quarters were doing arms business with the blood of Muslims.

She also narrated how she and her family were the worst victims of terror-

Hasina regretted that some derailed people were engaged in terrorist acts, and said her government involved people from all walks of life, including imams, teachers and guardians, to create awareness against such social menaces.

Qubaisi said Hasina was a role and prosperity. model when it came to women

empowerment and development in education and health sectors.

Indian Lok Sabha speaker during her meeting with Hasina narrated that their parliament members were in a festive mood while ratifying the Land Boundary Agreement (LBA) and had passed the bill unanimously.

"All members of the Lok Sabha were very happy to support the bill and it was really historic and remarkable,' she said. Welcoming the Lok Sabha speaker,

filed for manufacturing toxic paracetamol syrup, to surrender before the trial court within seven days.

Three other fugitive accused are Rid Pharma's director Abdul Gani, and pharmacists Mahbubul Islam and Enamul Haque.

The government in January filed an appeal with the HC, challenging the lower court verdict.

From June to August in 2009, 28 children across the country died of renal failures caused by the intake of the paracetamol syrup and suspension allegedly manufactured by Rid Pharma.

On July 22, 2009, the Directorate General of Drug Administration (DGDA) sealed off Rid's factory in BSCIC area of Brahmanbaria following wide media coverage of the children's death, and findings of Dhaka Shishu (Children) Hospital physician Prof Mohammad Hanif that Rid Pharma's Temset had toxic substance.

In August that year, Shafiqul Islam, then superintendent of the Drug Administration, filed the case with the Drug Court and only five prosecution witnesses testified after the court indicted

the five accused in March 2011. On November 28 last year, the Drug Court acquitted all the five, saying the prosecution utterly failed

to prove the charge against them. Negligence, inefficiency and incompetence of the Drug Administration in dealing with the case led to their

acquittal, the judge said in the verdict. Two officials of Drug Administration involved in the case against Rid Pharmaceuticals violated due legal procedure, and showed sheer negligence and incompetence

in dealing the case, the verdict said. The two officials are Shafiqul Islam and Altaf Hossain. Both of them were drug superintendents in 2009. Shafiqul is now an assistant director of the Directorate General of Drug Administration while Altaf is a deputy director, said a DGDA director in December last year.

[imam] will not deliver any speech which is contrary to the laws of the land," the court observed.

If anybody makes derogatory comments on Islam and Prophet Hazrat Muhammad (PBUH) or any other religion, he or she can be brought to book, it said, adding, "Nobody has the right to take the law in his own hand and nobody should make derogatory comments about any religion."

Even if any person does not believe in any religion, he or she should not make any disparaging comments about religion, the HC said.

The court made the observations while delivering the verdict on the death reference and appeals of eight convicts in the 2013 Rajib murder case.

The HC upheld death penalty of two convicts, life imprisonment for one and various jail terms for five others. It observed that seven convicts in Rajib murder case "have gone to the dogs" due to their parents' failure to give them proper education.

Rajib, who was an activist of Shahbagh movement and used to write against Jamaat-Shibir and war criminals on different blogs under the pseudonym Thaba Baba, was hacked to death near his Mirpur home on February 15, 2013.

The condemned convicts are: Redwanul Azad Rana, and Faisal Bin harmony, the HC observed. Nayem alias Dweep.

Among the jailed convicts, Mufti Jasimuddin Rahmani, chief of banned militant outfit Ansarullah Bangla Team, was awarded five years' imprisonment as he was found guilty of provoking Rajib's murder with his sermons. Maksudul Hasan alias Anik was

given life term imprisonment. Four other convicts -- Ehsan Reza Rumman, Nafis Imtiaz, Nayem Sikdar Irad and Sadman Yasir Mahmud -- had been sentenced to different jail terms.

Apart from Jasimuddin, all the seven convicts were students of North South University in 2013.

that the seven were meritorious students and their parents were well edu-

"It is not apprehended why they [seven convicts] have gone to this wrong path. We [judges], like many others, think that their parents are responsible for it. Their [parents] duty was to give proper education to their children, but they failed to do that. Therefore, their children [convicts] have gone to the dogs," said the HC bench of Justice Jahangir Hossain Selim and Justice Md Jahangir Hossain.

The judges said their parents were busy with their lives and failed to give

proper attention to their children. They said the parents had imposed a certain education and other things on their children without caring for what the children want to do or study. This made the children reactive. This practice of the parents should be stopped, the HC observed.

Parents are the primary teachers of their children and they have to carry out their responsibilities in this regard, it added.

At the same time, everyone, including the state, should ensure quality education and make people aware of the country's political atmosphere, population control, true history of the country's independence and religious

should appoint honest, sincere and experienced officers, who are committed to working for the people, to investigate such cases, it said.

"Then such crimes would be reduced from the society and the country ...," it said. Citing the defence's arguments, the

HC said three investigation officers probed the case. Jasimuddin used to deliver sermons against bloggers but the investigation officers failed to provide the evidence, the HC said.

"It was a planned murder. The offence committed by the accused was horrendous, heinous and atrocious.
