50 hurt in Gazipur stampede

At least 50 garment workers were injured during a stampede to escape a fire incident at their workplace in Gilarchara of Gazipur yesterday. Two seriously injured workers, Anjana, 40, and Romana, 40, who is pregnant, were admitted to Mymensingh and Dhaka Medical College Hospitals. Others were taken to local clinics.

Workers said panic broke out at Vintage Denim Ltd as a fan suddenly fell from the ceiling at the packaging section around 8:00am. Some four hours later, fire started from an electric short circuit on the factory premises and the workers started stampeding. Administrative manager of the factory Khandker Hamidul Islam said four sections of the factory were kept closed yesterday.

"To put equality and equal rights at the heart of things one needs to be sure that everyone is at the table, one has to look and see who is not there, who is not being heard, who is not being included.... It is necessary to use our power to change that," she added. Margaret Mensah-Williams, president of the IPU Bureau of Women Parliamentarians, called upon her colleagues across the world to take firm action in three priority areas - eliminating gender inequality from laws, enabling parliaments to deliver gender equality and making women's economic empowerment a reality. "If we are to succeed in delivering on dignity and well-being for all, we must respond to the needs of women in crisis situations - women migrants and refugees, women with disabilities or living with HIV, young and elderly women, all women." "We must lead the way in our families and in our parliaments. We cannot be complacent, perpetuate gender biases and let inequalities prevail. Let's walk the talk," she stressed.
