Swapon attends HSC exam in jail

Swapon Kumar Roy, a Higher Secondary Certificate (HSC) examinee from Patgram Technical and Business Management College, appeared at the examination inside the district jail yesterday.

Following the instructions from the controller of examinations of Technical Education Board, Dhaka, arrestee Swapon attended the examination inside the jail, said Kishore Kumar Nag, superintendent of district jail.

"Swapon was given his books for reading in jail on Friday and 1 sent letter to the education board controller the next day, seeking permission for Swapon's taking part in the examination," he said. The District and Sessions Judge's Court granted his bail

prayer yesterday, said advocate Shariful Islam Raju. "We feel temporary relief as our son Swapon could take part in his examination and the court granted his bail

prayer, " said Swapon's father Subhas Chandra Roy. "We are simple farmers. I believe Swapon became a victim of local politics as we have been facing a problem over casting vote in the union parishad polls last year," he

Police arrested Swapon, 19, from near their home at Bhandardah village in Patgram upazila, claiming his involvement in a cow stealing incident. But they produced him before a judicial magistrate's court on Friday, showing him arrested in a case filed on December 27 last year.

Buri Teesta river dying

WDB stops flow of water as sluice gate collapses in 1988 flood

People in Ulipur upazila of the district are suffering as the Buri Teesta river is drying up due to earth filling at a place where a sluice gate collapsed in 1988. The Buri Teesta originates from the

Teesta river at Arjun village and joins the Brahmaputra river at Kachkol village under Chilmari upazila. Flow of water in the 30-km-long river through Ulipur municipality area

used to be controlled through two regulators (sluice gates) of Water Development Board (WDB) at Arjun and Kachkol villages. WDB stopped flow of water by filling earth when the sluice gate at Arjun village

collapsed during the flood in 1988. From then, the branch river started losing its depth and water-carrying capacity, and is almost dead now. Freedom fighter Abu Bakar Siddik,

70, of Khearpar village, said, "Water would flow freely in the Buri Teesta about 20 years ago. Before liberation, the people of Roumari and Rajibpur upazilas would come to Ulipur Bazar for marketing and transporting all kinds of goods by boat. Boat races were held every year, and there were plenty of fish in the river."

"Due to lack of flow, the river got filled up slowly with silt coming from upstream during the rainy season. Some people have constructed houses by raising the riverbed. Vast tracts of crops get damaged during flood or heavy downpour," Abu Bakar said.

"Dredging of the Buri Teesta and construction of the sluice gate are needed to save the ecology and produce crops by reviving the water flow," he added. Abdul Aziz, 65, of Jotdarpara

village, said, "I would cultivate jute and get it rotten in the river, but I cannot do it now. The riverbed was dredged for irrigation by the government about 37 years ago. It is still possible to revive the river if it is dredged again." Parimol Majumdar, an activist of

'Save Buri Teesta-save Ulipur' move-

ment, said, "We are agitating against grabbing of the Buri Teesta. We also want dredging of the river and reconstruction of the sluice gate." "We have formed human chains

and held bicycle rallies in Ulipur to demand restoration of flow of water in the Buri Teesta, and submitted a

memorandum to the Upazila Nirbahi Officer (UNO)," Porimol said.

Executive Engineer of WDB in Kurigram Shafiqul Islam, said, "Digging of ditches and construction of embankments in different districts will be started this year. An eight kilometre area in Kurigram has already been taken under the project. Besides, a separate project for the Buri Teesta will be placed to the higher authorities. If the local lawmaker assists me, the project may be approved quickly." UNO Shafiqul Islam said, "I have

received a letter on the Buri Teesta from the villagers and have taken some steps. I have asked the assistant commissioner (land) to mark the area of Buri Teesta according to CS and SA land records. The meeting of Kurigram district river protection committee under the National River Protection Commission has taken a decision on the Buri Teesta and requested the local WDB authority to look into it as there are some lands of the WDB there."

"We will take steps against the land grabbers in the Buri Teesta after marking the river area," the UNO said.

Assault of Headmaster Jhalakathi UZ chairman sued

Twenty one cattle were recovered from an underground cowshed at the house of a suspected thief in Nilphamari's Horinchara Koimaripara village in Domarupazila on Saturday.

Law enforcers arrested Dulal Roy, son of late Kesto Mohan, in this connection.

Police said Mominul Islam, 40, son of Ansar Ali of the village along with his fellow thieves used to steal cattle from farmers' houses at dead of night. He later kept the cattle at his underground cowshed and sold them to faithful brokers and butchers at lower prices.

A few days ago, the thieves stole a milking cow from the house of one Mosharaf Hossain of Koimari village in nearby Jaldhaka upazila.

Saturday morning, he found his cow at the house of Dulal at Koimari Para after a frantic search and informed the police. Later, Dulal was arrested.

Collapsed rail bridge yet to be repaired

A railway bridge in Madhabpur upazila of Habiganj has remained unrepaired after it collapsed four days ago.

Railway bridge No 55 collapsed due to heavy rainfall on March 30, causing immense sufferings to passengers, said Shaistaganj Stationmaster Saiful Islam.

Rail communication between Sylhet, Dhaka and Chittagong resumed yesterday afternoon after arranging an alternative route there, said Mujibur Rahman, officer-in-

charge of Srimangal Railway Police Station. It will take some time to repair the bridge and trains will ply the alternative route until the bridge is repaired, said the OC.
