3 JMB suspects on five-day remand

Militant outfit Neo JMB leader Jahangir Alam alias Rajib Gandhi, also a plotter of last year's June 1 massacre at Holey Artisan Restaurant in the capital, yesterday made confessional statement under Section 164 in two violence related cases in the district.

Amid tight security, he was produced before the Court of Senior Judicial Magistrate SM Taskinul Huq. Rajib confessed before the


court that he conducted meetings at different places to re-organise Neo JMB activities and got involved with violent activities to unsettle the administration, said Shafiqul Islam, public prosecutor, Gaibandha court.

On March 30, the court granted him seven days' remand after Masudur Rahman, officer in charge of the Detective Branch (DB) of police, sought ten days' remand to interrogate him in violence related cases.

On that day, following four days of interrogation under an earlier granted remand, Rajib gave statement before the court, confessing his involvement in the murder of village physician Mahbuber Rahman Dipty of Gaibandha Sadar upazila on June 2, 2015.

Meanwhile, Senior Judicial Magistrate Jainul Abedin yesterday granted five days' remand for three suspected Neo JMB activists -- Mehedul Islam, 35, of Palashbari, Delwar Hossain, 30, of Gobindaganj, and Ataur Rahman Montu, 35, of Gaibandha Sadar upazila.

They were arrested from Palashbari on Tuesday as per confession of Rajib, said DB SI Protap Kumar Shingha, the investigation officer.



Zamindar Bari on verge of ruin

Kansat Zamindar Bari, which has great historical value, is a deserted house now and on the verge of ruination after years of neglect.

Locals say the building, erected in 1867 in Shibganj upazila of the district, is gradually falling apart due to negligence of the local authorities.

Surjya Kanta came to Kansat village from Muktagachha in Mymensingh and built the big, decorated mansion, originally called Surjya Garh, on about 2.24 acres of land on the bank of the Pagla river, around 25 km from the district town.

The exquisitely decorated twostoried mansion has 16 rooms. Surjya Kanta had two sons,

Shashi Kanta and Shitangshu Kanta. Shitangshu was the last zamindar. Shitangshu went to Kolkata

after the partition of India in 1947,

and the Pakistan government took ownership of the building. It remained unused until after the liberation of Bangladesh, when it was made the union land

office. The office was later shifted to the kachari bari in front of the mansion. Prof Mazharul Islam of the

Department of Bangla in Chapainawabganj Government College, and a local historian, said

the zamindar bari is a heritage in the district. This building has historical value because it is a physical connection with our past, he added.

"It was built around 1867. At that time, the place was crowded because many people built their houses around the zamidar bari. So, it will help us know about the culture and religion of the people of that time," he said.

Abdul Mannan, 60, of Kansat bazar, said the local authorities have never taken any steps to preserve the building.

It is the only zamindar house in the district, but now it has turned into a dumping spot for garbage and a den of drug addicts, he

added.

Nurul Islam, assistant land officer of Kansat union, said the building is seriously damaged. He urged the authorities to take immediate steps for preservation of the building. Locals said if the historic

Zamindar Bari is not renovated it will be destroyed and the memories of the zamindars will be lost forever. Kansat Union Parishad

Chairman Benaul Islam said the government should renovate the building for its historical value. Upazila Nirbahi Officer of

Shibganj Shafiqul Islam said he will take necessary measures for preservation of the building.

Hailstorm hits Sunamganj

Hailstorm coupled with rain damaged crops on around 80 thousand hectares of land in Sadar, Dirai, Dharampasa and Shalla upazilas of Sunamganj in the last two days.

Besides, a number of houses along with trees were damaged when the storm hit over 100 villages in the upazilas, said locals. Farmer Prosanto Das of Perua village in Dirai upazila

said big hailstones, some weighing about 20 grams, damaged roofs of many houses. Md Mukshed Ali, chairman of Jahangirnagor Union

Parishad in Sadar upazila, said at least 70 percent of the crops were damaged as the hailstorm during the last two days hit 20 villages in the area. Another affected grower Monirul Islam of Chamordani

the upazila. Dirai upazila Chairman Kamrul Islam said big hailstones during the storm and rain damaged scores of houses at least 30 villages in the area. Besides, hundreds of trees and many

electric poles were uprooted during the hailstorm. A number of houses were damaged as the storm hit 20 villages in the area, said Dharampasa upazila Chairman Abdul Motaleb Khan.

Md Zahidul Haque, deputy director of Department of Agriculture Extension in Sunamganj, said the hailstorm damaged boro and vegetables on over 79 thousand and 790 hectares of land in the upazilas.

7 militant suspects on remand

A court here yesterday granted three-day remand for each of the seven militant suspects who were arrested on Monday from the district town.

Police produced them before Judge Md Billal Hossain of Cognizance Court No-1 seeking 10-day remand each, but the court granted three-day remand each, said Nawajesh Ali Mia, inspector of the court.

OC of Kotwali Police Station Md Kamrul Islam filed a case against them under Anti-Terrorism Act.

Acting on a tip-off, police raided a house in Boro Kalibari area and arrested them from there.

The arrestees are Shahidul Islam, 28, and Ashigur Rahman, 19, of Haluaghat upazila; Al Amin, 25, Masum Ahmed, 30, Shah Al Hossain Shamim, 27, Ruman Mia, 27, of Netrakona's Purbadhala; and Nasir Uddin, 27, of the district's Mohanganj.

No firearms or explosives were found, but police recovered computers, chequebooks, electronic devices and jihadi books.

Pagoda an attraction for tourists

Hundreds of people visit Rama Jadi daily

The newly built Rama Jadi (pagoda) in Bandarban's Rowangchhari upazila has become the latest tourist spot in the district.

Founded by U Pannya Jota Thera, locally known as Guru Bante, the 108-foot-high pagoda is one of the highest Buddhist temples in the country.



Herons have found a safe haven in Raja House at Sreemangal upazila of the district. Gulam Mostofa Raja is the

owner of Raja House in Motiganj village. Several species of herons have made the small woods their home,

building nests in the trees in the area. The trees also house birds and parrots. The sight of the birds nesting and gathering food is quite extraordinary, which is why at

first glance it seems like a settlement of migratory birds. Gulam said the heron population in the colony has been grow-

ing every year since they started coming there in 1990. Everyone here likes these heron, and even outsiders do not

bother them, he said, adding that

a heron sanctuary is good for the ecology. "It is not possible to have garden.

such a place without love for herons," said visitor Sumona Bosak, who came from Dhaka. "The people here are very nice as they allow the herons to live here in safety," said Mohammad Ali and Sajal Rozario, who came

from Bogra. "We are helpless when it comes to natural calamities. But we try to ensure that the birds do not suffer. It is necessary for everyone to be conscious about protecting nature and biodiversity as a whole," Gulam said.
