Devotees split over land recovery

Two groups of devotees of Thakur Anukul Chandra were divided over protecting the land, once owned by the spiritual leader.

The groups consider the land, the birth place of Thakur Anukul, as holy place.

Occupation of a piece of land in Pabna by a group of devotees of Thakur Anukul was protested by another group.

Shat Shangha Bangladesh (SSB) claimed that Hemayetpur Shat Shangha Asram (HSA) occupied 15 decimals of disputed land on the Pabna Mental Hospital premises on March 12 while they are fighting a legal battle to recover 62 decimals of the land, the birthplace of Thakur Anukul.

Protesting illegal occupation of the disputed land by Shat Shangha Asram,

Shat Shangha Bangladesh formed a human chain on Abdul Hamid road on March 27, blaming the role of the district administration in occupation of the disputed land.

After the rally at a press conference at the Pabna Press Club, Shat Shangha Bangladesh activists said they are trying to recover 62 decimals of land on the hospital premises through a legal battle.

"We don't want to occupy the land illegally, we want to recover it through a legal process along with the support of locals," said Dhritabata Aditta, Shat Shangha Bangladesh secretary.

Shat Shangha Asram in a statement rejected the allegation of occupying the disputed land.

"Fifteen decimals of land were recorded in the khas khatian and Shat Shangha Asram bought the land for Tk 6.5 lakh," said its Secretary Jugol Kishore.

Shat Shangha Bangladesh organiser Tapan Das Hory said the district administration played a vital role in processing the official documents in favour of Shat Shangha Asram, although there is a legal battle going on over the land.

"It is not possible to take any decision on the disputed land before the verdict in the pending case is given. But the district administration prepared the official documents so that Shat Shangha Asram gets the piece of land," Hory alleged.

Acting Deputy Commissioner of Pabna Maksud Khanam Siddiqui said the district administration does not support any faction.

"We did not ask the Shat Shangha Asram authorities to occupy the land. The district administration will take action according to the law," Maksud added.

Physically challenged woman raped

A physically challenged woman aged about 30 was raped by a middle aged man at Jogirhat village in Rajapur upazila here on Tuesday morning.

"Siddik Howlader took my physically challenged daughter to a house nearby while she was collecting dry leaves at a wood garden beside her home," said the victim's father, adding that the culprit raped her there and threatened her not to disclose the incident to her parents.

The woman's father said they asked what happened to her as they found her dress torn off. The challenged daughter was in tears while she was telling how she was raped by Siddik, he added.

Siddik also threatened the victim's parents not to file any case or complaint against him.

The victim was sent to Jhalakathi Sadar Hospital yesterday for medical test while police raided different places to arrest Siddik, said Rajapur Police Station Officer-in-Charge Sheikh Munirul Gias.

He said victim's father filed a case with the police station on Tuesday night against Siddik Howlader, 42, of Jagannathpur village.

39 dykes under threat as Monu river swells

Over two lakh people along the Monu river are in fear of losing their homesteads and croplands as the authorities concerned are yet to take any steps to repair 39 flood protection embankments that collapsed partially in Sadar, Kulaura and Rajnagar upazilas.

Meanwhile, about 500 feet stretch of the riverbank, which collapsed due to an earthquake last year at Mondira village in Kulaura, has been lying unrepaired since then, while the rainy season is knocking at the door, said a worried resident of the area, Hossain Chowdhury, 65.

Abdul Latif, a member of Hazipur Union Parishad (UP), said they have dumped sandbags in the Monu to protect the flood protection embankment from onslaught of the river, but it is now out of control due to rain for the last few days.

The entire embankment may go under water anytime if steps are not taken immediately to repair it, he said.

Despite repeated calls, local Water Development Board (WDB) is yet to take any steps to repair five embankments in the area, said Nazmul Haque, chairman of Kamarchak UP in Rajnagar upazila.

Md Tipu Khan, chairman of Tengra UP in Rajnagar, said they have already requested the authority to repair 20 collapsed embankments in the area.

Four points of the Monu have started collapsing as the river is swelling, said Bakhor Khan and Abdul Basit Bachchu, chairmen of Prithimpasa and Hazipur UPs of Kulaura.

Moulvibazar WDB Executive Engineer Bijoy Indro Sankar Chowdhury said they wrote to the higher authorities for funds to repair the embankments but they have not got any response yet.
