

RU student returns lost cash to owner

"How did the money come here?" is the question that cropped up in her mind when Sumi discovered a bag full of cash along with her shopping bags.

She was perplexed, but she knew she was going to do what her family has taught her to do.

"That was someone's hard-earned money. It is my duty to return it to the owner," said Sumi after handing the Tk 1 lakh cash over to its owner. "My family has always taught me to be honest. That's what I did.'

Sumi Ara Khatun is a master's student of mathematics at Rajshahi University. On Wednesday morning, she shopped at RDA Market in Rajshahi city and bought some clothes from Usha Fashion. While shopping, she felt unwell and requested the shopkeeper to keep some of her shopping bags, which she would collect later. When back home from the market, Sumi found

that one of the bags contained the cash. Though immediately puzzled, she soon realised that the shop owner must have mistakenly slipped the bag of money while returning her shopping bags. "Finding a mobile [phone] number written on the

back of the bag of money, I called them and asked if they have lost anything," Sumi said. "But they were unaware of their lost money at first.

Mymensingh men STAFF CORRESPONDENT The International Crimes Tribunal-1 yesterday issued arrest warrant against six Mymensingh men, who have been charged

with crimes committed during the Liberation War in 1971.

The special tribunal issued the warrant following a petition moved by Prosecutor Rezia Sultana Chaman.

The six are among 11 accused from Mymensingh against whom the prosecution on Wednesday pressed four charges for allegedly committing crimes in 1971.

The tribunal also asked the police authorities to submit execution report on the warrant on May 22 and will pass further order in the case on that day.

The prosecution declined to give names and details of the six accused. Till 5:00pm, none was arrested, Rezia told The Daily Star.

The 11 were involved with Razakar Bahini, the Pakistan occupation army's auxiliary force, during the Liberation War and committed crimes which include killing of four people, torture on nine, and incidents of looting, arson, abduction and

confinement under Pagla Police Station in the district, according to the prosecution.

The remaining five accused -- Khalilur Rahman Mir alias Khalilur Rahman, 62; Md Samsuzzaman alias Abul Kalam, 65 Mohammad Abdullah, 62; Mohammad Abdul Malek Akand alias Abul Hossain, 68; and Md Rois Uddin Azadi alias Akkel Ali, 74 -- are now in jail.

They are all from Pagla. Samsuzzaman, Abdullah and Rois fled the area after the war. Since then, Samsuzzaman has been living in Pabna, Abdullah in Dhaka and Rois in Rajshahi, according to the tribunal's investigation agency. The investigation agency claimed to have

found evidence against the 11 over their alleged involvement in wartime crimes. The four charges against them are: Killing of Shahabuddin alias Khoka, a local organiser of the Liberation War of Sadhua village; killing of Joidhar Khan alias Taru, another local organiser of the war, and looting and torching of his house in Sadhua village; killing of Toiab Ali of the same village; and killing of freedom fighter Nur Hossain of Rouha village.


