BID TO STOP RADIATION Formulate guideline on cell tower operation

HC asks BTRC

The High Court yesterday directed the Bangladesh Telecommunication Regulatory Commission to formulate a guideline on the operation of cell phone towers in the country in order to stop its radiation harmful to public health.

During hearing a writ petition, the court asked the BTRC chairman to submit a report before it after complying with the directive in eight weeks.

The HC also gave three months' time to the health ministry to obtain separate assessment reports from three international organisations about public health risk from radiation emitted by mobile phone towers set up in different areas across the

country. The organisations are World Health Organization, International Atomic Energy Agency, and International

Four to die for gang rape

A Lakshmipur court yesterday sentenced four people to death for raping a woman ir Rashidpur village of the district in 2013. The convicts are Nasir, 28, Masud Alam, 20, Md Bahar, 24 and Moheen Hossain, 21. Of them, Masud is on the run.

The court also fined each of the four Tk 50,000.

Additional District and Session Judge Sidur Rahman Gazi passed the order in presence of the convicts, excluding Masud, after examining witnesses and evidences.

According to the prosecution, on August in 2013, the gang picked up the woman from her house in Rashidpur at night and raped her after taking her to a nearby garden.

Locals rescued her later in a critical condition and admitted her to Lakshmipur

Sadar Hospital. Following the incident, the woman filed a case with Lakshmipur Sadar Police Station.

Mohiuddin, Nasir at loggerheads

Chittagong city unit Awami League president ABM Mohiuddin Chowdhury and the unit's general secretary AJM Nasir Uddin continued the war of words against each other yesterday.

After slamming the incumbent city mayor Nasir in the Monday's rally, Mohiuddin, a former city mayor, from a press conference yesterday alleged that Nasir "did not have any clear idea" about how to do development work at a cheaper cost.

"But, he [Nasir] does not come to me for advice," said Mohiuddin at the press conference at Premier University in the city, adding, "If he [Nasir] knew how to take incomegenerating projects, he would not have increased tax."

Mohiuddin said he was also against the increase of holding tax.

Meanwhile, Nasir at his city corporation office told reporters there is no basis for Mohiuddin's allegations.

"Some are saying he [Mohiuddin] has become old and has no control

over what he says," said Nasir. "He [Mohiuddin] wanted to be a mayor and eventually became frustrated once he realised he would not become so in future. Therefore, he is

raising baseless allegations." Nasir also alleged that during Mohiuddin's tenure as a mayor, many "unplanned works" including building markets over drains were done, which remains a main reason for

waterlogging in the city. Nasir said, "He [Mohiuddin] alleged that I bought nomination for the mayoral post...who gave me the nomination? The prime minister gave me the nomination...then who took the money? What did he mean by that allegation...I want to know."

Rivalry between Mohiuddin and Nasir is an old issue which started in the 80s when Nasir was a student leader loyal to Akhtaruzzman Chowhdury Babu, a former presidium member of Awami League and former president of Chittagong (south district) unit AL, in the 80s and 90s, and Mohiuddin, a general secretary of

Chittagong (city) unit AL. The rivalry between Mohiuddin and Babu was well-known at that time, said party sources. The recent conflict between Mohiuddin and Nasir is a continuation of disagreement between the two leaders over a series of issues in the last two years, report our Chittagong correspondents.

VERDICT LEAK CASE SQ Chy's lawyer gets SC bail

The Supreme Court yesterday upheld a High Court order that granted bail to AKM Fakhrul Islam, a lawyer for executed war criminal Salauddin Quader Chowdhury, in a case filed for leaking the draft of Salauddin's verdict a day before a tribunal delivered the judgment.

A four-member bench of the Appellate Division headed by Chief Justice Surendra Kumar Sinha gave the order after dismissing a leave to appeal petition filed by the government challenging the HC order.
