PM THANKS JUDICIARY

Hasina said Bangladesh would have been developed as a prosperous country long ago had Bangabandhu been

Bangabandhu had been in power for only three and a half years and during that period he laid the foundation of all the basic developments of the country, she told the programme.

The PM thanked the judiciary for its courageous role in delivering the judgment in the Bangabandhu murder case.

She also lauded the judiciary for the successful trials of the notorious war criminals of 1971, saying that each of its verdicts was a milestone in making Bangladesh's journey smoother as an independent nation.

Referring to the long process of formulating a law, Hasina said elected public representatives were entitled to frame laws in public interest.

"If any law is declared null and void by a two-member bench, all the efforts behind the process go in vein."

She called for considering the matter more carefully.

The PM said the residential complex was constructed considering the safety and security of the judges and also to provide them with modern housing facilities. Similar steps were being taken at the district and upazila levels.

The CJ said the civilisation in a country flourishes on the capability and independence of its judiciary. "In other words, the best way to measure any government's success is to measure the capability and independence of the country's judiciary."

Maintaining a balance among the state's three branches is part and parcel of the constitution, and the judiciary helps maintain the balance, he added.

Sinha said each organ of the state would have to discharge its duties within the framework of the existing laws and the constitution.

"While performing duties, there could be cold relations among the state's different organs at times. If this is considered positively, creativity would develop in each of the branches. This would help a lot establish the rule of law and ensure people's welfare."

He said the judiciary played a very important role in strengthening democracy in the country.

The biggest challenge to the judiciary was the huge backlog of cases and the inadequate number of judges, the CJ pointed out.

In India, he said, there are 18 judges for one million people, whereas the stone of the complex in May 2011. number is 10 in Bangladesh. "Moreover, there's no infrastructural facility for this small number of judges."

Sinha said there were seven judges

at the Appellate Division and 85 at the High Court Division of the Supreme Court. Among the 85 judges, three were working at the international crimes tribunals and four were seriously ill. "As a result, I often struggle to constitute benches.

The situation would be worse following the retirement of seven judges this year, he said.

About the digitisation process, the CJ said although the government launched the process in almost all the ministries, divisions and departments, the judiciary was not included in it.

He said the judiciary took up the ejudiciary project, but it was interrupted for an unknown reason. He sought the PM's intervention in this regard.

The judiciary always discharged its duties at crucial times of the state and hoped that the pro-liberation government would help the judiciary perform its duties in a stronger way, Sinha added.

Later, the premier unveiled the plaque of the 20-storey Judges Complex. Built on 1.5 acres of land at a cost of around Tk174 crore, the building houses 76 flats.

Housing and Public Works Minister Mosharraf Hossain and Law Minister Anisul Haq were present.

India is responding with a charm offensive of its own. When Bangladesh's prime minister, Sheikh Hasina, made a four-day state visit to Delhi that concluded on April 10th, her Indian counterpart, Narendra Modi, made sure she did not go back empty-handed. He offered \$5bn in loans, including \$1bn for a Russianbacked nuclear plant, Bangladesh's first; and \$500m to buy Indian arms. The two countries signed a defence agreement committing them to deeper co-operation. India promised more cross-border elec-

tricity and railway lines. mattered most to Sheikh Hasina: a treaty on how to share the water of the 53 rivers that flow from India to Bangladesh. One river in particular, the Teesta, has become the focus of attention. Bangladesh wants the water split evenly, whereas the Indian state of West Bengal claims 55%. Mr Modi has

promised to resolve the issue, but his Bharatiya Janata Party (BJP) governs only one of the four states bordering Bangladesh. The chief minister of West Bengal refuses to let him bid away her state's stake in the Teesta. Sheikh Hasina had made an urgent pitch in the Hindu, an Indian newspaper, arguing "friendship is a flowing river". She went home shrugging: "We sought water, but got electricity."

Even if the water of the Teesta was his

Stoking resentment against Muslims, and against illegal immigrants from Bangladesh in particular, has proved a successful electoral formula for the BJP. When the passengers protested, bus

conductor Hanif smiled and said, "We are taking standing passengers from today to begin the new practice but will fix the new fare tomorrow [today]." A section of bus owners had been

ignoring BRTA-set fare charts for many years. They had employed selfdevised "seating service" and charged passengers high fares. But during rush hours they used to take standing passengers. The buses with stickers reading "seating service" glued to their win-

dows didn't hang the fare chart, which was made mandatory by BRTA Rather, they used to show charts they made up for taking extra fares from passengers. In a recent meeting, the transport

owners decided to operate vehicles complying with the route permit that the vehicles would pick passengers from designated stoppages and allow them to travel even by standing.

The transport owners were also ordered not to collect more than the fares approved by the government, Enayet said.

Nazmul Ahsan Majumder, director (enforcement) of BRTA, said five BRTA mobile courts would be monitoring bus operation.

The buses giving seating service got route permits just like others and so same conditions are applied to all of them, he said.

"If these buses don't operate like others, they will face legal action."

"We make boards in different sizes, says Monir Hossain who owns the Pori factory and has been in the business for eight years. A large sized board costs around Tk 2,750 to make and we sell them for up to Tk 3,500. But the best quality board will sell for as much as Tk 10,000."

Medium-sized boards retail for around Tk 2,500 while the smallsized carrom boards for children wil sell for about Tk 1,200.

Mostak Hossain who owns Apon Carrom Board Factory has been in the trade for four years.

"Workers' salaries cost us Tk 4,000 per day," he says. "In this locality there are several factories like ours but elsewhere in greater Jessore carrom board factories are few. Indeed, traders from across the country visit this area to purchase stock." Timber scrap from the factories is sold as fuel for up to Tk 150 per sack, he adds.

"We buy all our carrom boards from the Jessore Khajura bus stand area in New Market," says the owner of Laboni Sports House in Jhenidah's Kaliganj upazila. "The quality of the carrom boards from there is very good, and for carrom sets there is always healthy demand."

US govt hacked SWIFT systems

FROM PAGE 16 relation to the materials released by Shadow Brokers," the company said.

The absence of warning is significant because the NSA knew for months about the Shadow Brokers breach, officials previously told Reuters. Under a White House process established by former President Barack Obama's staff, companies were usually warned about dangerous flaws.

Shook said criminal hackers could use the information released on Friday to hack into banks and steal money in operations mimicking a heist last year of \$81 million from the Bangladesh central bank.

"The release of these capabilities could enable fraud like we saw at Bangladesh Bank," Shook said.

The SWIFT messaging system is used by banks to transfer trillions of dollars each day. Belgium-based SWIFT downplayed the risk of attacks employing the code released by hackers on Friday.

SWIFT said it regularly releases security updates and instructs client banks on how to handle known threats.

"We mandate that all customers apply the security updates within specified times," SWIFT said in a statement.

SWIFT said it had no evidence that the main SWIFT network had ever been accessed without authorization. It was possible that the local

messaging systems of some SWIFT client banks had been breached, SWIFT said in a statement, which did not specifically mention the NSA. When cyberthieves robbed the

Bangladesh Bank last year, they compromised that bank's local SWIFT network to order money transfers from its account at the New York Federal Reserve.

The documents released by the Shadow Brokers on Friday indicate that the NSA may have accessed the SWIFT network through service bureaus. SWIFT service bureaus are

companies that provide an access point to the SWIFT system for the network's smaller clients and may send or receive messages regarding

money transfers on their behalf. "If you hack the service bureau, it means that you also have access to all of their clients, all of the banks," said Matt Suiche, founder of the United Arab Emirates-based cybersecurity firm Comae Technologies, who has studied the Shadow Broker releases and believes

the group has access to NSA files. The documents posted by the Shadow Brokers include Excel files listing computers on a service bureau network, user names, passwords and

other data, Suiche said. "That's information you can only get

if you compromise the system," he said. Cris Thomas, a prominent security researcher with the cybersecurity firm

Tenable, said the documents and files released by the Shadow Brokers show "the NSA has been able to compromise SWIFT banking systems, presumably as a way to monitor, if not disrupt, financial transactions to terrorists groups". Since the early 1990s, interrupting

other militant Islamic groups in Afghanistan, Pakistan and other countries has been a major objective of US and allied intelligence agencies. Mustafa Al-Bassam, a computer science researcher at University College London, said on Twitter that

the Shadow Brokers documents show that the "NSA hacked a bunch of banks, oil and investment companies in Palestine, UAE, Kuwait, Qatar, Yemen, more." hacked" EastNets, one of two SWIFT
