Paddy gone, now fish

MINTU DESHWARA, Moulvibazar

Fish in Hakaluki Haor have started dying since Sunday as half-ripe paddy submerged under flashfloods continues to rot and pollute its water.

It is a double blow to the livelihoods of people dependent on the waterbody after the flashfloods damaged hundreds of acres of Boro paddy just weeks ahead of harvest.

Rotting fish are spreading an unbearable stench and posing health hazards.

"I lost my Boro crop. I thought we could survive with the fish in the haor. But now, all the fish are dying," said Rahim Uddin, a fisherman from Bhuksimul union in Moulvibazar's Kulaura upazila.

People in the haor areas under Sylhet division are going through a similar situation due to the flashfloods late March caused by incessant rain and the onrush of water from



upstream.

Different species of fish -- puti, tengra, bheda, baila, pabda and ruhi -are dying in Hakaluki Haor, one of the country's largest haors, and have started rotting, said Sultan Mahmud, senior fisheries officer of Kulaura.

Acidity in the haor water has also risen. A pH level of 7.5 to 8.5 indicates SEE PAGE 10 COL 4

3 Myanmarese 'smugglers' held after 'gunfight' with BGB

1. First, we thank the BNP, as the party itself cited the supplementary charge sheet of the August 21 grenade attack case as the source of parts of our report that the party objected to.

The supplementary charge sheet said the August 21 grenade attack was the outcome of a collaboration between Huji men, influential leaders of the BNP and the Jamaat-e-Islami, and some officials of the home ministry, police, Directorate General of Forces Intelligence, National Security Intelligence and Prime Minister's Office.

The names of some BNP and Jamaat leaders and ex-top police and intelligence officials were included in the supplementary charge sheet submitted by the CID.

In our report, we just reproduced some information from the charge

In addition, we used the statement Mufti Hannan made before a court after his arrest in 2005. Hannan claimed that law enforcers were not supposed to arrest him since some influential ministers of the BNP-led government had assured him that he would be exempted from the August 21

2. The claims the BNP made in paragraph-2 were not part of our

However, we checked the claims.

Talking to The Daily Star on Sunday, the BSCIC officials in Gopalganj said Mufti Hannan was never allocated any plot. His brother Munshi Anisul Islam was given a plot where he set up a factory to produce candles. The allocation of the plot was cancelled after the incident of planting a bomb near Sheikh Hasina's rally venue in

Kotalipara in July 2000. The BNP's another claim that Hannan said some local AL leaders in Gopalganj were behind the plot to kill Hasina in 2000 was correct. We checked it and found Hannan, who was sentenced to life term in absentia in 2003 in the case over planting the bomb, made the accusation in May

2010. 3. What the BNP said in paragraph-3 of the rejoinder was also not part of

our report. However, we checked the party's claim. On behalf of Hannan, a petition was filed with a court in September 2011 for withdrawing his additional confessional statement in the August 21 grenade attack case, alleging that he

gave the statement under duress. He gave the additional statement in April 2011. Later, the CID submitted the supplementary charge sheet in the

Hannan only sought to withdraw his additional confessional statement, not his first confessional statement. In his first confessional statement in 2007, he confessed that he and his aides carried out the grenade attack.

However, the petition was flawed. It was submitted without any authorisation from the jail authorities. Hannan didn't even seek permission from the court for submitting the petition. It was found that Hannan himself didn't put his signature on the

elder brother are at work," says six-yearold Sohel who is playing in the short yard in front of their home. "They return at noon." With both men and women in each household having spent the morning hours cleaning the street, when they do return all are tired.

"I have been working as a sweeper for 25 years," says Johor Ali, 55, one of Babur's neighbours. "I would be really happy if my job was made permanent."

"We are often neglected," remarks another sweeper, Unus Bappary, 50. "People sometimes insult us. Most people think our work is so dirty such that we are untouchables to them."

"Sometimes our women are harassed," adds Babur, "by someone who has left their house late at night."

Indeed for female sweepers harassment is not the only additional difficulty.

"For the last five years I have worked as a sweeper," says Dolna Khatun, 25. "It's so hard to leave my children at home alone from late at night. But we need this work so that we can eat. Even though our work is hard the authorities do not offer us any employment permanency."

Rubbish truck driver for Faridpur Municipality Ripon Sheikh, 30, worries about his life and his job security. "If the authority decides any day that we are no longer required we'll be unemployed. We have raised the issue with the authorities but no change has been forthcoming."

"I started this job when I was 15 years old," says Sojibur Rahman, 20. "It's five rule."

"The female workers earn Tk 3,000 per month and the male workers Tk 6,000," explains the colony's leader, Rafiq Sheikh, 66. "I myself have been working for 30 years and do not take any extra benefit from my service. Actually, for the last three days I was unable to work due to cold and fever, so I will not get my full month's salary this month We have no security: not in our jobs nor in our lives."
