Troubles within

Men with multiple identities in govt stand in the way of getting transport sector in order

A solution to the chaos in the transport sector seems impossible as the people involved are all powerful.

They are ministers of the government, owners of transport companies and vehicles, and leaders of transport owners and workers organisations. They always protect their own interest rather than the people's interest.

They often violate existing laws and government directives. They even dare to disregard court verdicts and keep people hostage by enforcing strikes.

And now these people are standing against the government when it is about to enact a new law "Road Transport Act-2017". They have announced protest programmes to press for

their demand for withdrawing some clauses of the law which the cabinet had approved.

"With the government's protection, they [transport owners and workers] have gradually become powerful. They think they are all in all and that's why they are not respectful of the court's verdict, and disobey government directives," said Mozammel Haque Chowdhury, secretary general of Bangladesh Passengers' Welfare Association.

The ongoing suffering of city dwellers is the manifestation of the power of these people.

As the Bangladesh Road Transport Authority (BRTA) and the transport owners announced that no public transport would operate in Dhaka in the name of "special service" or "seating service" from Sunday, many owners took their buses off the streets to create a crisis.

Owners pull out around 40pc buses off Dhaka streets, 'aim' to keep charging unfair fare amid government drive

Three days have passed, and there is no sign of any respite. With the city's public transport system going haywire since Sunday, commuters have been left in the lurch as the government has yet to come up with a solution. Amid the drive against so-called "spe-


cial services" that overcharge passengers and yet operate in a chaotic manner, the capital saw many of its rickety fleet of buses and minibuses going off the roads over the last three days.

While Bangladesh Road Transport Authority (BRTA) dumped some buses that had no valid papers, transport owners withdrew many buses from the streets, protesting the drive. As of January, the city had some 6,000

buses run by private operators. In addition, the state-run BRTC operates about 100 buses. Following the drive, private operators

took some 25 to 30 percent of their buses off the roads, said Iqbal Ahmed, a traffic inspector (Tejgaon) of Dhaka


Arrest order for mayor-elect

Graft case of 2008 brings trouble for BNP man in 2017

Days before Monirul Hoque Shakoo would take oath as the mayor of Comilla City Corporation for a second consecutive term, ground has been made for his suspension.

A Dhaka court yesterday accepted the charge sheet in a corruption case filed against him in 2008. It also issued an arrest warrant for the BNP leader.



The acceptance of the charge sheet has created a scope for the government to suspend Shakoo, who won the Comilla mayor polls on March 30. According to Section 12 and 13 of the Local Government

(City Corporation) Act, 2009, a mayor or a councillor, if convicted or charge sheeted in criminal cases, can be suspended. The act also says any elected representative can be removed from office for skipping three consecutive general meetings without any valid reason.

However, it seems that the Local Government Division under the LGRD ministry has all along been strict only while enforcing the act in cases involving elected SEE PAGE 10 COL 1

Bangladesh and Bhutan yesterday stressed the need for boosting regional connectivity and expediting the process of implementing the BBIN initiative to bring prosperity in the region. The issues were discussed at the bilateral meeting

between Bangladesh and Bhutan at Gyalyong Tshogkhang in Thimphu. Prime Minister Sheikh Hasina led the Bangladesh


delegation while her Bhutanese counterpart Dasho Tshering Tobgay led his country at the meeting, reports Our diplomatic correspondent adds: Bangladesh and Bhutan yesterday inked five deals on avoidance of double

taxation, agriculture, standardisation of goods, cultural cooperation and waterways connectivity. Diplomatic sources said Dhaka allowed transit to Bhutan to use its waterways for transportation of goods

imported through Chittagong and Mongla seaports. The deals were signed at the Royal Banquet Hall of Gyalyong Tshogkhang after the official talks between the two countries. The two premiers witnessed the signing of the deals.

Foreign Secretary M Shahidul Haque and PM's Press Secretary Ihsanul Karim briefed reporters after the meeting. Terming the BBIN (Bangladesh, Bhutan, India and Nepal) a major corridor for establishing connectivity in the

region, Hasina urged the Bhutanese PM to expedite the process for ratifying the BBIN motor vehicles agreement addressing its environmental concerns.
