The baby girl, who was rescued from a dustbin in the capital's Mirpur on

March 11, died on early Monday at Dhaka Medical

College Hospital (DMCH). Anisha, a name given to her by doctors and nurses of neonatal intensive care unit, breathed her last around 2:00am, Zahirul Islam, a sub-inspector of Shah Ali

Police Station, told The Daily Star last night. A woman rescued the newborn from a dustbin. Later, Shah Ali police

brought her to the DMCH. Zahirul said an autopsy was conducted yesterday. Anisha was suffering from hepatitis, the SI said citing doctors. Some couples rushed to DMCH with requests to adopt her but the decision was pending with a court.

Compensation given after 26yrs

Family of DU student killed in road crash receives first instalment

Twenty six years after the untimely death of Nafia Gazi, a revered debater and a bright student of Dhaka University, her family yesterday received the first installment of compensation from BRTC (Bangladesh Road and Transport Corporation).

The first payment of Tk 2.5 lakh was handed over to Nafia's father by Road Transport and Bridges Minister Obaidul Quader at the latter's office in the secretariat in Dhaka.

The remainder of the total Tk 10 lakh compensation would be paid within six months, the minister said. "We are trying to prove one thing -- that although BRTC is a state body, it isn't above the law."

On March 29 of 1991, economics student Nafia was crushed under a bus belonging to the government-owned transport service BRTC near Mauchak market in the capital.

Nafia secured first place in her first-year finals. A gifted debater and a writer, she was also involved in various other extracurricular activities in the university. Dhaka University Debating Society organises a debating completion named after her every year. The killing of such a brilliant student caused a huge public outcry.

Madhob Shil, a relative of Pushpo, told The Daily Star that Pushpo went outside home with her granddaughter, Monisha, 2, at 5:00pm on Monday with a distant relative.

The relative told other family members of Pushpo that he was taking her to a Bank as her signature was required to withdraw Tk 50,000.

"We must save our coastal areas and the coastal people. We must save Manpura. A proper utilisa-Dhara Trust.

Zayed Iqbal Khan of Bangladesh Krishak Federation said, "Between 1973 and 2010, Manpura has lost around 34 square kilometres of land. The land is decreasing day by day. A concrete flood control embankment has to be built to protect

Subal Sarkar of Bangladesh Bhumihin Samity said about 20 villages and 10 bazars have gone completely under water. "Even the Manpura town is in a vulnerable condition, since the river is just about 300 yards away."

Mihir Biswas of Paribesh Bachao Andolon said it is necessary to create green belts to save the | Islam. coasts.



5 held with snake venom in capital

Detectives in a drive in the capital's Kuril bus stand area seized 12 pounds of snake venom and arrested five persons

Abdul Baten, joint commissioner of Detective Branch of police, disclosed it yesterday at a press briefing at Media and Community Centre of Dhaka Metropolitan Police.

On information, detectives conducted the drive and seized six glass jars containing venom, and arrested Abu Hanif, Afsar Ali, Nazrul Islam, Muktar Hossain and Rahich Uddin, said Baten.

Checking the market price, police said the maximum price of 12 pounds (5.5kg) of venom might be Tk 25 crore.

In primary interrogation, the arrestees confessed that the venom was illegally brought into the country mainly to sell it to different pharmaceutical companies, which use it for producing medicine, said Baten.
