# PPP can deliver better education

Says lawyer, activist Rokhsana Khondker at UN meeting on SDG

Public-private partnerships (PPP) can deliver effective education and health services, said lawyer and activist Rokhsana Khondker yesterday at a high-level meeting on SDG at the United Nations in New York.

"PPP can ensure better delivery of education in several ways. They can control teacher strikes and absenteeism, they can ensure more effective management of schools...," she said. Rokhsana is one of the four speakers invited by the

president of the UN General Assembly, says a press release. The other speakers are Giulia Porino of Italy, Donna Katzin of the US and Kaoutar Yaiche of Morocco. "The key to forming effective PPPs is to ensure that the

government has strengthened capacity to conducting monitoring and oversight of the private sector. Same kinds of partnerships can be put in place for the health sector," she said. Rokhsana is the founder executive director of Khan

Foundation and founder chair of the Board of Trustees of the Millennium University. She is also an advocate at the Bangladesh Supreme Court and a long standing member of the American Law and Society Association.
