BRTA 'gives in to owners', suspends drive against 'seating service' with special fare

The BRTA has suspended for 15 days its drive against "seating", "nonstop", "gate-lock" and other so-called special bus services in the capital, apparently giving in to pressure from transport owners.

The Bangladesh Road Transport Authority took the decision in a meeting yesterday, a day after Road Transport and Bridges Minister Obaidul Quader publicly expressed helplessness over the matter.

"Another meeting will be called in those 15 days to find out how the seating service can be brought under a legal framework," said Khandaker Enayetullah, secretary general of Bangladesh Sarak Paribahan Samity. He was one of the participants of yesterday's meeting.

Meanwhile, passengers' rights campaigners and commuters expressed frustration at the BRTA decision, saying the government body gave in to pressure from the bus owners. They also termed the decision a defeat of the government and the people to the transport operators.

"This will set a bad example in the history of transport sector and will have an adverse impact on the sector in future," said Ilias Kanchan, chairman of Nirapad Sarak Chai, a platform working for ensuring road safety. He also took part in the meeting.

"What was the necessity of launching such a drive, if you would stop it midway? Today's decision will definitely make the transport owners and workers more desperate," said Mahmud Khayer, a private job holder who was waiting for a bus near Farmgate intersection yesterday.

Recently, the BRTA and the transport owners announced that no public transport would operate in the city in the SEE PAGE 10 COL 5

Marufa Akhtar continued pursuing education after marriage and her illiterate inlaws did not like it.

As she was taking Higher Secondary Certificate exams from Nalchity Degree College in Jhalakathi, her in-laws' family in the absence of her husband, who works in the Middle East, became more harsh on her. On Tuesday afternoon, Marufa's mother

Lucky Akhtar alleged, her daughter's motherin-law, brothers-in-law and sister-in-law tortured her until her death. Later they left the body at Jhalakathi Sadar Hospital.

"There was a spot round the neck of the body," said Golam Forhad, a physician of the hospital, who performed the autopsy. According to the police inquest report the body bore marks of injuries, said

CRIMES DURING 1971 LIBERATION WAR

2 Kishoreganj men sentenced to death

A war crimes tribunal yesterday sentenced two people from Kishoreganj to death for crimes they had committed during the 1971 Liberation War.

"The gravest nature of the offences of 'extermination' 'genocide 'and · mitted crimes during the 'murder' and the accused persons' participation and complicity therewith : Liberation War in 1971. as already found proved shakes human conscience, the humanity and : civilization," said the International Crimes Tribunal-1 in the verdict.

The court said all the six charges brought against the accused -- Syed · Yesmin Khan Munni --Mohammad Hussain alias Hossain, 64, younger brother of convicted war: submitted the charges, criminal Syed Hasan Ali, and Muhammad Moslem Pradhan, 66 -- had been : witnesses' statements and proved.

Red-eyed wasp created for the first time

A jewel wasp has been genetically modified to have red eyes to prove that 'gene editing' technology can be used on such small creatures.

The ultimate goal is to gain greater understanding of insect genetics, which could be used to find new ways of protecting crops or stopping the spread of diseases like malaria.

The researchers, led by Professor Omar Akbari, of the University of California Riverside, said initially they planned to look into the male jewel wasps' unusual ability to ensure all its offspring are male.

Govt misleads people with untrue info

Sultana Kamal on Rampal power plant

Rights and green activist Sultana Kamal yesterday said the government was desperate to go ahead with Rampal power plant despite receiving various findings of international organisations that show adverse impacts of the project.

The convener of "National Committee to Protect the Sundarbans" claimed the government could not reply to different local and international studies that say the plant would harm the biodiversity of the Sundarbans beyond imagination.

"The government is not telling anything real and objective regarding the power plant. In some cases, they are confusing people by providing untrue information," she said at a programme at the city's Dhaka Reporters Unity.

The National Committee to Protect the Sundarbans organised the programme titled "Exim Bank's Finance in Rampal Power Project & Reality of the Sundarbans' Peril by Huge Pollution: Two International Evaluation Reports."

Noted engineer and air quality consultant Dr Ranajit (Ron) Sahu placed a paper titled "Comment on the Government of Bangladesh's response to Unesco regarding air emissions from the Bangladesh-India friendship power plant". Coming down heavily on

India, China to resume stalled talks next week

The stalled consultation process for the BCIM (Bangladesh, China, India, Myanmar) Economic Corridor is set to resume, with officials and scholars from the four countries meeting in Kolkata next week after a gap of more than two-and-half years.

The last meeting of the Joint Study Group (JSG), which has government sanction, was

held at Cox's Bazaar in Bangladesh in December 2014.

Officials from the external affairs ministry and scholars and academics from India will take part in the meeting to be held during April 25-26. The objective behind resuming the dialogue will be to finalise the JSG report.


