The shooting comes just two days after police arrested two men in southern Marseille with weapons and explosives who were suspected of preparing an attack to disrupt the first-round of the presidential election on Sunday.

France is in a state of emergency and at its highest possible level of alert since a string of terror attacks that began in 2015, which have killed over 230 people.

Thousands of troops and armed police have been deployed to guard tourist hotspots such as the Champs Elysees or other potential targets like government buildings and religious

Up until now, polls showed voters more concerned about unemployment and their spending power than terrorism or security, though analysts warned this would change in the event of further bloodshed.

For weeks, centrist former banker Macron and National Front (FN) leader Marine Le Pen have been out in front but opinion polls now show there is a chance that any of the four leading candidates could reach the

second-round runoff on May 7. Scandal-plagued conservative Francois Fillon and far-left firebrand Jean-Luc Melenchon have closed the gap substantially in the last two weeks.

Military police stopped the microbus at a checkpoint at Kachukhet in Dhaka Cantonment area around 8:00pm. They detained the 11 team members of the DB Police East, who were taking away the four men, according to witnesses.

Several locals said the club on the third floor of a six-storey building is known for gambling. The club president, however, refuted the allegation.

Talking to this newspaper on Wednesday night, Abdul Baten, joint commissioner of Detective Branch of Dhaka Metropolitan Police, said the DB team raided the club on information that contraband drug yaba was kept there.

The team was returning after arresting several people and seizing yaba tablets. "When they were stopped by the army, they said they are detectives returning after a raid," he said.

According to the general dairy (no 1,106) filed by police with Kafrul Police Station on Tuesday night, Senior Assistant Commissioner of the DB Ruhul Amin Sarkar, who led the DB team, identified himself to the military police as Major Mosaddek of Rab-4 after the microbus was intercepted at the checkpoint. Eight of the 11 DB men were sus-

pended on Wednesday. They are Subinspector Zahidul Islam, Assistant Sub-inspector (ASI) Lutfar Rahman, ASI Mahbubur Rahman, ASI Tofazzal Hossain, Constable Abdul Latif, Azizul Haque, Jahangir Alam Khan and Tawhidul Islam, said police sources.

Killing of three white men in US racially motivated

A black man accused of shooting three people to death in Fresno, California, wanted to kill as many white men as possible because he expected to be arrested for another shooting, police said on Wednesday, calling the incident a hate crime. Kori Ali Muhammad, 39, fatally

shot the three white men in downtown Fresno on Tuesday after realizing he was wanted for the killing of a white security guard last week, Fresno Police Chief Jerry Dyer said. "Kori Muhammad is not a terror-

ist, but he is a racist, and he is filled with hate, and he set out this week to kill as many people as he could," Dyer told a news conference on Wednesday. Muhammad, who is being held

without bail, has not been formally charged with the deaths of Zackary Randalls, Mark Gassett and David Jackson on Tuesday or Carl Williams last week. It was unclear whether he had obtained an attorney. The FBI is examining Tuesday's

killings as a possible hate crime or act of terrorism but has not yet made an official determination.

Dyer said Muhammad, who went by the nickname Black Jesus, began the series of shootings in the central California city last Thursday when he had a confrontation with a security guard at a motel.

He had been asked to leave the motel and opened fire because he felt disrespected, the police chief said.

Watchdog to vote on Moscow bid for new Syria attack probe

The governing body of the global chemical arms watchdog will Thursday vote on a controversial Russian-Iranian move to set up a new team to probe a suspected chemical attack in Syria, sources told AFP.

The draft decision, seen by AFP, calls for an investigation by the Organisation for the Prohibition of Chemical Weapons (OPCW) "to establish whether chemical weapons were used in Khan Sheikhun and how they were delivered to the site of the reported incident" -- even though an official probe is already underway.

It also calls for investigators to visit the Shayrat airbase -- bombed by the United States after the April 4 attack -to "verify allegations concerning the storage of chemical weapons" there.

The move comes as OPCW head Ahmet Uzumcu said Wednesday that "incontrovertible" test results by the OPCW team already probing the incident had shown sarin gas or a similar substance were used in the attack.

Samples from three people killed in the attack and seven survivors analysed at four OPCW-designated laboratories "indicate exposure to sarin or a sarinlike substance," said Uzumcu. Western nations have accused the

Syrian President Bashar al-Assad, is leading efforts to sideline the OPCW's existing fact-finding mission by calling for a new "full-scale and thorough investigation".

The move has raised hackles at the OPCW executive council meeting this week in The Hague, where nations have lined up to voice support for the existing fact-finding team (FFM).

The team "deserves our full confidence," the Belgian representative to the OPCW told the meeting on Wednesday.

"We don't see the need to put in place a new structure." And the British delegation to the

OPCW said in a tweet that Wednesday's talks showed "once again clear support for the ongoing FFM investigation into the attack." The draft decision, due to be voted

on by the council later Thursday, also calls for member states to "provide national experts for participation in the investigation."
