8 more victims die after 4 days

Eight more people, including a third brother, succumbed to their injuries in the last 24 hours following a boiler explosion at a rice mill in Dinajpur sadar upazila on the night of April 19, bringing the death toll to 12.

Of the remaining 18 people who were also severely scalded, nine are in critical condition in Rangpur Medical College Hospital (RMCH).

Except one, all of the victims worked on day-to-day contracts at Jamuna Automatic Rice Mill in Gopalganj village.

The mill's manager, Ranjit Saha, 40, and Delwar Hossain, 32, passed away at Dhaka Medical College Hospital.

Of the others, Udoy Chandra Roy, 30, Shafiqul Islam, 20, Mukul Chandra Rai, 46, Munna, 32, and Dulal Chandra Roy, 38, died at RMCH and Ripon, 29, at M Abdur Rahim Medical College Hospital.

Earlier, Delwar's brothers Rustam Ali, 40, and Mokshed Ali, 45, and Anjali Rani Roy, 40, and Ariful Haque, 30, died at RMCH.

Meanwhile, workers under the banner of Chatal Mill Workers Welfare Union formed a human chain in front of Dinajpur Press Club in the afternoon and handed over a memorandum to the deputy commissioner.

Terming the deaths "murders", they demanded that the mill's owner be handed down exemplary punishment for negligence and Tk 5 lakh be provided to each victim as compensation.

They also expressed concern over a case not being filed. Talking to The Daily Star, the mill's

owner Subal Ghosh claimed that the boiler had been approved for use by the authorities concerned. A six-member probe committee of

the district administration led by Additional District Magistrate Mahbubur Rahman yesterday got three more days to submit a report.

They have already visited the spot and talked to some workers.

wholesalers and retailers. "From February the price is at its best," says Mozaffar. "It usually decreases slightly by the middle of May." Mozaffar currently realises a net profit of Tk 10 lakh per annum from lemons.

In addition, he sells lemon saplings, 4,000 last year for up to Tk 20 each. "They will yield fruit once they reach three years of age," he says.

His efforts to inspire others have met with success. According to local agriculture officials, over the last several years many tobacco farmers have switched to lemons; and lemons from Ramu are now supplied to markets in Comilla, Chittagong and Dhaka.

"We have been discouraging farmers from growing tobacco," says Ramu upazila's agriculture officer Abu Masud Siddiqui. "Mozaffar Ahmed is a role model farmer in this community. He has personally initiated a 'green revolution' against tobacco cultivation, and throughout the district many regard him as an agricultural 'hero'."

According to Abu Masud, there are currently more than 100 lemon groves

in Ramu upazila and adjoining areas. Kauarkhop union's chairman,

fellow freedom fighter Nurul Haque, says much of the tobacco cultivation in Ramu was his. "Three years ago I moved away from tobacco," he says. "Mozaffar Ahmed inspired me so I learnt how to farm lemons instead." Other former tobacco growers in Naikkhangchhari and Tulatoli villages echoed Nurul's words. "We want to recommend Mozaffar

Ahmed for the Bangabandhu

Agriculture Medal," says ASM Shahriar, deputy director of the Department of Agricultural Extension in Cox's Bazar. "We have always supported his efforts by providing advice and assistance as we can." Mozaffar's innovative efforts are far from completed. Recently, workers in

his Char Haitupi orchard have been busy transforming lemon groves into multi-crop farms, by planting brinjal, tomatoes and species of gourd between the rows of lemon trees.

Mozaffar also dreams of cold storage facilities, and perhaps a processing factory for lemons in Ramu.

Different workers' organisations, survivors and family members of Rana Plaza victims hold a candlelight vigil

yesterday evening in memory of those who perished in the biggest industrial disaster in the country four years ago.

Birendra Das, a farmer of Harinakandi village in Tahirpur, said, "I thought I would be able to save crops on five acres of land in Shanir Haor. The paddy on my other land already went under water. This was my last hope."

The grieving farmer added that he did not know how he would be able to feed his three children and parents without any harvest.

There are 22 haors, including Shanir Haor, in Tahirpur.

Board of Tahirpur, Boro paddy has been cultivated on around 22,000 acres of land in Shanir Haor.

An unusually early flashflood struck as early as late March in entire haor region of Bangladesh's northeast and damaged Boro crops in 1.8 lakh hectares of land in Sunamganj, Netrakona, Moulvibazar and some other adjoining districts.

Conservative estimates put the loss of rice at half a million tonnes. According to statistics disclosed by

the government yesterday, around 1,276 tonnes of fish and 3,844 ducks died in the haors where the level of dissolved oxygen dropped.

BAEC'S TEST RESULTS

Bangladesh Atomic Energy Commission (BAEC) is expecting to get its test results today on possible causes of deaths of fish, ducks and other aquatics.

A 10-member team of experts from the BAEC that collected samples of water, soil, dead fish and ducks, and water hyacinth from five haors and a river in Sunamganj returned to the capital yesterday.

"We will be testing, among other According to Water Development things, presence of radioactive materials in the samples at our Atomic Energy Centre in Dhaka and hope to get the results by tomorrow [Monday]," the BAEC team led by its member (Physical Science) Dilip Kumar Saha told The Daily Star yesterday.
