Civil society activists and environmentalists in Bangladesh have been protesting against the super thermal power plant, saying the coal-fired plant will harm the ecology of the world's largest mangrove forest.

The BHEL, a behemoth in India's public sector, won the contract against stiff international competitive bidding and this is the company's largest power project order abroad.

The order was issued by Bangladesh India Friendship Power Company (Pvt) Limited (BIFPCL), a 50:50 joint venture of National Thermal Power Corporation of India and Bangladesh Power Development Board.

The EXIM Bank of India will provide the loan, for which an agreement between the bank and the BIFPCL was signed in last month.

A facility agreement between the BIFPCL and the Exim Bank for financing the construction of the project was signed at the Taj Palace Hotel in New Delhi in presence of Bangladesh Prime Minister Sheikh Hasina at a meeting of India-Bangladesh Business Forum on April

BHEL's work in the project includes design, engineering, manu-

facture, supply, construction, erection, testing and commissioning of two projects of 660MW each with ultra-supercritical parameters on turnkey basis, the BHEL said in a statement on its website. phone.

It will also set up a jetty and a river water intake system. "This prestigious order is a testi-

mony to BHEL's proven technological excellence and also to its capability in executing power projects of this magnitude and complexity on turnkey basis. The order will also provide a fillip to the company's focus on globalization as a driver of future growth," the statement said.

The key equipment for the project will be manufactured at BHEL's Trichy, Haridwar, Hyderabad, Ranipet, Bhopal, Bangalore and Jhansi plants while the company's power sector construction division will be responsible for construction and installation activities at site.

It also does not say whether the five accomplices of Sohel were Bangladeshis. They are Qari Abdul Aziz alias Abdul Halim, Yaqub alias Saddam Hossain, Asadullah alias Nazimuddin Maimoon, Abu Ibrahim alias Saiful Islam Hasan and Abu Bakr alias Anuj Hasib.

The 13-page statement, titled "Behold", is said to be a transcript of an audio message from the "top AQIS leader Asim Omer". The alleged chief of the Bangladeshi affairs of AQIS and his five companions were mentioned only in a paragraph. The statement was also published in

al-Qaeda's media production house "As-Sahab Media", with a photograph of Sohel, said Bangladeshi law enforcement members.

Sohel's death was first learnt from a video released by As-Sahab Media last month, as mentioned by Ansar al-Islam members in Dawahilallah online forum. Ansar al-Islam is believed to be the Bangladesh chapter of AQIS.

Korea agreed last year to deploy the THAAD to counter the threat of missile launches by North Korea. They say it is solely aimed at defending against North Korea. But China says the system's

advanced radar can penetrate deep into its territory and undermine its security, while it will do little to deter the North, and is adamant in its opposition. "China strongly urges the United

States and South Korea to stop actions that worsen regional tensions and harm China's strategic security interests and cancel the deployment of the THAAD system and withdraw the equipment," Chinese foreign ministry spokesman Geng Shuang told a briefing. "China will resolutely take neces-

sary steps to defend its interests," Geng said, without elaborating. The United States began moving

the first elements of the system to South Korea in March after the North tested four ballistic missiles. The liberal politician expected to

win South Korea's election, Moon Jae-in, has called for a delay in the deployment, saying the new administration should make a decision after gathering public opinion and more talks with Washington.

Television footage showed military trailers carrying equipment, including what appeared to be launch canisters, to the battery site.

Protesters shouted and hurled water bottles at the vehicles over lines of police holding them back.

which we suspect was part of suicide blasts," he added. Heavy sounds of gunshots and explosions were heard near the house till 7:30pm, reports our

Chapainawabganj correspondent. No law enforcers were hurt. "We have suspended the operation at 8:30pm due to darkness," M Khurshid Hossain, deputy inspector general of Rajshahi Range police, told

The Daily Star by phone. Asked about any movement inside, he said they were not sure about that. But he added there were explosives

in the house. "We will resume our operation early in the morning tomorrow [today]." According to CTTC officials, a man named Rafiqul Islam alias Abu, his wife and two children live in the house.

He rented the house in February. Two

nine years ago and the couple has two daughters, aged eight and six. He used to sell different kinds of spices in local markets, his mother said.

She added her son studied at Trimohoni Alia Madrasa in Shibganj and had a circle of about 10 friends. He didn't have good relations with other people.

From his early years, Abu used to practise religion in a different way. For example, he used to celebrate Eids on the day Saudi Arabia observes them.

Meanwhile, police yesterday picked up three people who were in good terms with Abu, a police source said, though there was no official confirma-

The three were identified by the source as Mahfuzur Rahman alias Mohon, Abdus Salam and Monirul Islam.
