

# ACC arrests three Sonali Bank officers in Pirojpur

The Anti-Corruption Commission (ACC) yesterday arrested three officers of Sonali Bank Ltd in Pirojpur for allegedly embezzling around Tk 59 lakh through cheque forgery.

The arrestees -- Senior Principal Officers (SPOs) Shubhas Chandro Chakroborty and Md Ruhul Amin of the bank's Pirojpur regional office, and Principal Officer (PO) Abdur Rahman of the bank's Pirojpur branch -- were sent to jail by a court.

On November 6, 2012, Md Shafiqur Rahman, the then district registrar, filed a case accusing Anjan Kumer Das, office assistant and computer operator of Pirojpur district registrar's office, of withdrawing Tk 25 lakh by forging his signature.

During investigation, the ACC found that six officials of the bank helped Anjan withdraw Tk 58,88,896 against 147 cheques with forged signatures between 2004 and 2012, said ACC officials.

The other officials have been transferred to different branches while the prime accused Anjan is out on bail, said sources.

# MYMENSINGH, JAMALPUR ICT will try four in absentia

The International Crimes Tribunal-1 yesterday decided to hold trial of four men from Mymensingh and Jamalpur in absentia in a case filed over committing crimes during the Liberation War in 1971.

The tribunal took the decision as the four fugitives did not show up before the tribunal even after publication of an advertisement asking them to do so, Prosecutor Abul Kalam said. Earlier, police filed report showing them fugitives.

It also appointed Gazi MH Tamim and Abdus Sattar Palwan as state defence counsel for the fugitives and fixed July 12 for hearing on charges.

The fugitives are Badaruzzaman alias Chand Kazi of Muktagachha upazila in Mymensingh and Nasiruddin alia Kalu, AKM Belayet Hossain, and Ismail Hossain of Jamalpur Sadar upazila.

They are four among eight accused of the case. Other accused Rezaul Haque alias Akkas Moulvi of Muktagachha and ABM Yunus Ali, his brother AKM Yusuf Ali alias Yusuf Alam and Omar Faruk alias Omar Ali of Jamalpur Sadar Upazila are now in jail.

The prosecution on September 7 last year pressed eight specific charges against the eight over war-time offences.

According to tribunal's investigation agency, Badruzzaman was a local Razakar commander while the seven others were involved with Al-Badr Bahini in 1971.

# 3,222 hectares of land to be eroded by 3 rivers this year

## Predicts CEGIS study claiming that most of its 2016 predictions came true

It was not corruption, rather natural disaster that played a key role behind the havoc in haor this year, claimed the water resources minister yesterday.

Many experts are talking about the haor situation with various media, but they were hardly talking about the fact, he alleged.

"Maybe there was some corruption in constructing the haor embankments, but that did not play a significant role behind the havoc in the haor area," claimed Water Resources Minister Anisul Islam Mahmud.

There was heavy rainfall in Cherrapunji of India and the embankments were breached due to the rainwater, he added.

"Only Tk 20 crore from the embankment construction fund was disbursed so far. So, there was no scope of mass corruption as it was claimed," he said.

The minister was speaking as the chief guest at a dissemination seminar on "River-bank Erosion Prediction 2017" in the capital's Cirdap auditorium.

The prediction was made for the Jamuna, the Ganges and the Padma rivers.

This year around 3,222 hectares of land would be eroded by the three rivers in the country, predicted a study.

Out of the total estimated land that experts predicted to be eroded, around 322 hectares will be households, predicted the

corruption, it will come down," he said.

In its report, ACC has made about 65 recommendations to curb corruption.

To reduce irregularities in public examinations, ACC suggested transferring teachers to other schools during the examinations.

It has recommended amending corresponding acts of police to ensure that the law enforcement agency completes probe on time.

To facilitate people obtaining passport, it suggested that the special branch of police should provide a list of criminals to the passport department to reduce harassment.

ACC commissioners Dr Nasiruddin Ahmed and AFM Aminul Islam and its secretary Abu M Mustafa Kamal were present.

and three other top leaders of the alliance [UNA] signed in the declaration of the alliance as individuals, not as chiefs of their respective parties or alliances," said BNA spokesperson Hossain.

Hossain also said they had informed Sunil that the eleven parties would no longer be a part of UNA. There are actually 14 parties in BNA, not 22 as claimed by Moni, said Hossain.

Asked, ABM Ruhul Amin Hawlader, secretary general of JP and chief spokesperson of UNA, said there might be some misunderstandings among different components of BNA. "But we have asked them to resolve their internal dispute."

Hawlader claimed that top leaders of all components in the 58-party alliance were present at UNA's first meeting.

Meanwhile, tensions flared up among different components in "National Islamic Grand Alliance," a partner in the JP-led UNA, sources said.

NIGA, consisting of 34 Islamic organisations, got divided into two factions on Tuesday following internal conflict, sources said.

After a meeting at a city restaurant, Abu Naser Wahed Faruk was removed from NIGA's chief and made Khaja Mohibullah Santipuri as its new chief. Asked, Abu Naser said he is still chairman of NIGA.
