 AGAINST Australia, the Blackcaps lost a cluster of wickets.

England's captain James Anderson was named man-of-the-match for a miserly return of two for 31 in eight overs up front.

Victory saw England into the last four of a tournament featuring the world's top 10 teams. The two international sides after an eight-wicket defeat of Bangladesh at the Oval last week, regardless of the result of their last Group A match against arch-rivals Australia at Edgbaston on Saturday.

Two years ago, New Zealand thrashed England by eight wickets on home soil at the 2015 World Cup in Wellington.

But this decisive win was a measure of England's progress in the 50-over format since that chastening defeat.

England were in danger of falling short of 300 after Joe Root (64), Alex Hales (56) and Ben Stokes (48) all got out when well set. Jos Buttler (27) and Liam Plunkett (6) helped take them to 310 all out.

New Zealand lost their first wicket just four balls into their innings when Luke Ronchi was clean bowled for a golden duck by Ball.

But captain Martin Guptill (27) and Williamson dug in before the former edged an intended drive off all-rounder Stokes to Root at a wide slip.

Both Williamson, posting his fifth fifty as many ODI attacks in England, and Taylor were hit on the helmet by fast bowler Liam Plunkett, who finished with four for 51.

But Williamson still drew Wood back over the head for a fine Cardiff ground ravalling Williamson as a windsew veteran.

Taylor, without being in his fluent best, offered sound support in a stand of 95.

England captain Eoin Morgan, shuffling the pack, recalled Wood and the Durham quack duly delivered the wicket his side badly needed when a rising ball took Williamson's glove and diving wicket-keeper Buttler clung on to the catch.

Wood was the hero of Williamson's 98-ball innings featuring eight fifties. And when Taylor (39) held out off Ball to midwicket, New Zealand were 166 for four in the 34th over.

But Stokes, who had been off Plunkett but fell next ball when he found Hales in the deep.

Leg-spinner Adil Rashid justified his selection in place of the injured Chris Woakes with two for 47 in 10 overs, a 100-ball ending the match when Tim Southee was caught at deep midwicket.

After just 30 minutes' play, the match was halted at 11:00am local time (10:00 GMT) as a national minute of silence in memory of the victims of Saturday's terror attack in London was observed.

Jason Roy hit Adam Milne for four to go to 13 but was then bowled down his legs by the pacester.

His exit meant the struggling Surrey opener had managed just 47 runs in his last seven innings at this level.

Root, fresh from his career-best 137 in the T20 against Bangladesh, twice drove left-arm spinner Mitchell Santner for six. Hales slapped Milne high over long-off before he was bowled next ball by Milne.

Root, deprived of the strike during a stand of 54 with Stokes, saw his innings end when he played on trying to care Anderson, while Stokes uprooted Trent Broot straight to Milne at third man.

But he was extravagantly 'licked' Broot for six and flat-batted another off Milne. Plunkett joined in by pulling Milne for a six that brought up England's 300.

Trump sides with Saudis

 Nations over its alleged support to trade and Islamist groups - emerged at a delicate moment in the crisis as the ruler of Kuwait was to meet in Saudi Arabia to try to mediate the dispute.

It was a key moment for the former Bangladeshi diplomats who told The Daily Star that they did not see any immediate impact of the split on Bangladesh's manpower, economy, trade and investment.

But the diplomatic row continues for long and escalates further, it will affect Bangladesh, as Saudi Arabia and Qatar are two major destinations of Bangladesh workers.

Qatar, which is home to some 4.5 lakh Bangladeshi mostly in its ongoing infrastructure development projects ahead of the 2022 World Cup football to be hosted by Doha.

Though Bangladesh's core foreign policy is "friendship to all and malice to none", the Saudi Arabia joining the US is in discussion to keep it well-prepared if any "uncomfortable" request comes from Saudi Arabia, the diplomats told this newspaper.

Bangladesh has recently strengthened ties with the Saudi Arabia joining Saudi-led coalition while it also maintains very good relations with Qatar.

Qatar vehemently denies the accusations against it, calling them baseless. Ordinary Qataris, however, were the US experts trying to put the pressure on to stock up on goods against the crisis.

Trump said, in apparent reference to the Gulf Arab powers Saudi Arabia and the UAE, that leaders he met on his trip warned him Qatar was funding "radical ideology" after it had demanded they take action to stop financing militants.

It was not immediately clear what US officials' high profile intervention into the crisis was.

The US officials said on Monday that the United States would quietly try to calm the waters between Saudi Arabia and Qatar, arguing that the small Gulf state was too important to US military and economic interests to be isolated.

Qatar hosts 8,000 US military personnel at al Udeid, the largest US air base in the Middle East and a staging ground for US-led strikes on the Islamic State militant group that has spread across Syria and Iraq.

There are also deep financial and business links between the two based on Qatar's leading world role in gas.

Gulf Arab officials said Kuwait's Emir Sheikh Sabah Al-Ahmed Al-Jaber Al-Sabah will meet Saudi Arabia's King Salman hoping to heal the damaging rift which has affected global oil prices, hit travel plans and sown confusion among bankers and businesses in the region.

Qatar has also been the target of consequences for the Qatar economy, a number of banks in the region began stepping back from business dealings with Qatar. Saudi Arabia's central bank support for militant groups.

During a visit to the CAAB headquarters on Monday, EU Ambassador in Dhaka Pierre Mayaudon informed CAAB chief Air Vice-Marshal Shehan CBI Chowdhury about the decision to equip Bangladesh's border list sources at the CAAB and the civil aviation ministry said.

Following the EU decision, which came into effect from June 1, businesses and passengers travelling at a third airport en route to an EU country, said AHM Ziaul Haque, additional secretary of the ministry.

To get its name dropped from the list, the airport had to be equipped with sniff first but to ensure screening through bomb detection dogs or equipment before loading.

Group Captain Kazi Iqbal Karim, CAAB's Air Marshal, International Airport, yesterday told The Daily Star that the airport authorities have started screening goods using the explosive detection dog unit with the assistance of Rapid Action Battalion and Border Guard Bangladesh.

"The first cargo consignment that went through the screening weighing 30kg and was loaded onto an Etihad flight," he said.

Sources at the CAAB or the ministry could not confirm whether the EU will lift the cargo restriction following introduction of the sniffer dogs.

CAAB's Air Marshal, International Airport also told the CAAB chairman that the EU will send a aviation security team for inspection if Dhaka introduces necessary security equipment at the airport and international airport.

Before informing the EU, Bangladesh will have to get clearance certificate from the International Civil Aviation Organisation on successful security equipment installation.

Speaking to this newspaper, SM Jahangir Hossain, president of Bangladesh Fresh Vegetables and Allied Products Exporters Association, yesterday said why did CAAB do so much in this introduction into the sniffer dogs.

Last year, he mentioned, Australia, the UK and Germany termed Bangladesh a high-risk country and imposed a ban on direct cargo flights through security agency Izarrat Shajhail International Airport.

The name-e-janaza of Justice Latifur was held on the SC premises after Zohr prayers.

He was buried at Banani graveyard around 10pm. Burial master Hafizur Rahman Khan a relative of the deceased, told The Daily Star.

Born in Jessore in 1936, Latifur studied English literature at Dhaka University. He got his LLB from the LLB in law from the same university.

He got the membership at the Dhaka High Court in 1960 to start a career as a lawyer. He took oath as a permanent HC judge in 1981 and became an Appellate Division judge on January 15, 1990.

Latifur became the chief justice on January 1, 2000 and retired from his post on February 28, 2002. He took oath as the chief of the caretaker government on July 15, 2001 and carried out duties till October 10 of the same year.

The 8th parliamentary election was held on Oct 1, 2001 under the caretaker government led by him. The BNP-led four-party alliance came to power through this election.
