

I was evicted illegally
Moudud claims at press briefing

BNP standing committee member Moudud Ahmed yesterday alleged that Rajdhani Unnayan Kartripakkha (Rajuk) evicted him illegally from the Gulshan residence as it did not serve him any prior notice.

"Now I am living at my Gulshan apartment where I have to sleep on the floor as my bed needs to be repaired," he said, while addressing a press briefing at the Supreme Court Bar Association (SCBA) auditorium.

Journalists stand by colleague sued under section 57
 Demand withdrawal of case by Sunday

Journalists yesterday gave a 48-hour ultimatum to withdraw a case filed by a judge against a bdnews24.com journalist under section 57 of the Information and Communication Technology Act.

They threatened to go for tougher movements, including besieging of the information ministry, on Sunday if their demand is not met by that time.

The journalists demanded that the section 57 be scrapped during the ongoing parliament session as it is misused to harass newspersons.

They were addressing a human chain in front of the capital's Jatiya Press Club protesting the case filed against reporter Golam Mujtaba Dhruva for his report, published on June 11.

The report says that a truck, which was parked on a road in Resene Tunka area for shifting of the judge's house, blocked the way for an ill child, who was being taken to a hospital.

According to the report, this created an altercation

The six accused are Shahadatullah Jewel; banned militant outfit Harkat-ul-Jihad-al-Islami leaders Mufli Hanan, Obaidullah Rahman, Anis Morsalin and Mahbul Moutarik; and Narayanang City Corporation councillor and local BNP leader Shawkat Hashem Shahu.

Of them, Mufli Hanan has been hanged, Anis Morsalin in an Indian jail while Shahu and Obaidullah Rahman are now freed on bail. Complainant of the case and Narayanang town AL General Secretary advocate Khokon Saha demanded speedy trial of the cases.

Public Prosecutor Wazed Ali Khokon said they demanded that the government bring back the two accused from India.

While talking to the Daily Star, Chandan Shil, who led both his legs in the bomb attack and also a leader of Ekattorer Chatak Dalac Nirmul Committee in Narayanang, also demanded that the accused are brought back from India.

 "You can call it eviction. But I don't. It is protecting people from the risks of death," Quader said. "We must think about livelihood, but life comes first. As public representatives, we must protect lives. People have to be forced out of hills for saving their lives. If needed, force should be applied to do that."

The minister also put the emphasis on rehabilitation of the people living on the hills and directed the district administration to take necessary steps in this regard.

When it was pointed out that the poor do not want to leave their dwellings, he said this mentality needs to be changed through an awareness campaign. The administration and the mayor, all have to come forward to lead the campaign, he said.

The minister also directed Mayor AZM Nasir Uddin to take steps to reduce waterlogging in the city. "It should be the top priority of the mayor," he said.

Mayor Nasir, Deputy Commissioner of Chittagong Zillur Rahman Chowdhury and lawyer Dr Afisul Amin were with the minister during his visit to the affected areas.

The trial in Bangladesh killing case started in Dhaka in 1997. The Supreme Court in 2009 upheld the death penalty of 12 convicted ex-army officers for the assassination.

Five of the convicts - Syed Farooq Rahman, Sultan Shahriar Rashed Khan, Bazul Huda, AKM Mohiuddin Ahmed and Mohiuddin Ahmed - were hanged on January 27, 2010, while a sixth convict, Aziz Pasha, died in Zimbabwe in 2001.
