Proper hill management a must to check landslides

Experts tell Ctg meeting with national committee

Proper hill management based on geological survey is required to check landslides and its consequences in hilly areas like Chittagong Hill Tracts (CHT), said experts at a meeting yesterday.

The National Committee, formed by the Ministry of Disaster Management and Relief, held the meeting with experts in the conference room of Chittagong Divisional Commissioner Office.

The 27-member committee, formed after the recent landslides that killed over 150 people in Chittagong, CHT, and Cox's Bazar district, started working from Monday and also visited the landslide-hit Rangamati district yesterday.

Convenor of the committee, Satyabrata Saha, also the additional secretary of the ministry, said they would talk with all the

stakeholders, including landslide victims, and then prepare recommendations for their future plans.

Stressing the need for forming upazila-level branches of the committee, Prof Md Shahidul Islam of the geography and environment department of Dhaka University said it is not possible to save hills without field-level monitoring and supervision.

Abdul Haque, associate professor of geography and environment studies department of Chittagong University, said vulnerable hills have to be marked first.

"We have no geological survey. We do not know internal structures of specific hills in particular areas. Then how would we address the issue?" he asked.

UNDP Recovery Advisor Seeta Giri and Joint Secretary to the ministry Dr Ardhendu Shekhar Roy also spoke.

Restore river, canals

Once its capacity is raised, the river will be able to hold the excess water during high tides and thus delay entry of tidal water into connected canals as well as adjoining low-lying areas, he explained.

In the second phase, all ponds and water bodies, especially canals and drains will need to be reclaimed from illegal occupation and water retention capacity of all the canals and drains should be enhanced through excavation and restoration, Shahinul said.

Long-term steps should also be taken so siltation and littering does not clog these up and both sides of the water dispersion channels remain unobstructed, he said, adding that in the third phase, navigation gates and sluice gates should be installed at the mouth of the Karnaphuli to control the flow of water into the canals.

The CDA chief town planner also recommended building of water retention reservoirs at the river mouth.

Meanwhile, Chittagong City Corporation Mayor AJM Nasir Uddin in a press conference on Monday said the CCC had taken a number of projects including excavation of a new canal and a 4,600 foot-long drain and clearing of existing canals and drains from obstruction and siltation.

NEWS IN brief

Indo-Bangla dialogue ends

The Eighth Round of India-Bangladesh Friendship Dialogue ended yesterday in India's Guwahati.

The dialogue prepared a vision document and research report on "North-East India and Bangladesh: Borders as Prosperity Zones". The dialogue also assessed the possibilities and modalities for designing sustainable and forward-looking mechanisms in joint finance and promotion of both innovative and high-end value-added products and services. It suggested a security and economic vision of South Asia for 2030.

Bangladesh State Minister for Foreign Affairs Md Shahriar Alam, in his concluding remarks, emphasised greater collaboration between North East India and Bangladesh.

Governor of Tripura, Tathagata Roy, introducing himself as a friend of Bangladesh, mentioned that Bangladesh should get its fair share of water from the river Teesta, says a foreign ministry press release.

The three-day event from July 2 ended after the adoption of Guwahati declaration styled, "Bangladesh-India Relations: Into a Brave New World", which suggested organising an India-Bangladesh Business Summit.

The next round of dialogue would reconvene in Cox's Bazar, Bangladesh, at the beginning of 2018.

Red Cross Society of China donates US\$ 100,000 to flood-hit people
