## Sholakia attack victim Jharna remembered

Jharna Rani Bhowmik, a victim of Sholakia terror attack, was remembered at a meeting organised by the family on her Char Sholakia house premises in Kishoreganj town yesterday.

The speakers placed wreaths at her portrait built near her house. Kishoreganj Zila Parishad Chairman Zillur Rahman, among others, spoke on the occasion.

A religious ritual was also held at Jharna's house, marking first death anniversary of the 40-year-old, wife of Gourango Nath Bhowmik.

Jharna and three others were killed in the attack on the largest Eid congregation in Sholakia on July 7 last year. On that day, a bullet hit Jharna's forehead through a window while she was cooking in her house near the Eid congregation.

# Five killed

Five people were killed and 22 others injured in road accidents in Comilla and Magura on Thursday and yesterday.

Our Comilla correspondent reports, three people, including two of a family, were killed and two others injured as a CNG-run auto-rickshaw was hit by a lorry on Dhaka-Chittagong highway in Lokhipura of Comilla Sadar upazila yesterday, said police.

Mahmuda Akter, 25, wife of Ikram Hossain, her one-and-half-year-old son Arshad Hossain and the auto-rickshaw driver Monir Hossain died on the way to Dhaka.

The injured -- Ikram Hossain, 40, and her daughter Nafisa Akter, 6, -- were sent to Comilla Medical College Hospital.

Our Jhenidah correspondent adds, two passengers were killed and 20 others injured in a head-on collision between two buses in Alamkhali Bazar area of Magura Sadar upazila on Thursday night.

One of the deceased is Habibur Rahman Swapan, 24, son of Abdur Rauf of Kanaidanga village in Chuadanga.

The injured were admitted to Magura Sadar Hospital.

## 4 'Neo JMB' men held

interact with the artists to know about their feelings and understandings."

"While writing, she would employ the artists' opinions with her own realisations. This set a unique standard and quality in her writings. There are a very few art critics in our country, of those, English writers are even rarer. Fayza Haq was the finest among the art critics who wrote in English. She was my favourite art critic."

"She could mingle with artists with ease. Fayza Haq was popular among young artists... A vacuum has been created in the field through her demise. The artist community will remember her forever," he added.

Acclaimed artist Kalidas Karmakar, said, "I feel sad hearing the news of Fayza Haq's departure. May God rest her soul in peace. She wrote an article on my first solo exhibition in 1976. Since then, we shared a close bonding."

Fayza began writing for The Daily Sun (Pakistan) in 1970 while she was teaching at Karachi University. Continuing two professions simultaneously was a problem for her and subsequently her father asked her to choose between them. Fayza then decided to continue journalism and switched to The Morning News (Pakistan).

Later, she worked at The Bangladesh Observer and The Bangladesh Times until joining The Daily Star at its inception almost a quarter century back.

She continued writing for the daily even after her retirement in 2015, on a variety of topics.
