

# Swechchhasebak League man hacked to death

## Jubo League leader blamed in Thakurgaon

A local Jubo League leader allegedly hacked to death a local Swechchhasebak League leader in Munsirhat under the municipality on Tuesday.

The victim was Abdul Mannan, son of late Tasir Uddin of Islamnagar area and treasurer of Sadar upazila unit of Swechchhasebak League.

Police and locals said Mannan was going from the town to Railway Station area on a motorbike when Sajib Dutta, joint secretary of Sadar upazila unit of Jubo League, and his friend Shanta, intercepted him near art gallery area. They chased Mannan to Munsirhat area when he tried to flee.

Jummon and Jony Ulubbi went to Munsirhat when Mannan phoned them for help.

Sajib and Shanta allegedly hacked Mannan indiscriminately and hit Jummon with an iron rod, leaving them badly injured, while Jony managed to flee.

Locals took them to Thakurgaon Sadar Hospital where the doctor declared Mannan dead.

Jony told police that Sajib and Mannan engaged in an altercation last week over a

small matter, which led to a scuffle between them. Sajib threatened that Mannan would face a dire consequence soon, Jony added.

Leaders and activists of Awami League and its front organisations rushed to the hospital and demanded immediate arrest of the killers without considering political identity.

Upazila Swechchhasebak League President Shahnewaz Qadir Choudhury alleged that Sajib had been involved with tender scam, land grabbing, snatching and drug trading for long, using the influence of his brother Subhashish Dutta Samir, general secretary of the district Jubo League.

Residents of Islamnagar blocked a road demanding arrest and punishment of the killers. They warned that they will not lift the blockade until their demand is met.

Superintendent of Police Farhad Ahmed yesterday said the killers have been identified and police are conducting drives to nab them.

Additional police forces have been deployed at different places in the town to avert any untoward incident.

# UZ engineer sued over corruption

The upazila engineer of Nazirpur in the district has been sued over corruption.

Md Atiar Rahman Choudhury, former chairman of Sheikhmatia union parishad in the upazila, yesterday filed the case before the court of Special Tribunal Judge Md Golam Kibria, also District and Sessions Judge of Pirojpur.

The court sent the case to Anti-Corruption Commission, said M Shah Alam, lawyer of the plaintiff.

According to the case, Md Jakir Hossain Mia, Nazirpur upazila engineer, committed corruption regarding development works involving Tk 22 lakh and 1.20 lakh in 2016-2017 and 2015-2016 fiscal years.

# Tangail Bar expels AL leader for using fake certificate

Tangail Bar Association on Monday expelled an Awami League (AL) leader on charge of forging academic certificate and suspended membership of another for embezzling money from the association's fund.

Asaduzzaman Liton, also former joint secretary of district AL and a member of Awami Ainjibi Parishad, was expelled permanently from the association for forging academic certificate.

Besides, membership of Mohsin Shikder, former general secretary of Tangail Bar Association and vice-president of Kalihati upazila unit of AL, was suspended for a month for misappropriating money from the association's fund.

District Bar Association took the decision at a special meeting on Monday and informed the duo through separate letters yesterday.

Tangail Bar Association General Secretary Abu Raihan Khan said an allegation was raised against Liton for forging Higher Secondary Certificate. He was asked to submit his original certificate before the incumbent association members about one and a half years ago, Raihan added.

As he did not comply with the association's order, they decided to expel him, Raihan said.

Meanwhile, the inquiry committee found that Mohsin had spent Tk 13 lakh from the association's fund without any approval, he said.

# Current hampers ferry service on Paturia-Daulatdia route

## Vehicles get stuck in lines as ferry trips take much longer time

Seventeen ferries including nine Ro Ro's, five utilities and three K-type ferries are in operation on Paturia-Daulatdia route, said Md Nasir Chowdhury, deputy general manager (Commerce) of Bangladesh Inland Water Transport Corporation's Aricha regional office.

Due to the increased water level and strong current of the Padma and Jamuna, the ferries spend much more time than usual to cross the river. This reduced the number of ferry trips, and consequently the numbers of vehicles waiting for the crossing.

"We will have to wait for decrease in the river current for the ferry services to be normal," Nasir said.

Ferry service on Paturia-Daulatdia river route sees serious disturbance since Tuesday due to strong current and continuous increase of water in the Padma and Jamuna rivers.

Thousands of passengers of 17 south and south-western districts of the country have been suffering at the ferry terminal area for hours.

Over 300 vehicles including 200 goods-laden trucks were seen lined up at Paturia ferry terminal around 4:00pm on Tuesday.

The water of the Padma and Jamuna near Aricha increased by 21 centimetres in 24 hours till yesterday afternoon, said Hasan Mahmud, executive engineer of Manikganj Water Development Board.

During this correspondent's visit to Paturia Ghat on Tuesday, Golam Mawla Mohammad Amzad Hossain, engine officer of a Ro-Ro ferry, said the ferry now requires double the time than normal to cross the river.

Because of increase in the water level, the pontoons of both the gates have to be lifted to higher level and it hampers loading and unloading of the vehicles on and from the ferries.

"I have been waiting at Paturia ferry terminal for the last two days. Having spent all the money given by the truck owner, I am to face an uncertain wait for getting the turn," said truck driver Sumon Mia.

Hampering of ferry movement on Shimulia-Kawrakandi route since Monday also adds to the pressure of vehicles, especially trucks, said officials concerned.

The authority is giving priority to buses, minibuses and cars to avoid passengers' hassle.

Meanwhile, there are allegations that the drivers of vehicles waiting for getting into the ferries have to give 'extra amounts' as per the demand of the people in charge of the maintenance of serial and booking counters.

Transport workers were seen protesting it in front of the serial counter on Tuesday.

Rise of water level and strong current in the river also hampers movement of cargo launches and engine-run boats on Aricha-Kazirhat route.

It is almost impossible to move on the road during monsoon due to its muddy condition. People cannot walk even during dry season due to dust, he said.

President of the parishad Prof Mir Mokhseedul Alam, general secretary Kashinath Sarkar and Bangladesh College University Teachers' Association district committee general secretary Prof Asutosh Roy spoke at the programme.

They also demanded nationalisation of the education system.

The speakers said they will go for tougher programme if the government does not take initiative to fulfil their demands immediately.


Meanwhile, teachers of non-government schools and colleges formed a human chain in Bogra town realising the same demand, reports our correspondent.
