## PM tells doctor

Dr Samanta Lal Sen, a member of the medical board constituted for her treatment, said the premier asked the doctors to treat the girl with utmost importance when he met her at the Prime Minister's Office (PMO) yesterday noon.

Dr Sen, also national coordinator at National Institute of Burn and Plastic Surgery of DMCH, said Muktamoni's medical reports have been sent to Singapore General Hospital

### HC declares DU teacher's appointment illegal

The High Court yesterday refused to grant bail to Ariful Islam Sohel, owner of Ghoroa Hotel and Restaurant at Motijheel in Dhaka, in his 16-year-old staff Riad killing case.

The HC also dropped Ariful's bail petition, said DAG Md Bashirullah. Ariful tortured Riad, accusing him of stealing a mobile phone and Tk 1,500 and shot the boy to death in Swamibagh on October 28, 2015.

Attorney General Mahbubul Alam told The Daily Star that the HC declared the appointment of Tofail as a DU teacher illegal, as his qualification was lesser than that of the writ petitioner. He, however, said that the HC did not direct the DU authorities to appoint writ petitioner as their teacher.

### Verdict on 4 children's murder today

The Speedy Trial Tribunal in Sylhet is set to deliver verdict today in the case over killing of four schoolboys in Bahubal upazila of Habiganj in February, 2016.

Monir Mia, 7, Zakaria Shuvo, 8, Tajel Mia, 10, and Ismail Mia, 10 – were killed on February 12 over enmity between their fathers and their rival group in village arbitration council.

Detectives on April 5 pressed charges against Abdul Ali, his two sons Rubel Mia and Jewel Mia, Habibur Rahman Arju, Shahed Ahmed Bashir, Bachchu Mia, Babul Mia, Ustar Mia and Billal Mia. Arrest warrants have been issued against fugitives -- Babul, Ustar and Billal. Bachchu was killed in a "gunfight" with Rab on February 25, 2016.

Earlier, on July 17, the Bangladesh High Commissioner in Malaysia also called on the director general of the Malaysian immigration department to address the issue of blanket detention and harassment in Malaysia, the foreign ministry officials said.

In a notable incident on July 20, Odhikar General Secretary Adilur Rahman Khan was denied entry into Malaysia despite having a valid visa and all other travel documents. Upon arrival at the Kuala Lumpur Airport, he was detained for several hours before being sent back to Bangladesh.

The Met Office recorded 72 mm rainfall in 24 hours till 3:00pm yesterday from Monday.

Dr Edris Alam, an associate professor of Department of Geography at Chittagong University, said tidal water reached the highest level naturally yesterday.

The level usually goes up during the full moon or the dark moon, he said, adding, "The high tide of last two days was influenced by the dark moon."
