

VC PANEL SELECTION SC okays DU senate meeting

The Supreme Court yesterday cleared the way for holding a special general meeting of Dhaka University's senate on July 29 for selecting a three-member panel to appoint its new vice chancellor.

Following a petition filed by DU, the chamber judge of the Appellate Division stayed a High Court order that halted process of the senate meeting scheduled to be held on July 29.

The chamber judge also sent the stay petition to the full bench for its hearing on July 30.

Sixteen teachers and registered graduates of DU have filed a writ petition with the HC saying that there is no full-fledged senate.



Bannya receives Feroza Begum memorial award today

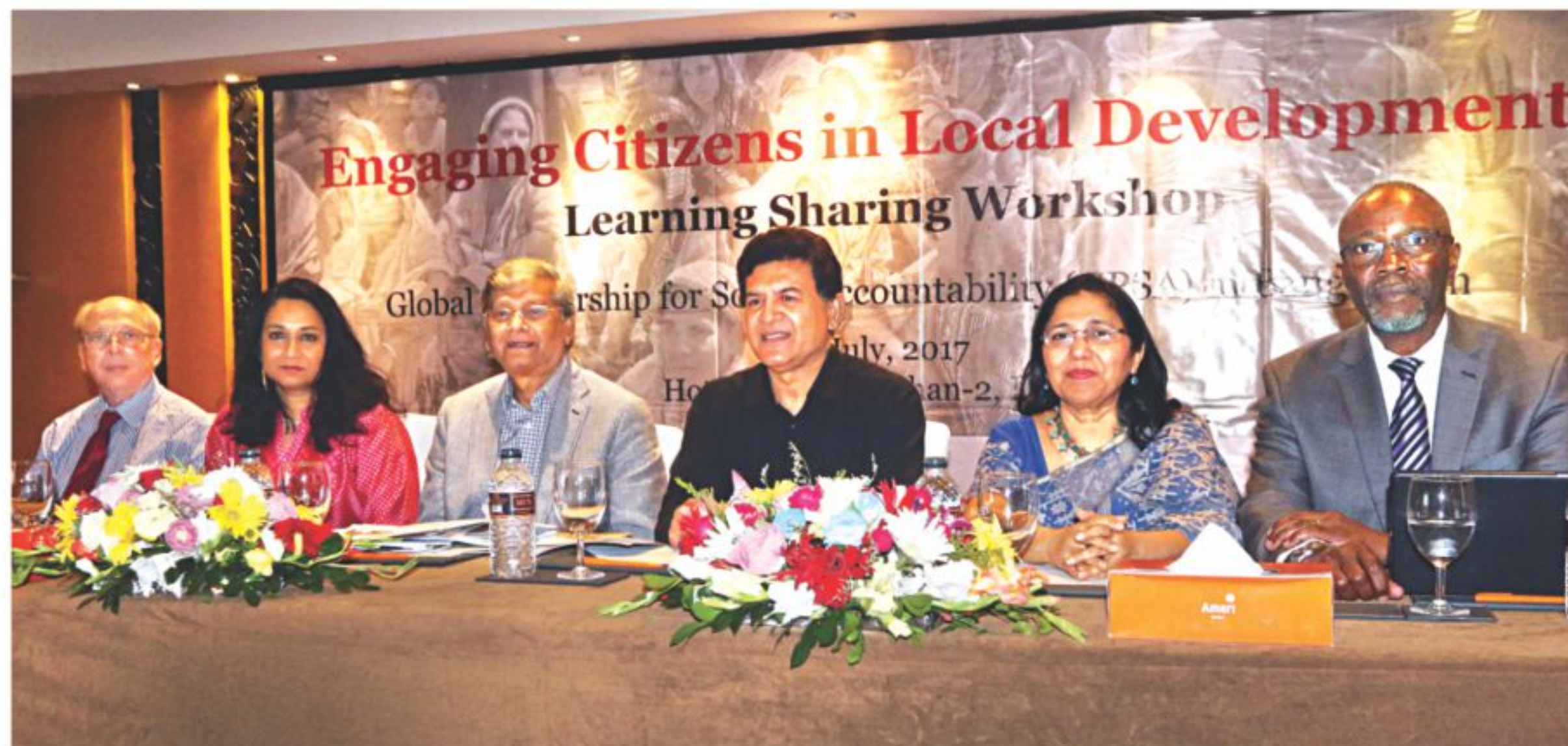

Engagement with local govt empowers people: Experts

Citizen engagement with local government institutions has significantly increased the proactive disclosure of information, strengthening people's ability to hold union parishads accountable in their activities, such as in project implementation, annual plan and budget drafting, said policymakers and experts yesterday.

They said participation of locals, especially women and marginalised communities, also increased in budget and ward meetings following implementation of two projects, SEBA and JATRA, under Local Government Support Project 2, which ends this month.

Manusher Jonno Foundation (MJF) implemented SEBA, and CARE Bangladesh JATRA, in 45 unions of seven districts in the last three years.

The projects' outcomes were shared at a workshop, "Engaging Citizens in Local Development -- Lessons Learned from the Experience on the Ground of Global Partnership for Social Accountability (GPSA)" in Hotel Amari in the capital.

GPSA, MJF, CARE and the World Bank organised the workshop, revealing the impacts and lessons of constructive citizen engagement under the GPSA framework.

Emphasising continuation of such projects focusing on local governance in Bangladesh, State Minister for

Finance and Planning MA Mannan said civil society always monitored activities of elected bodies, and this was very important for development.

"We have very vibrant civil society groups in our country, mostly at the national level. They will have to work at the local level to monitor development works," said Mannan. He appreciated activities carried out under SEBA and JATRA.

Power and Participation Research Centre Chairman Hossain Zillur Rahman said effective engagement of citizens was the key to reaching larger goals, both in Bangladeshi and global context. "This is the largest issue not only in Bangladesh but also around the world and important for local development," said Rahman, former adviser to a caretaker government.

"A few years ago we asked people to raise their voice and now we are asking them to raise their voice strongly, which is very important and under this project people also learned to raise their voice strongly and effectively," he added. "For innovation we also need to ensure citizen engagement," said Rahman.

Shaheen Anam, executive director of MJF, said citizen engagement was critical to increase the impacts of development projects at the local level.

"We have faced a number of challenges but found huge success in our projects and received a great deal of

support from the government and built partnership with local government bodies," added Anam. She also said opinions of ordinary citizens, including women, would have to be valued.

Country Director of CARE Bangladesh Nick Webber said their organisation had long experience working with local government in Bangladesh, and was committed to collaborating and sharing resources and experiences.

Rajashree S Paralkar, operations manager at the World Bank, and Jeff Thindwa, practice manager at GPSA, gave presentations.

They said allocation for health, human development, and water supply increased, the amount was reduced for infrastructure development from 2014 to 2016.

Following implementation of the projects, citizen participation also increased significantly, especially of women and poor people, according to the presentations given by Ziaul Karim from SEBA and Anowarul Huq from JATRA. They said locals' presence in union parishad meetings was around five percent previously; later it went up to 68 percent while issues raised by the poor and women reached 55 percent and 25 percent respectively.

The event was chaired by Luiza Nora, citizen engagement coordinator for South Asia at the World Bank.

Lawyer Manzill Murshid gets death threat

Supreme Court lawyer Manzill Murshid has allegedly got a death threat from some men of a drug company, for challenging a report that was in its favour.

Manzill, also the president of Human Rights and Peace for Bangladesh (HRPB), yesterday lodged a general diary (GD) with Shahbagh Police Station in this regard.

He said two to three men belonging to the drug company threatened to kill him on the Supreme Court premises yesterday when he was getting out of a courtroom after opposing a petition of the drug company praying to the High Court for allowing it to produce medicines.

The hearing on the petition has been adjourned for a week.

In the GD, Manzill said due to the incident he now feels insecure. They may also harm his family as he moves cases for public interest. He also requested police to take necessary legal actions.

Following a writ petition filed by HRPB, the HC on April 3 directed the health secretary to form a five-member committee in 15 days to monitor whether 28 drug companies were following the Good Manufacturing Practice set by the WHO.

As the health secretary formed a four-member committee excluding a WHO representative, the HRPB moved a contempt of court petition before the HC on July 17 against the secretary and a senior assistant secretary to the health ministry.

The HC the same day issued a contempt of court rule against them for not properly complying with its order.

Meanwhile, the HC directed the officer-in-charge of Shahbagh Police Station to produce the people who threatened Manzill Murshid before it by today, Manzill Murshid told The Daily Star last night.

Contacted, OC Abul Hasan told this correspondent that he is yet to receive any such order.

Abida obtained her Master's degree in sociology from Dhaka University and another Master's degree in "Foreign affairs and trade" from Monash University, Australia.

Death penalty for carrying Yaba pills

Govt to amend narcotics law

The government is going to amend the "Narcotics Control Act 1990" to include death penalty for carrying over 250 pieces (25 grams) of ATS (amphetamine-type stimulants) drugs such as Yaba.

The maximum punishment under the law for carrying same quantity of ATS is 15 years of imprisonment.

This new provision has been included in the law's draft amendment, Mukul Jyoti Chakma, deputy director of Department of Narcotics Control (DNC), told The Daily Star yesterday. "Several other changes will also be brought in the law, including power to conduct mobile court to ensure capital punishment for drug traders," he also said.

According to DNC, the draft of "Narcotics Control Act 2017" was sent to the home ministry on March 21 this year. Meanwhile, Home Minister Asaduzzaman Khan Kamal at a programme yesterday said, "We have already taken steps to amend the Narcotics Control Act 1990 to ensure the highest punishment for drug traders."

The minister was addressing a discussion on the occasion of International Day against Drug Abuse and Illicit Trafficking 2017 in the capital. Dhaka Ahsania Mission was awarded first prize for its contribution in the field of drug prevention at the programme.

Omar Faruk Chowdhury, MP and member of the Parliamentary Standing Committee on home ministry; Farid Uddin Ahmed Chowdhury, secretary of security services division of home ministry; and Jamal Uddin Ahmed, director general of DNC; also spoke.

PEOPLE WITH DISABILITIES Participation key to ensuring their rights

NHRC, UNDP meeting told

People with disabilities should be involved in various economic and social activities for protection of their rights and their integration into the mainstream of society, a meeting was told yesterday.

The speakers recommended inclusive education, adequate transport facilities, and budget increase for the special needs people and their representation in local government.

National Human Rights Commission (NHRC), in association with the United Nations Development Programme (UNDP) in Bangladesh, organised the meeting at Brac Centre in the capital to prepare a national plan of action for people with disabilities.

Speaking as chief guest, NHRC Chairman Kazi Reazul Hoque said the government should come forward to ensure their rights because many targets of Sustainable Development Goals (SDGs) involved these people.

Gazi Mohammad Nurul Kabir, director general of the Department of Social Services, said the government had brought people with disabilities under social safety net programmes and established several help centres for them in different districts.

He suggested including the issue of people with autism in the national plan of action.

Brig Gen Fakhrul Ahsan, director of Military Intelligence Directorate; Sharmela Rassool, chief technical officer of UNDP, and Md Nazrul Islam, full-time member of NHRC, also spoke.

Grenades, ammunition found in N'ganj

Police found 12 grenades, 200 rounds of SMG bullets and 40 rounds of shotgun bullets, and a binocular in Purbachal Blue City in Rugganj of Narayanganj yesterday.

The recovery spot is some 400 yards on the east of the previous spot, said Ismail Hossain, officer-in-charge of Rugganj police.

On June 2, police recovered 62 submachine guns (SMGs), two binoculars, two rocket launchers, 44 SMG magazines, five pistols, 49 shells, two walkie-talkies, 42 hand grenades and other ammunition from a Rugganj pond.

Five SMGs were also found in Belabo union on June 3 while a rocket shell was found on June 7 in the same area.
