

Two murdered in capital

A driver of a human haulier driver was killed at Keraniganj early yesterday.

Deceased Imran Hawlader, 22, was a resident of south Bontokpara in Keraniganj.

Imran engaged in a scuffle with another human haulier driver Titu as Titu's vehicle collided with his near Babubazar flyover.

Imran stopped Titu after crossing the flyover and beat him. Meanwhile, Titu called his men who stopped Imran in Kadamtoli and "settled" the feud, said Imran Rana, a friend of the victim.

When Imran was going home after keep-

ing the vehicle in the garage around 9:30pm, he got a call from a person who told him to go near Sajeda Clinic in Kadamtoli.

As Imran went there, Titu and his aides stabbed him and fled the scene, Rana said.

Imran was admitted to a local clinic but later shifted to Dhaka Medical College Hospital around 12:00am where he died, Rana added.

In another incident, a woman -- Parvin Begum, 40, -- was allegedly beaten to death by her husband over a family feud in West Rampura area of the capital yesterday.

Police said the deceased's husband Monir Hossain is a drug addict. Monir is on the run, he added.

'Robber' killed in 'gunfight' with Rab

An alleged robber was killed in a "gunfight" with the Rapid Action Battalion at Arbania in the Sundarbans yesterday morning.

The dead, Abdur Rouf, 42, was the chief of Sundarbans-based robber gang "Choto Majnu Bahini," says Rab.

Enayet Hossain Mannan, company commander of Rab-1, told The Daily Star that acting on information, Rab members raided Jongla, Bhabra and Arbania areas in the Sundarbans in the morning.

Sensing their presence, Rouf and his cohorts opened fire on them around 9:30am. Rab members then returned fire,

triggering the "gunfight".

After the "gun battle", Rab members found Rouf lying on the spot. He was taken to Dacope Upazila Health Complex where doctors declared him dead.

Three days ago, members of "Choto Majnu Bahini" fired on some forest officials in Kalaboghi area, leaving forest official Shyama Prosad injured, said Rab official Mannan.

Two policemen were injured in the "gunfight" and they took first aid, the Rab official added.

Rab also claimed to have recovered a rifle, 15 bullets and a sharp weapon from the spot.

On August 8 in 2011, the ACC filed the Zia Charitable Trust graft case with Tejgaon Police Station accusing four people, including Khaleda, of raising funds for the trust from unknown sources abusing power.

According to the charge sheet of the case, Khaleda and three others abused power to collect Tk 6.19 crore for Zia Charitable Trust during the BNP-led government's tenure between 1991 and 1996.

Dr Momenuzzaman said, "Usually a patient had to stay in the hospital for at least seven to 10 days if an open heart surgery was performed."

"Whereas with TAVI done in a cath lab (catheterisation laboratory), a patient can go home in two to three days and can resume his/her normal activities within four to five days."

The hospital authorities said to have this procedure done in its Cardiac Centre, after a US-based heart device implant team visited the hospital and gave a clearance that the TAVI procedure can be done here.

Dr Jahangir Kabir, chief cardiac surgeon at the hospital, said the more a person gets older, the more they are at risk of aortic heart disease.

With old age, calcium deposit increases in heart valve and its movement ability goes down. Calcium deposit also damages the valve and restricts the amount of blood flowing through it. Patient starts showing symptoms of chest pain, breathlessness and fainting among others, due to it.

Doctors also said it is a deadly disease because these patients are at a high mortality risk.

The only remedy is an aortic heart valve replacement, which can be done through an open heart surgery. But elderly patients with other complications such as kidney and lung problems, or artery blockage might be at severe risks and not suitable for a conventional surgery.

Therefore in case of such patients, TAVI is a risk-free and life saving procedure done with simple sedation and local anaesthesia.

The babies were born on September 29 last year in a remote village in Paschim Dinia of Sunderganj upazila with the help of a local midwife. Shahida and Raju were not aware of having twins, since Shahida did not go through any ultrasonography (USG) procedure during her pregnancy.

Confused, the couple did not know what to do in such a situation. After five days, they took the conjoined twins to Gaibandha Sadar Hospital as their abdomens started to swell failing to pass stool. The hospital authorities referred the babies to DMCH the next day.

As the babies were too sensitive to undergo a major surgery, the DMCH doctors then conducted surgeries in the abdomens for letting the stool pass for the time being. The couple were then instructed to bring back the babies to the hospital when they turn six months old.

After six months, the babies were admitted to the hospital again. But the condition was still not favourable for conducting a surgery. Therefore, the doctors sent them back. This time, on July 15, the couple got the twins admitted to the hospital after the doctors gave them the go-ahead.

After months of preparation, fear, and sleepless night, the parents of the conjoined twins are hopeful that their daughters will live a normal life like other children.
