



Schoolboy killed by drug addict in-law

An eleven-year-old boy was brutally murdered allegedly by his cousin's husband while trying to save his father from the wrath of the drug addict in-law at Beparipara village in Nilokkhia union of Bakshiganj upazila under the district yesterday morning.

The deceased, Rana, son of Mozammel Haque of the village, was a Class IV student of Nilokkhia Government Primary School.

Police arrested Babu, 30, and his brother Omar Faruk, 18, sons of Abdus Salam of the same village, in connection with the murder.

Babu, son-in-law of Maskut, elder brother of the victim's father Mozammel, is a drug addict.

Babu often put pressure on Maskut to give him money to buy liquor, police quoted the

victim's family members as saying.

As Maskut and his brothers Mozammel and Golam Mostafa strongly objected to Babu's drinking habit and decided not to give him any money for the purpose, Babu got furious.

Babu and his men started beating his in-laws around 10:00am yesterday.

As Rana came forward to save his father, Babu hit him on the throat with a shabol (a sharp object used for digging earth), leaving him critically injured, said Mohammad Rubel Mia, officer-in-charge (Investigation) of Bakshiganj Police Station.

Rana died on the way to Bakshiganj Upazila Health Complex.

Informed, police rushed to the spot and arrested Babu and Omar Faruk, the OC said, adding that they sent the body to Jamalpur General Hospital morgue for autopsy.

Dyke collapse caused the flood

Locals blame negligence of WDB for inundation of 15 Lalmonirhat villages

Flood victims in 15 villages at Kulaghat union in Sadar upazila blamed the Water Development Board (WDB) for the collapse of a dyke along the Dharla river at Dakhin Shiberkuti village.

About 300 metres of the dyke collapsed on August 11, flooding the 15 villages, locals said, adding that WDB did not do the repair work of the dyke properly.

Maziron Bawa, 58, widow of late Soleman Ali of the village, said her two houses were washed away by floodwater when the dyke collapsed, and she along with her four-member family are passing their days under the open sky. "If WDB had done the repair work properly, the dyke would not have collapsed and my houses would not have been washed away," she said, adding that WDB is responsible for rendering them homeless.

Sonabhan Bawa, 62, said they lost their houses due to the negligence of WDB officials. "The government allocated money to save us from erosion by the Dharla river, but WDB officials did not use the money properly," she added.

"WDB officials, along with the contractor, misappropriated most of the fund without doing the repair work properly," said flood victim Syed Ali, 48. "There were a large number of bags filled with sand, but those were not dumped before the flood, so the dyke collapsed," he added.

Kulaghat Union Parishad (UP) Chairman Idris Ali said if all the bags had been dumped in time, the dyke would not have collapsed and so many villages would not have been flooded. "Negligence of WDB officials is responsible for collapse of the dyke," he alleged.

Contractor of the work, Karmokar Agency's proprietor Dulal Chandra Karmokar told this

correspondent to talk to WDB officials for information in this regard.

Sub Divisional Engineer of the district WDB Abullah Al-Mamun said repair work was done properly, but the Dharla river overflowed the dyke, so it collapsed. "First phase of the work costing Tk 13 lakh was completed in the last week of July, while only 20 percent of the work of the second phase, costing Tk 1,20,83,000, was done in the first week of August," he said.

Rejecting the allegation that negligence by WDB officials was responsible for the collapse of the dyke, Executive Engineer of district WDB Krishna Kamol Sarker said the GO bags filled with sand were not dumped as they had not been counted by the authorities.

Residents of the 15 villages urged the authorities concerned to investigate the matter and take necessary steps if WDB officials or the contractor are found responsible for collapse of the dyke.

Traditional boat race held

KISHOREGANJ BOAT CAPSIZES

Bodies of 4 missing people recovered

Police on Monday recovered the bodies of four people, who went missing in separate boat capsizes in Bhairab and Itna upazilas on Saturday and Sunday.

The deceased are Arun Banarjee, 28, of Debhata upazila in Sathkira, Gobinda Chandra, 35, of Patnitola upazila of Naogaon, Abdul Mazid, 55, of Ujarkanda village and Mohammad Ibrahim, 47, of Gojaria village in Itna upazila of the district.

Police recovered the bodies of Aurun and Gobinda from Meghna river in Bhairab about 10:30am.

The duo went missing when an engine boat with 10 passengers onboard capsized in the river on Saturday.

Meanwhile, the bodies of raw hide traders Mazid and Ibrahim, who went missing during a boat capsizing on Sunday night, were recovered from Alongjuri canal (a local water body) in Itna upazila around 10:00am.

Kishoreganj Additional Superintendent of Police Mohammad Rakib Khan said the four bodies were handed over to their respective family members.

Relief for flood victims

Over two thousand flood affected people in Sirajganj's Shahzadpur and Ullapara upazilas and Pabna's Sadar and Bera upazilas received relief materials in the last couple of days.

Dhaka Community Hospital in association with Mercury Malaysia, a Malaysian donor organisation, distributed foods items among the flood victims in the two districts.

The two organisations distributed relief materials at different villages in Shahzadpur and Ullapara upazilas of Sirajganj on Monday, while the flood affected people in Bera and Pabna Sadar upazilas received the support yesterday, said Waqar Hossain, director of the hospital.

Missing man found murdered

Police on Monday recovered the body of a 35-year-old man floating in a canal in Mathbaria upazila of the district, two days after he went missing.

The deceased Mohammad Dulal, of Betmore Rajpara village in the upazila, was a labourer at a timber market in Nesarabad upazila.

Quoting deceased's family members, police said Dulal went out of his house on the Eid day saying he would return in two days.

Later, his family members repeatedly tried to reach him over cell phone but it was found switched off. Officer-in-Charge of Mathbaria Police Station Tarikul Islam said.

Locals spotted Dulal's body floating in a canal at neighbouring Kalirhat village and informed the police, who went to the spot and recovered it.

The body bore several injury marks, the OC added.

Logs piled on schoolground

An influential person has been keeping huge logs on the playground of Kobi Jasimuddin School and College in Kajuri union under Sadar upazila for the last eight months, depriving the students of a place to play.

Students said the trunks were put on their playground last January during widening of the Badoepur-Saltha Road. They were told that the trunks would be removed within 15 days, but those have not been removed as yet, they added.

Headmaster Mizanur Rahman said, "Fakir Faruk Hossain, son of the School Managing Committee President, also former Chairman of Kajuri Union Parishad, Md Siddikur Rahman, kept those trunks on our school ground in January, saying that it would be only for 15 days. I asked him several times to remove them, but he did not pay any heed to my words."

Siddikur said, "I allowed Faruk to keep the trunks because he is my son. He said he would remove those within 15 days, but he has kept them there for eight months as he could not get a profitable offer for them."

District Education Office Porimal Chandra Mondol said, "I shall talk with the headmaster of the school as soon as possible."

Cops assault journo inside police station

Some members of the district Government Railway Police (GRP) allegedly beat up a cameraman of a private television channel in the GRP Police Station yesterday.

The victim is Al Amin Talukdar, 34, a cameraman of Jamuna Television.

Witnesses said Al Amin, who came to Dinajpur to celebrate Eid with his family members, was waiting at the platform of the station to collect tickets for returning to Dhaka when Assistant Sub-Inspector (ASI) of the police station Yousuf Ali, who was in plainclothes, pushed him from behind.

As Al Amin protested, Yousuf dragged him into the police station where the policemen slapped him indiscriminately and threatened to implicate him in drug peddling cases.

Al Amin told this correspondent that the policemen became furious when he identified himself as a video journalist. "They threw away my identity card when I showed it to them," he added.

Hearing about the incident, local media workers rushed to the spot and rescued Al Amin.

The victim filed a written complaint with the police station yesterday.

Officer-in-Charge of the police station Saidur Rahman said his department closed the ASI for the incident.

The journalists in the district condemned the incident.

Dinajpur Press Club President Swarup Kumar Bakshi said attacks on pressmen by members of law enforcement agencies have increased in the country recently. Torturing any person inside a police station is a serious offense, he added.

He hailed the prompt action of closing the accused ASI and urged the police to launch an investigation as more policemen were involved in beating Al Amin.

Television Camera Journalists' Association of Dinajpur also condemned the attack.

Mahananda, Teesta erosion on

The two rivers devour around 80 homesteads and make many homeless

Erosion by Mahananda river in Chapainawabganj and Teesta in Nilphamari has rendered a number of families homeless in the two districts in the last couple of days.

Our Chapainawabganj correspondent reports: Erosion by the Mahananda took a serious turn, devouring about 50 dwelling houses at Dewantola village under Sundarpur union in Sadar upazila of the district within a week.

Besides, about three-kilometre area of the river bank at the village is facing serious threat of erosion anytime.


Villagers said about 50 houses, farmlands, bamboo clusters and mango orchards have already gone into the Mahananda in the last couple of days.

People living in the area are shifting their homesteads from the erosion-hit village to safer places as the river is devouring fresh areas every day.

"As I do not have any other land, I took lease of a land from one of the villagers and erected a tin-roofed house there for my family," said Abdus Samad of Dewantola village.

Ekramul Haque of the village alleged that the Water Development Board (WDB) did not take necessary steps to check the erosion.

Meanwhile, locals urged the authorities concerned to take immediate steps to save
