Bridge connecting road collapses

Illegal sand lifting blamed

The approach road to the bridge over a canal on the old Sylhet-Dhaka road collapsed early morning yesterday following illegal sand lifting and incessant rain for the last three days.

Road communication between Sylhet and Dhaka was suspended yesterday following the collapse of the bridge over Chandi Cherra in Ramgonga area under Chunarughat upazila of Habiganj.

A running microbus fell into the gap between the bridge and the road early yesterday. Five passengers were injured and received treatment locally.

Deputy Divisional Engineer of the Roads and Highways Department (RHD) Hamidul Islam told this correspondent that a section of the old Dhaka-Sylhet road collapsed near the bridge on Sunday night due to heavy rain and surge of water from the hills.

It will take some time to repair the bridge, he said, adding that it will take three days to build an alternate road.

A good number of bridges have been damaged under the pressure of water and extraction of sand from rivers, making those risky for movement, he added.

Milon Mia, a college student of the area, said he has to suffer a lot as the road is badly damaged and crossing the bridge is risky.

Munem Mia, a CNG-run auto-rickshaw driver of Chandpur village, said they are facing financial loss due to the damaged bridge.

During a visit to the spot, this correspondent found villagers, including kids going to school, walking on the broken road amid risk of accident. The sufferings of the people increase when rainwater fills the potholes. Vehicular movement on the road has been suspended.

Bangladesh Paribesh Andolon's (Bapa) Habiganj unit General Secretary Tofazzal Sohail told this correspondent that one cause for the collapse is unabated illegal sand lifting by some local influential people. That has led to the erosion of agricultural land, including villages, of the area, he added.

Former head of the Department of Forestry and Environmental Science at Shahjalal University of Science and Technology Narayan Saha, told this correspondent that the main causes of the collapse are sand lifting and felling of trees.

It is important to stop sand lifting to prevent such kinds of accidents, he added.

Aman farming uncertain in Gaibandha, Dinajpur

Farmers in the dists fear fresh flood, face severe seedling crisis

Flood-hit farmers in Gaibandha have stopped planting Aman seedlings, fearing fresh flood as re-planted seedlings on vast lands in low-lying areas went under rainwater.

Meanwhile, Aman farming has become costlier for Dinajpur growers due to severe seedling crisis created by last month's flood.

As heavy downpour for the last three days again inundated low-lying areas in different upazilas of Gaibandha, fear-stricken farmers stopped planting the costly seedlings, reports our correspondent.

The farmers incurred huge loss this season, as they planted Aman seedlings twice earlier and they are now attempting to plant for the third time.

According to the control room of Gaibandha Water Development Board, 15 millimetres of rainfall was recorded during the last three days. Besides, increasing trend of water level was marked in the Jamuna and Teesta river basin areas. During the last 24 hours, water level in the river Jamuna

increased by 10 centimetres.

Landless and marginal farmers have given up the idea of fresh plantation of Aman seedlings, as they could not procure high priced seedlings from the market. So they are planning for Rabi crop farming.

"All seedlings on my five bighas of land were washed away by the floodwater. However, I again planted seedlings on two bighas of land, but they went under water," said Sontosh Kumar, a farmer of Kholahati village in Sadar upazila.

"We don't like to take risk of further plantation of seedlings with the increasing trend of water level in river basin together with heavy downpour," said Rafiqul Islam, another farmer of the village.

"Three days ago, we sold seedlings at Tk 400 to Tk 500 per pawn (80 bundles), but now there is no customer," said Idris Ali, a seedling vendor.

If such a situation prevails for the next few days, the seedlings will perish, causing huge loss, said Yasin Ali, another vendor.

In Dinajpur, severe Aman seedling crisis worries farmers in the

district. The situation was created due to last month's flood that washed away seedbeds, reports our correspondent.

The Department of Agriculture Extension in the district targets cultivation of Aman paddy on 2, 53,687 hectares of land.

Some people are bringing Aman saplings to Dinajpur from other districts like Bogra to meet the crisis, but it is too expensive, said farmers.

Mominul Islam of Galtabari village in Biral upazila said he planted Aman on an acre of land this season. He spent Tk 600 for seedlings. Flood washed away the seedlings. After flood, he purchased the same quantity of seedlings at Tk 12,000.

On the other hand, many Aman farmers sold their lands for low prices after floods.

Golam Mostafa, deputy director of DAE in Dinajpur, said such problem will not affect their rice production target this year. His office distributed sufficient seedlings among the affected farmers.

SINTHIYA RAPE, MURDER 2 on 6-day remand

A court here yesterday granted six days' remand for two accused in the case for rape and murder of seven-year-old Sinthiya.

Investigation Officer (IO) of the case Ashrafuzzaman produced accused Ahsan Habib and Majedul Huq Kaltu before the Senior Judicial Magistrate's Court of Ramesh Chandra Daga, seeking seven-day remand for each. The court granted six-day remand.

Earlier, police produced the arrestees before the court on September 2, but the court fixed September 11 for hearing.

Sinthiya Akhter, daughter of Salim Mia, a mason in Fulchhari upazila, and a Class I student at Fulchhari Model Government Primary School, went to the nearby restaurant for buying breakfast items on August 31 and had been missing since then, police said.

Her family members searched everywhere but failed to find her. Her body was found in a nearby pond the next day.

Police arrested Ahsan Habib, 22, and Majedul Islam, 28 of the same village on August 31, but could not arrest another Akram Hossain, 30.

Local people continued agitation demanding capital punishment of the perpetrators.

Drive is going on to arrest Akram Hossain, said AKM Ashrafuzzaman, officer-in-charge of Fulchhari Police Station.

Youth held after JMB suspects' confession

Rapid Action Battalion (Rab) arrested a youth on charge of connection with banned militant outfit Jamaatul Mujahideen Bangladesh (JMB) at Elenaga in Kalihati upazila under the district on Sunday night.

The arrestee is Mohammad Borhan Uddin alias Razib, 25, son of Nizam Uddin of Chinamura Madhyapara village in the upazila.

Rab also recovered a 0.9mm pistol and three bullets from his possession, said Bina Rani Das, commander of Crime Prevention Company-3 of Rab-12.

"On September 4 night, the elite force arrested JMB suspects Masum and Khokon from Masinda in the same upazila and seized an improvised drone, machetes, axes, and controversial Islamic literature from their possession.

"They told the investigators that they bought the machetes and axes from Razib," Bina said.

Train derails in B'baria

Four compartments, including the engine, of a Dhaka-bound intercity train derailed near Brahmanbaria Railway Station early yesterday.

The rail communication between Dhaka and the eastern zone of the country was disrupted for ten hours following the derailment. No casualty was reported.

The Dhaka-bound Turna Nishita Express train from Chittagong derailed at Ponoiut rail crossing around 4:00am, said Md Mainul Hoque, assistant station master of Brahmanbaria Railway Station.

Rail links of the eastern districts, including Chittagong, Sylhet, Noakhali and Chandpur routes with the capital, were restored through an alternative line, he added.

A new engine was connected to the train before leaving for Dhaka, he said.

The reason behind the derailment could not be known immediately, he said, adding that a four-member committee was formed to probe the accident.



Children raise fund for Rohingya kids
