



# Building on Bagerhat school playground

An influential person constructs the structure, defying order of the local administration

A local influential person is constructing a building on the playground of a secondary school, ignoring the order of the local administration and causing grievance among the teachers, students and guardians.

Headmaster KM Raju Ahmed said SM Ishaq Secondary School was established on 2.38 acres of land at Kaltala village in Chitalmari upazila of the district in 1963.

A month ago, Mithu Fakir, a local influential person, and his people started constructing a building on the south side of the school's playground, he added.

Over this incident, he filed complaints on September 10 with the deputy commissioner, superintendent of police, Chitalmari upazila nirbahi officer, officer in-charge of Chitalmari Police Station and secondary education officer, the headmaster said, adding that the administration stopped construction work until the matter was solved.

But, Mithu started the construction work again on October 10, ignoring the administration's order.

Class X students and many guardians said Mithu and his men are constructing the building by occupying the school's playground illegally.

They will carry out protest programmes if the grabbers are not removed from the school field, they added.

Mithu's brother Suman Fakir said the land is their ancestral property, and the school has recorded the land in its name illegally.

Officer-in-Charge of Chitalmari Police Station Anukul Sarkar said they have stopped the construction work and police have been deployed in the area to maintain peace and order.

## Sonia's family for removal of OC

Family members of schoolgirl Rahima Akhter Sonia, 14, who committed suicide in Panchagarh on October 10, demanded removal of the officer-in-charge (OC) of Tentulia Police Station for the sake of proper investigation of the case.

They made the demand at a press briefing at Kalamajodh village in Tentulia yesterday.

Sonia's parents Jaherul Haque and Selina Begum alleged that since the beginning they have been facing non-cooperation from the police, especially OC Suresh Chandra.

Despite being informed about the rape incident that led the girl to commit suicide the OC filed an unnatural death case and later delayed filing the case against accused Monsur Alam Rajon and Atikuzzaman Atik, they said.

Besides, OC Suresh also intervened in interrogation of the two accused, now on a five-day remand, to recover the obscene video footage, the family alleged.

On October 10, eighth grader Sonia committed suicide after the two culprits, who allegedly raped the girl, threatened to release the obscene video footage on the Internet.

Sonia's mother Selina filed a case with Tentulia Police Station on October 14, accusing Rajon, a ward boy of Tentulia Upazila Health Complex, and Atik.

On October 16, police sought to conduct autopsy again and appealed for a 10-day remand for the accused when they surrendered before the court.

## ROBBERY IN JOYPUHAT 6 fake DB men held while fleeing

Villagers caught six fake members of Detective Branch (DB) of police in Khetlal upazila of Joypurhat when they were fleeing after looting Tk 3 lakh from a man of Akkelpur upazila in the district on Wednesday.

At least five such incidents took place in Dinajpur, Joypurhat and Naogaon since last August, said the police officials in the districts.

Razzaqul Haidar of Belghari village of Akkelpur upazila in Joypurhat was returning home on a motorcycle after drawing Tk 3 lakh from a bank in Bogra's Dupchachia upazila on Wednesday afternoon when two cars blocked his way at Satni on Dupchanchia-Akkelpur road, witnesses said.

Introducing themselves as members of DB, the men from the cars blindfolded Razzaqul and left the spot with him.

Later, the gang dropped him at Kalishwar village after snatching the money.

On suspicion, locals chased the cars and caught those around four kilometres away. The angry mob at Hatshahar under Khetlal upazila set fire to one of the cars, gave the alleged robbers a good beating and handed them over to police.

The arrestees are Keramat Ali, 45, from Faridpur, Md Firoz, from Sirajganj, Ashrafur Islam, 34, and Sabuj Mia, 26, from Bogra, Yousuf Ali, 34, from Dhaka, and Yousuf Ali, 45, from Bhola.

Police seized Tk 86,000, three handcuffs, three keys and two cars from the gang and a case was filed, said Sirajul Islam, officer in charge (OC) of Akkelpur Police Station.

Earlier on October 8, a gang posing as DB men picked up Md Asaduzzaman Rashed, 35, at Morapukur refuelling station at Mobarakpur village in Patnitola upazila of Naogaon when he was returning from a bank after drawing Tk 17 lakh.

They picked him up into a microbus, telling him that he was accused in a drug peddling case.

The robbers snatched the money and dropped Rashed at a distant place.

A banana trader was stabbed to death at Laxmipur village in Rajbari Sadar yesterday morning.

The deceased was Zillur Rahman, 36, son of Md Joinal Abedin of the village.

The victim's brother Bablu Sheikh said, Zillur went to a tea stall beside their house around 8:00pm on Wednesday.

He left the stall following an anonymous call and remained missing since then. Later, his body was found at a nearby filed, said police.

Zillur was a drug addict and his fellow addicts might have killed him, said local people.
