RU FINE ARTS ADMISSION TEST Questions over questions

"What is the name of the greatest book in the world?" Students were asked to answer this multiple choice question (MCQ) at the entry test of Rajshahi University's fine arts faculty on Wednesday.

The question which had four choices -- A) The Holy Quran, B) The Holy Bible, C) The Holy Injil and D) Gita -- left the admission seekers surprised and baffled.

It was the 76th among 80 MCQs, each carrying 1.25 marks, on the question paper.

This particular MCQ, along with another controversial one from that paper, later triggered an outrage on the campus and criticisms in social media, with many blasting the university authorities for coming up with the "extremely communal" questions.

They also said the questions reflected the "radical mentality of the teachers concerned".

The other question was "When did the Myanmar army and the Buddhists launch an armed attack on the Rohingya Muslims?" It was the 41st MCQ on the question paper.

In the face of criticisms, the faculty's admission committee withdrew the questions yesterday, saying all the examinees would receive full marks for them. It, however, did not say who exactly was responsible for the incident.

Talking to The Daily Star, Atia Yasmin, an admission seeker, said she avoided answering the question on the "greatest book" as it made her totally confused.

"It was a strange question. Students of different faiths will answer it differently," she said.

Termining those who set the questions communal and irresponsible, another examinee, who wished not to be

Deploying army in polls possible under law: CEC

It is possible to deploy army during the next general election as per the existing electoral laws, Chief Election Commissioner KM Nurul Huda said.

The Election Commission has the jurisdiction to deploy army, and it will take the decision in this regard later, he said at a press conference at the EC office in the capital's Agargaon.

During the electoral talks with the EC, most political parties have expressed their opinions in favour of army deployment ahead of the next polls likely to be held in December 2018.

However, not all parties have agreed on what sort of power the army should exercise at the time.

Some want the army to have magistracy power while others want it as a striking force in case an untoward situation emerges.

The CEC said the existing electoral laws were enough to hold a free and fair election and there was no need for any new law.

Qatar moves to end modern-day slavery

Decides to introduce minimum wage for all foreign workers, scrap 'kafala' system

Qatar will introduce a minimum wage for all foreign workers as part of a reform initiative that the International Trade Union Confederation has termed a breakthrough towards ending modern-day slavery in the Gulf country.

The oil-rich nation has also decided to scrap the controversial "kafala" system that bans foreign workers from changing jobs or leaving the country at will.

The decisions made by the Qatari cabinet on Wednesday would ensure more freedom for foreign workers and allow them to have the necessary means to meet their living expenses.

The changes are good news for Bangladesh, as nearly 40 lakh Bangladeshis work in the Gulf country.

"This is a very welcome decision. Our workers will be benefited by this," Serajul Islam, labour counsellor at the Bangladesh Embassy in Qatar told The Daily Star over the phone.

There have been allegations that foreign workers don't get the wages promised before their recruitment by Qatari companies. The new minimum wage system would remove these problems, he said.

According to an Al Jazeera report, Qatari Labour Minister Issa al-Nuaimi said they would set up a "Workers' Support and Insurance Fund" which would ensure that overdue wages are paid to workers. And it would operate independently under the auspices of the cabinet.

Belgium-based International Trade Union Confederation (ITUC),

Three B'Baria cops sued on rape charges

Three police officials were sued on Wednesday on charge of raping a housewife in Brahmanbaria.

They accused are Inspector Kazi Mahfuzul Hasan Siddique, Sub-inspector Shadon Kanti Chowdhury and Assistant Sub-inspector Kamal Hossain of Chatalpar Investigation Centre in Nasimgang upazila, said sources at the district's Children and Women Repression Prevention Special Tribunal, where the case was filed.

Taking cognisance of the case, Judge Ahsan Habib ordered the chief judicial magistrate in Brahmanbaria to investigate the incident, said the lawyer for the woman from Balikhola village.

According to the case statement, some members

'Planet-engulfing' star discovered

A star that devours planets has been discovered by researchers who believe it could have already eaten 15 of them.

The planet-gobbling star Kronos and its sister Krios are both around 4 billion years old and are around 350 light-years from Earth.

Dubbed Kronos after the child-eating Titan of Greek mythology, the star is the clearest and most dramatic case yet of a sun-like star consuming its own planets.

"Even if our sun ate the entire inner solar system, it wouldn't come close to the anomaly we see in this star," said study co-author David Hogg, group leader for astronomical data at the Flatiron Computational Astrophysics (CCA) at the Flatiron

Hasina lucky, 'didn't have to appear in court'

Says Khaleda

BNP Chairperson Khaleda Zia yesterday said Sheikh Hasina had been lucky that she, unlike her (Khaleda), never had to appear before a court.

"Honourable court, you know that various types of cases on charges including corruption, abuse of power, irregularities and extortion were filed against Awami League President Sheikh Hasina on different occasions... But unlike me, she never had to appear before court," Khaleda said.

But between 2001 and 2006, when the BNP was in power, Hasina appeared before courts on multiple occasions at hearings of graft cases filed against her.

Yesterday, Khaleda read out part of a long and emotional statement in self-defence at the hearing of Zia Orphanage Trust corruption case at a special court in Dhaka.

The 72-year-old former premier said she has been appearing before the court

A band of brothers for gold trafficking

Three brothers joined arms to conduct a gold smuggling business that spanned across Dhaka, Dubai, Masqat, Kuala Lumpur, Jeddah and cities in India. Their empire was built on the complicity of airport staff, cabin crew and even the cleaners.

Using encrypted messaging technology and far-sightedness and keeping their heads down, the trio conducted their business under the noses of law enforcers for years, while growing in size.

The information came to light when Detective Branch (DB) of Police arrested three members of a syndicate on Tuesday night.

The trio, arrested from the capital's Airport area, is Faruk Ahmed, 38, Meer Hossain, 28, and Md Shahin, 21. A team of DB officials found 80 gold bars weighing 9.33 kg in their possession. The DB officials also seized a car (Dhaka Metro Ga-22-1419) from them.

The estimated price of the gold seized is approximately Tk 4 crore, said Shaikh Nazmul Alam, deputy commissioner (north) of DB police.

On Tuesday, one of the siblings admitted to the investigators that for the last three years the syndicate have been smuggling in gold. The trio would smuggle in gold twice a week by bribing some cabin crew, airport staffs and cleaner.

"Usually the syndicate members bring five to six kg in every shipment, meaning at least 15 kg a week, from four countries," said a DB investigator who interrogated the arrestees. To avoid detection, they would curtail their operations at times of heightened security vigilance, an official said wishing anonymity.

To dodge law enforcers, they used to communicate among them using "WeChat", an online messaging application.

Faruq's elder brother, Masud Karim Rana, who is now on
