The students of Kangalichheo Dakkhinpara Government Primary School in Sakhipur upazila have been deprived of proper education as Selina Akter, the lone assistant teacher of the institution, has been conducting classes of all six classes for the last three months.

The institution has no peon or bell man, and besides taking classes and conducting office works, Selina has been performing other duties like cleaning the classrooms and ringing the bell.

According to upazila primary education office, the school was established in 1973 and nationalised in 2013 and it has a total of 70 students in all six classes from pre-primary to Class V.

Since the retirement of the headmaster of the school in 2015, it was running with two assistant teachers.

After one of the two assistant teachers retired on February 13 this year, Selina was transferred to the school from adjacent

Akandapara Government Primary School on deputation the same day.

Since the other senior assistant teacher went on retirement on August 13, Selina has been running the school single-handedly.

Due to shortage of teachers, education of the school kids has been badly hampered, guardian Ananda Mondol, also a member of the school managing committee, said.

During a recent visit, this correspondent saw Selina taking three classes simultaneously moving from one class to another.

"Although our Primary Terminal Examination is knocking on the door, we could not take necessary preparations due to shortage of teachers," Urmi Mondol, a Class V student of the institution, said.

"I have already informed my higher authorities of the matter," Sakhipur Upazila Education Officer Mohammad Aminul Haque said, adding that he will send two teachers on deputation as soon as possible.

# Two BCL men on fresh remand

Senior Judicial Magistrate's Court in Barguna's Patharghata yesterday granted three more days remand for two local Bangladesh Chhatra League (BCL) leaders when police produced them before the court seeking a fresh five-day remand.

Senior Judicial Magistrate Monjurul Islam granted the fresh remand in a case filed for killing an unidentified girl after rape.

Police produced Patharghata College unit BCL President Ruhi Anan Danial and General Secretary Saddam Hossen Chotto before the court after ending of their two-day remand, said Patharghata Police Station Officer-in-Charge (OC) SM Ziaul Haque.

The OC said they also sought five-day remand for college unit Organising Secretary Mahidul Islam Rayhan and Patharghata upazila unit Assistant Secretary Mohammad Mahmud.

The court, however, fixed November 19 for next hearing on the remand prayer for Mahidul and Mahmud, he added.

Earlier, police arrested the four BCL leaders on November 13 in Barguna's Patharghata upazila for their alleged involvement in killing the girl after rape around three months ago.

Meanwhile, police produced the four before the court on November 13 with a five-day remand prayer for Ruhi and Saddam. The court granted them a two-day remand each and sent Mahidul and Mahmud to jail.

Police recovered the body of an unidentified girl from a pond near Patharghata College on August 10.

Police arrested three other BCL leaders on Sunday night at their homes in Patharghata town after Mahmud gave a confessional statement before the Senior Judicial Magistrate's Court on Sunday morning about the murder and rape, the OC said.

The identity of the victim is yet to be known, he added.

## House torched over land dispute

Members of Hindu community are in fear

Criminals set fire to the house of a Hindu family in Arulia village under Chitalmari upazila of the district on Tuesday, sending ripples of fear through the community there.

Owner of the house Hrishikesh Mandal alleged that Faruk Sheikh and Naresh set fire to his house after locking the doors from outside, planning to kill him over a land dispute.

Hrishikesh said he had a dispute over land for a long time with local residents Faruk and Naresh.

Chitalmari Police Station Officer-in-Charge (OC) Ankul Chandra said unidentified people torched the house of Hrishikesh Mandal.

Police are investigating who set fire to the house, but they have not been able to communicate with Faruk and Naresh to find out about the incident, the OC said.

Hrishikesh said he and his wife went to sleep as usual, adding that a gang of criminals came to his house at around 1:30am and locked the doors from outside. Then they set fire to the house, he added.

"Seeing the fire, I and my wife got up and came out after breaking the door.

The flames completely burnt two of my rooms and another nearby house of Sunil Mandal," he said with tears in his eyes.

Chitalmari Upazila Nirbahi Officer (UNO) Abu Sayeed said that they visited the house of Hrishikesh and gave him four bundles of tin.

"I have asked the police to find out who set fire to Hrishikesh's house," the UNO said.

Chairman of Sadar Union Parishad (UP) Nizam Uddin said that Tk 10,000 in cash was given to Hrishikesh from the UP. He demanded investigation of the incident.

## Elderly man beaten dead during arbitration

An elderly man was beaten to death by his neighbours yesterday over a trifling matter during a village arbitration in Bhuapur upazila.


The deceased is Asgar Ali Boati, 76, of Dighikatuli village at Aloa union in the upazila.

Quoting witnesses, police said a tree of Abu Bakkar was tilted towards the house of his neighbour Asgar recently. The arbitration was arranged after a quarrel occurred between the two families when Asgar asked Bakkar to cut down the tree, police added.

Bakkar and his men started beating elderly Asgar indiscriminately with sticks just after giving statement at the arbitration, leaving him dead on the spot, police said.

Police recovered the body and sent it to the Tangail General Hospital morgue for autopsy.

Matin, inspector (investigation) of the police station.

Police yesterday circulated images and footage of the four assailants among journalists. They were seen in the footage captured in closed circuit television cameras (CCTVs) of the building.

Police said they were trying to identify and arrest the killers.

Shajahan Shaju, additional deputy commissioner of DB police, said it was a pre-planned murder and footage of the attackers' movement gave the impression that they were professional criminals.

He said some of the attackers were in masks. "We need support from the city residents to identify the attackers."

In the footage, it was seen that an assailant in a cap entered the recruiting agency office around 7:49pm. The three others followed him moments later.

The attackers completed the killing mission in just around three minutes and left the spot, said Shajahan.

The three injured were undergoing treatment at United Hospital yesterday.

**THE KILLING MISSION**

Ali Hossain, a peon at the agency, said the assailants stepped into the office asking, "Where is the boss?"

"I was in boss' room at that time to give him drinking water. Suddenly, an attacker entered and asked me to keep mum, brandishing a gun. Then he shot at my boss twice from a close range."

Two other assailants entered the room next to the owner's and opened fire at three staffers, Hossain added. The attackers left the office immediately.

Baju, a security guard of the building, said he saw four people entering the building casually. They came out two to three minutes later and walked away.

A little later, he heard someone knocking at the gate on the ground floor.

Opening the gate from outside, Baju saw the bullet-hit people lying on the floor. He soon called in nearby people and took the injured to the hospital.

An autopsy was carried out on Siddik's body at the Dhaka Medical College morgue yesterday evening. Morgue sources said a bullet hit his chest while another his right arm.

His family later took the body to his village home in Tangail for burial.

Talking to The Daily Star last night, Ruhul Amin Shawpon, secretary general of Bangladesh Association of International Recruiting Agencies (Baira), said Siddik was an eminent manpower businessman.

He strongly condemned the killing and demanded the government provide additional security to Baira offices as its members were feeling insecure following the murder.

Meanwhile, Home Minister Asaduzzaman Khan yesterday said the recent killings and incidents of disappearances didn't indicate that the country's law and order deteriorated.

"I don't think the recent killings and incidents of disappearances indicate any deterioration in law and order," he told reporters after inaugurating a morgue at Shaheed Suhrawardy Medical College Hospital in the city.
