society representatives strongly condemned the remand of Titu, sending him to jail and taking confessional statement from him forcibly.

Barrister Sara Hossain, honorary executive director of BLAST, said Titu was arrested over an alleged Facebook post, but keeping him in jail without granting bail was improper.

He is not that harmful that if released, he would commit a crime, she added.

"What is the logic behind keeping him in custody for more than three weeks without any judgement?" she asked.

Nijera Kori Coordinator Khushi Kabir said, "We know the process... how the law enforcement agencies take confessional statements."

The attacks on the religious minority are recurring due to an ineffective role of law enforcers and a lack of justice, she said.

The government has to clarify why such untoward incidents take place, she added.

Rana Dasgupta, general secretary of Bangladesh Hindu-Buddha-Christian Oikya Parishad; Syeda Rizwana Hasan, chief executive of Bela; and Shamsul Huda, executive director of ALRD; also spoke.

DU student continues hunger strike despite falling ill

Demanding Ducusu election, Dhaka University student Walid Ashraf continued hunger strike for the third consecutive day yesterday although he is falling ill.

A master's student of social welfare and research, Ashraf began the strike on Saturday on the Eternal Memory premises.

He again said he would continue the strike till death unless the authorities meet his demand.

"The authorities have taken necessary steps to hold registrar graduate election as per the direction of the High Court but did not take any step to hold Ducusu polls," he told The Daily Star.

Meanwhile on the third day, some university students joined him to express solidarity with his demand.

No DU official came to visit him.

No election to the Dhaka University Central Students' Union (Ducusu), which had played a pivotal role in many democratic movements, has been held since 1990.

prayer, the IO said Sohel was directly involved in Dipan's killing and he needs to be remanded so whereabouts of other people responsible for the killing could be known.

Dipan, 43, publisher of Jagriti Prokashoni, was hacked to death inside his office on the second floor of Aziz Cooperative Super Market in the capital's Shahbagh on October 31, 2015.

Later, his wife Razia Rahman filed the case accusing unknown persons.

In a confessional statement given before a magistrate on November 6, Sohel said he and seven others participated in the killing of blogger Avijit Roy, a Bangladesh-born US citizen who was hacked to death on Dhaka University campus as he along with his wife Rafida Ahmed Bonya was returning from the Ekushey book fair on that day in 2015.

Ansar Al Islam is said to be the Bangladesh chapter of al-Qaeda in Indian Subcontinent (AQIS).

Detectives have so far arrested three members of banned Ansarullah Bangla Team -- Moinul Hasan Shamim alias Sifat alias Samir alias Imran, Abdus Samad alias Abdus Sabur and Khairul Islam in the Dipan murder case. They confessed to the killing before magistrates on different dates.

children die from hunger," Penny said yesterday.

"This looks like ethnic cleansing. The Burmese military must end this inhumane violence and guarantee unrestricted humanitarian access so aid can reach those in need in Burma. Any return of families to their homes must be safe, voluntary and dignified."

"Global funding to support the Rohingya people will only meet urgent needs for the next 100 days -- we cannot turn our backs on those trapped in crisis," the minister said, adding, "Other countries must follow our lead and do even more to help children overcome the trauma of war, reunite them with their families and give a future to the next generation."
