

# JUBO DAL MAN MURDER Brother sues 10 people

The elder brother of slain Juba Dal leader Harunur Rashid Chowdhury filed a murder case with Sadarghat Police Station on Monday night accusing ten named persons.

On Sunday, Harunur was shot dead in front of his business establishment in the port city's Kadamtali area allegedly by local Bangladesh Chhatra League and Juba League men.

Harunur's brother Humayun Chowdhury filed the case mentioning the names of ten persons, said Sadarghat Police Station's Inspector (Investigation) Ruhul Amin.

The accused are Md Alamgir, 30; Md Kaisar, 25; Md Nur Nabi, 34; Md Hridoy, 28; Mosharruf Hossain Liton, 28; Md Sarif, 35; Md Jasim, 29; Tanvir Hossain Shaon, 30; Towkir Hossain Sejan, 30; and Hazi Md Salauddin, 40.

However, no one was arrested in this connection till Tuesday evening, said the inspector.

According to the case statement, the ten along with some others tried to establish supremacy in Kadamtali area by taking the control of truck and covered van business, and

# CU ANTHROPOLOGY DEPT Final exams pending for three months

The anthropology students of Chittagong University yesterday demanded that their pending final year honours examination be held immediately.

Around 50 students raised the demand at a human chain at Shaheed Minar on the campus.

Sources at the anthropology department said the fourth year examination was supposed to be held on August 20, 2017.

Sajeda Kakoli, one of the students, said, "Our friends from other departments have already filled out forms to attend their examination."

"What is our fault?" she said.

Campus sources further said the date for the examination was deferred following a writ petition filed with the High Court by department teacher Prof Rahman Nasir Uddin, challenging a decision to relieve him of the exam committee duties.

been found against the founders, its former teachers and guardians of students, he said.

The attorney general also said many of the people involved in the Lakehead Grammar School went to Syria for joining Islamic State. A militant, who has been killed in a drive of law enforcers at Mirpur recently, had involvement with the school, he added.

On November 7, the Dhaka district administration sealed off the two branches of the school and shut down all activities of the school, based on allegations that it was patronising militancy, promoting extremist views and providing support in the formation of militant outfits.

On November 15, following two separate writ petitions filed by the proprietor of the school, and guardians of 12 students, the HC ordered the authorities to reopen Lakehead Grammar School's Dhanmondi and Gulshan branches within 24 hours, declaring the closure of the school by the government illegal.

Following two petitions filed by the government, Justice Syed Mahmud Hussain, chamber judge of the Appellate Division on November 16 stayed for four days the HC verdict.

On November 19, the Appellate Division of the SC extended till yesterday its earlier order, which stayed its chamber judges' order that halted the HC verdict.

kilometres of the area making it difficult for the locals, especially children, to breathe, a local ward councillor Saleh Ahmed told The Daily Star yesterday.

However, the intensity of odour reduced when the customs officials started to destroy fruits in a 30-foot deep pit using more kerosene and bleaching powder among other chemicals, said customs officials.

The officials managed to destroy 13 containers of fish and fruits yesterday after assuring the locals of shifting the place for disposal soon, said Arefin Jewel, additional deputy commissioner (port) of Chittagong Metropolitan Police.

Nearly 2,000 tonnes of goods, including onion, ginger and garlic, which were brought in refrigerated containers between 2010 and 2016, will be destroyed to increase the capacity of the port.

Judge Md Akhtaruzzaman of the Special Judge Court-5 recorded her statements and fixed December 19 for arguments in the case.

The court also fixed the same date for placing her self-defence statement in the Zia Charitable Trust graft case.

before the court and got bail in the cases. On November 30, the same court issued arrest warrants against her as she failed to appear before it in due time.

In the two decades since 1990, the Awami League played a responsible role in protecting democracy and people's voting rights, and the path for grabbing power illegally has been stopped through the 15th amendment to the constitution, she said.

In her message, Khaleda Zia said democracy is not secure now. Through holding the January 5, 2014 polls, the incumbent government trapped the people again in "the rule of one party" and endangered people's rights, she alleged.
