

HC asks ex-BNP minister Altaf to surrender before trial court

The High Court yesterday directed former BNP home minister Altaf Hossain Choudhury to surrender before the trial court in Barapukuria coal mine corruption case.

The HC passed the order after rejecting a petition filed by Altaf in 2008 seeking cancellation of the trial proceedings in the case filed by the Anti Corruption Commission. ACC lawyer Khurshid Alam Khan told The Daily Star that the HC in 2008 stayed the trial proceedings. Yesterday, the HC vacated the stay order and discharged the rule, the ACC lawyer said. The ACC on February 26, 2008 filed the case with Shabbagh Police Station accusing BNP Chairperson Khaleda Zia and 15 others of causing a loss of Tk 159 crore to the state exchequer by awarding a contract for the operation of Barapukuria coal-mine to a Chinese company. Barrister AM Mahbub Uddin Khokon appeared for Altaf Hossain Choudhury.

He said this was even more important in the densely populated countries like Bangladesh where chronic diseases were rising. Referring to a digital biosensor for detection of liver damage, Prof Liepmann said one could test the liver condition at home by using the tool. A number of other diseases can also be detected in a similar way where nurses were not required. Abdul Matin Emon, CEO of Doctorola, an online-based healthcare management firm, said there were some four doctors for each 10,000 people in Bangladesh, which

was quite low. Moreover, most doctors are urban-based, he said. As a result, the patients crowd the city hospitals. The use of telecommunication and online-based services can reduce much of the travel time, suffering and expenses of the patients, Matin said. "If truly necessary, a patient can surely come to visit a doctor in Dhaka, but the follow-up can be done via online communication," he said. Jullia Quazi, managing director of US-based firm Healthcare and Life Sciences, said healthcare was going to be a major agenda for the "Digital World" in the future.

Kavin Holub of Augmedix, a US-based firm working for technology-based documentation for patients and health systems, said maintaining the information of patients digitally and making them available to doctors in need was one of the most important tasks in healthcare management. Traditionally, doctors have to spend a lot of time collecting patients' information, but this task can be better managed by digital documentation, he said. Faruk Alam, country director of medical device company Medtronic Bangladesh, also spoke.
