the Explosive Substances Act. During the BNP-Jamaat rule until October 2006, the investigators misled

the probe to protect real culprits, according to the prosecution. During the tenure of the last care-

taker government, charge sheets in the

Hannan's statement, told Hanif's two cases were filed against 22 people, including Abdus Salam Pintu and 21

Huji men, including Mufti Hannan. However, the investigators could not identify the mastermind and the sources of the grenades used in the attack and an extended probe was launched in 2009 in this regard, the prosecution said. A supplementary charge sheet was submitted against 30 accused, including Tarique, Lutfozzaman Babar and former Jamaate-Islami secretary general Ali Ahsan Mohammad Mojaheed, in July 2011.

In March 2012, the tribunal indicted 52 accused, including Tarique, on murder charges, while 41 accused were indicted in the case filed under the Explosive Substances Act.

The 11 accused -- including three former IGPs, three ex-CID officials, two former senior police officials, Khaleda's nephew Duke, and two former army officers ATM Amin and Saiful Islam Joarder -- in the murder case were not implicated in the explosive case. The court conducted the two cases simultaneously.

The names of Jamaat leader Mojaheed, Mufti Hannan and another Huji man were dropped from both the cases as they had been executed in different cases.
