

'MORAL DEGRADATION'
DU teacher
relieved of
academic duties

The Department of Educational and Counselling Psychology of Dhaka University yesterday relieved a female teacher of all kinds of academic duties for her alleged moral degradation.

The decision of relieving the lecturer for one year was taken in an academic meeting of the department on Tuesday, said Prof Mehtab Khanam, its chairperson.

On last Saturday, she was found locked at the office of Prof Akib Ul Haque of psychology department. She was later rescued by the university authorities.

Prof Akib's wife the next day submitted written complaints to DU vice chancellor and chairperson of educational and counselling psychology department, demanding punishment for the duo. The department took the decision after she was found guilty in the investigation.

The decision about Prof Akib will be taken today, said Prof Nasreen Wadud, chairperson of psychology department.

Too little done for a freedom

"When we brought her to the emergency ward of CMCH, she was referred to the orthopedic ward but we got no bed there," said Alauddin Khokan, publisher of her books, adding, "She was left on the floor for around three and a half hours."

"When we informed the staff that she is a freedom fighter and she should have privilege in treatment, the staffers started to misbehave with us."

"Then I informed the civil surgeon and he contacted CMCH authorities to provide her a seat, but in vain," he said, adding, "At last we shifted her to a private clinic as she became restless."

Doctors said Roma was suffering from diabetes, breathing problems and hypertension.

Alauddin, who apparently looks after the ageing fighter, said it is very difficult to afford her treatment cost in the private clinic, Medical Centre Hospital. Doctors said she need to undergo an operation which would cost around Tk 3.5 lakh.

Dr Azizur Rahman Siddique, civil surgeon of Chittagong, said when Alauddin communicated with him on that day, he immediately called the deputy director of CMCH to take necessary steps for her treatment.

"Alauddin did not contact me further, so I thought she was undergoing treatment in CMCH," he said.

Samirul Islam, associate professor of orthopedic surgery of CMCH, how-

ever, denied the allegation of negligence in treatment of Roma Chowdhury.

"When we cannot provide seats to patients, we arrange beds for them on the floor."

"Had she waited till the morning, we could have provided her a bed or a cabin," said Samirul.

He also said, "Her right femur has a fracture...as she has already some other complications including diabetes, breathing problem and hypertension, her condition is unstable."

"A surgery is a better option for her recovery," he added.

Contacted, CMCH Director Brig Gen Jalal Uddin said he did not know about the matter.

"Maybe, I was in Dhaka at that time," he said, adding, "According to an order of the health ministry, a seat always remains preserved for freedom fighters but in CMCH, freedom fighters are being admitted almost every day."

"We cannot provide all with seats but we take equal care of all," he added.

STRUGGLE OF ROMA

Born in 1941, Roma obtained her MA in Bengali literature from Dhaka University in 1961.

When the Liberation War started, her husband asked her to take refuge in India. But she chose to stay in

Bangladesh, and he left her for good.

On May 13, 1971, the Pakistani army tortured her and torched her house at Popadia in Boalkhali upazila.

Her five-year-old eldest son died of pneumonia on December 20, 1971, and three-year-old second son also died after two months. Out of grief and also out of the respect for freedom fighters, Roma started walking barefoot from 1972.

Though she briefly stopped walking barefoot for health condition, she resumed the practice on December 16, 1998 when her youngest son was killed in a road accident. She never wore any footwear afterwards.

Roma Chowdhury has written 18 books. Of those, "Ekattorer Janoni" depicts her struggle during the Liberation War.

Her other books include "1001 Din Japoner Padyo", "Vab-Boichitre Rabindranath", "Agun Ranga Agun Jhora" and "Ashru Veja Ekti Din".

Her publisher Alauddin said the Jatio Muktiyoddha Council contacted Roma a few years back to enlist her name as freedom fighter and give her related allowance, but she declined the offer, saying she was self-sufficient from selling her books.

Roma now lives with her third son, Jahar Lal Chowdhury, in a two-room rented house in Cheragi Pahar area of Chittagong city.

11 cop impostors held

The Detective Branch (DB) of Chittagong Metropolitan Police (CMP) yesterday arrested 11 imposters in Chittagong who used to rob or mug people impersonating DB and police officials.

They are: Haradhan Das, Mamun Uddin alias Mamun, Md Kaiser Hamid alias Raju, Md Jahidul Azam, Shahed Rana alias Shahed, Shawkat Ali, Selim Mahmud, Rezaul Karim, Md Rubel, Jahidul Karim, and Md Masud, aged between 28 and 51 years, said DB police.

Detectives also recovered two motorcycles, a CNG-run auto-rickshaw, two jackets with "DB CMP" embroidered on it, a handcuff, a toy gun, and a walkie-talkie from their possession which they used during robbery, said Deputy Commissioner (DC) (North) Hasan Md Shawkat Ali of DB at a press briefing at CMP headquarters in the port city's Laldighi area.

Raju is the gang leader while Selim was a ward councillor under Rangunia upazila

during a caretaker government, said the DC.

Additional Deputy Commissioner (ADC) (North) Md Kamruzzaman of DB told The Daily Star that the gang on December 28 picked up Imtiaz Uddin Imon, a student of City College Chittagong, in their auto-rickshaw from Love Lane area when he was returning home after withdrawing Tk 1.67 lakh from a bank.

They looted the money and dumped Imtiaz on Kadamtali flyover. The victim lodged a complaint with Kotwali police on Tuesday.

The gang mainly were active in Riazuddin Bazar and New Market areas as a number of financial institutions and banks are located there and perpetrated some 12 robberies and mugging, said the ADC.

Of the arrestees, Mamun is an accused in a murder case while Jahed is an electronic businessman who used to work as an informer for the gang, said police officials.

Rezaul was a first-grade contractor but got involved with crime after incurring losses, police sources added.

the bank dismissed him.

In 2015, the ACC had filed 56 cases over the embezzlement of Tk 2,036 crore from BASIC Bank. The investigation into the siphoning off of the rest of the money was underway. Monayem Khan is accused in 35 of the cases.

Fourteen BASIC Bank officials, including four deputy managing directors and three general managers, have been dismissed over the scam.

One of the best-run banks until 2009, BASIC Bank was entangled in financial irregularities following Sheikh Abdul Hye Bacchu's appointment as its chairman that year.

In 2012 and the next year, Bangladesh Bank detected the embezzlement of Tk 4,500 crore from the bank.

However, Bacchu was not made accused in any of the cases.

On November 23 this year, the ACC summoned the former chairman and the 10 ex-directors for interrogation. He was interrogated on December 4 and December 6.

Earlier, on August 18, a three-member Supreme Court bench while holding hearing in two loan scam cases expressed discontent at the ACC for not naming Bacchu and the bank's ex-board members.

Delowar Hossain, officer-in-charge of the police station, said Abdus Sattar, the owner of the land where the landslide took place, is in jail in another case. He will be shown arrested in this one also, he said, adding that they are trying to locate the other accused.

When asked about the names of the accused, Sub-inspector Juned Ahmed, the case's investigation officer, said they cannot disclose the names of the accused for the sake of investigation.

Meanwhile, rights activists through a joint statement, issued yesterday, urged the government to take strict measures against the traders to stop the illegal stone extractions.
