The students of Khodayerpur Government Primary School in Pabna Sadar upazila had to pay Tk 120 each for getting government approved textbooks meant for free distribution as the school authorities collected the amount for arranging annual sports programme.

An inquiry committee headed by Assistant Thana Education Officer (ATEO) Kamruzzaman Khaza visited the school on Tuesday and asked the school authorities to return the money to the students.

School managing committee (SMC) President Md Abdul Bari himself was present during the book distribution and he took the amount from the students for arranging sports."

Asked about the matter, Abdul Bari said, "Every year we collect small amounts from

the students during this time so that we can arrange sports and cultural programmes in the school. Otherwise it would be quite impossible for us to collect funds for such programmes."

"As per instruction of the officer who visited the school, we have started returning the

ATEO Md Karuzzaman Khaza said, "Free textbook distribution means it is totally free. "My two children read in the school. I Taking any money for the purpose is illegal have paid Tk 120 and requested the school and the school authority cannot refuse to give books to any enrolled student under any pretext."

"I have visited the school on Tuesday "Now I have come to the school for tak- and found the truth of the allegation of free distribution. I have asked the school Md Apan Ali, a Class IV student of the authority to return the collected amount immediately," he said.

A man allegedly killed his two and a half years old daughter by throwing her on the ground at Sreepur village in Harinakundu upazila yesterday.

Accused Liton Mandal of the village went into hiding soon after the incident, said Officer-in-Charge of Harinakundu Police Station Asaduzzaman.

Police said Liton locked in an altercation with his wife Sadia Khatun as the latter picked up Tk 50 from his pocket.

At one stage of altercation, Liton took away his daughter Lithi from Sadia's lap and threw her on the ground, leaving her dead on the spot, said the OC.

TANGAIL COUPLE MURDER

Detectives still clueless sisters, surrenders

Over five months have passed after the gruesome murders of retired schoolteacher in Tangail Anil Kumar Das and his wife Kalpana Rani Das, but investigators could not make any significant headway in the case till now.

Due to the delay in investigation progress, victims' son Nirmol Kumar Das and expatriate daughter Anjana Das are becoming frustrated as police are yet to identify their parents' killers.

On July 27 last year, police found the couple dead, tied to a sack of bricks, at the bottom of a drainage well beside their house in Sadar upazila.

Following a case filed by deceased's son Nirmol with, police detained Anil's two stepbrothers -- Ratan Das and Swapan Soumitra -- for quizzing and later shown them arrested. The duo were produced before a Tangail court on August 1 with a seven-

day remand prayer. After hearing on August 2 and 3, the court granted a three-day

remand for them and the case was shifted to Detective Branch (DB) of police the same day. The detectives, however, got no important information from the two that

can resolve mystery of the murders.

Of the two arrestees, Swapan obtained bail from the court on December 28. For quizzing, police also picked up six youths--Shahid Momen, Bhajan

Sheel, Mofiz Uddin, Minju Miah, Khokon Bhuiyan and Dulu Miah--from Rasulpur village, suspecting their involvement in the murders.

The murders were committed in a pre-planned way, Officer-in-Charge of Tangail DB police Ashok Kumar Sinha said, adding that they are yet to idenday, said Office-in-Charge of Baliakandi tify the killers but hope to unearth the mystery soon.

Stalker hacks two

Two school going sisters were hacked allegedly by a stalker at their residence at Khodmagura village of Rajbari's Baliakandi upazila on Tuesday night. After the incident, accused Alauddin

Sarder, 16, son of Mokter Sarder of Khamar Magura village, surrendered to police. He is a student of Class X of Notapara High School. The injured are Jamila Akhter, 16, a stu-

dent of Class X, and Hasnahena, 15, a student of Class IX of the school, and daughters of Abdur Rahman Mridha. They were admitted to Faridpur Medical College Hospital.

The victims' father said Alauddin used to stalk Jamila and offered her love proposal several times.

"As Jamila refused his proposal, Alauddin came to our house with a sharp weapon and hacked my two daughters indiscriminately while they were reading around 8:00pm," said Mridha.

They were later rushed to the hospital.
