# AL seeks removal of magistrates

Leaders of Chittagong Awami League and its associate organisations at a rally yesterday demanded removal of the two magistrates who led the mobile court that allegedly dismantled "sculptures of three leaders" at Jahur Hawkers' Market in the port city on Wednesday.

The rally, held in front of the market, was organised by Jahur Hawkers' Market Traders' Association.

Khorshed Alam Sujan, vice president of Chittagong city unit AL, alleged that Chittagong City Corporation wanted to set up three shops in the area. So it "dismantled" the under-construction sculptures of Bangabandhu Sheikh Mujibur Rahman, former CCC mayor ABM Mohiuddin Chowdhury and late Awami League leader Jahur Ahmed Chowdhury, he alleged.

"The market is not owned by the CCC," he claimed. "Why would the traders need permission to build a sculpture there? They were building the sculpture out of their love for Bangabandhu," he said.

"We want them [the magistrates] to be stand released...," he added.

Pointing to the CCC mayor, Sujan said a person is trying to build shops where the sculptures were being built. "The sculptures of the three leaders will be rebuilt there and we will volunteer..."

On the other hand, the magistrates said a flat slab was being built over a drain along with a wall beside it at the entrance of the market. And, there were "no underconstruction sculptures" when they were conducting the drive, they added.

## Prosecute police members who break the law

Demands ASK, saying withdrawal is not enough

Ain o Salish Kendra (ASK) yesterday demanded prosecution of the police members who had been breaking the law.

Expressing grave concern and condemnation over such reckless behaviour by some of the law enforcers, the legal aid and human rights organisation in a press release said only withdrawing the accused members from their duties is inadequate and setting a negative example in the society.

Quoting media reports, the ASK said in the most recent incident, on January 9, the brother of a schoolgirl was locked up and beaten up by police members at Khairabad Baintola police outpost in Botiaghata of Khulna.

Besides, an incident of a forced marriage and torture on a woman by an additional police commissioner of Dhaka Metropolitan Police (DMP) also surfaced over the last several days.

The incident in Khulna took place when the brother of the girl went to the outpost to complain about his sister being subjected to regular harassment by its police members on her way to school.

The members of the outpost were with drawn and her brother was released after locals besieged the police outpost.

Although the accused members of the law enforcers including DMP's Additional Commissioner Mizanur Rahman were withdrawn, such serious allegations against the protectors of the law are deplorable and unacceptable. And the accused therefore have to be tried under the law of the land, the ASK release read.

# Abuzz with teachers' agitation

New alliance vows to take to streets for nationalisation; madrasa teachers' protest enters third day with 74 more falling ill; MPO-listed institutions threaten hunger strike

Shadhinota Shikkhak Karmachari Federation, the biggest platform of 16 organisations of teachers and employees, yesterday said they will hold various programmes including campaigns, human chains, and submit memorandums to press home their demand.

At a press conference in the capital's Jatiya Press Club yesterday, the leaders of the federation said they will not hold any programme in February because of the SSC examinations, which will begin on February 1.

No bar on recruitment tests at three state-run banks

Bangladesh Bank can conduct the exams now, says lawyer STAFF CORRESPONDENT

The Supreme Court yesterday cleared the way for the authorities concerned to hold the tests for recruiting senior officers, officers and cash officers in three staterun banks -- Sonali, Rupali and Janata.

Chamber Judge of the SC's Appellate Division Justice Syed Mahmud Hossain stayed for six weeks a High Court order that halted the examinations scheduled for today.

He ruled that the recruitment procedures of the candidates as per the 2016 circulars will not be affected by this order. Justice Hossain delivered the order following a petition filed by Bangladesh Bank.

Following the order, the Bangladesh Bank can take initiatives to conduct recruitment tests for all eight banks including Sonali, Rupali and Janata banks today, Barrister Munirujjaman, a lawyer for Bangladesh Bank, told reporters.

Attorney General Mahbubey Alam appeared for the central bank.

Following a writ petition, the HC on January 7 stayed the recruitment tests.

It also issued a rule asking the respondents to explain within four weeks why they should not be directed to hold the exams as per the 2016 circulars, which were separately issued by the BB, before holding the recruitment tests based on the 2017 circular.

#### Providing Legal Aid SCLAC seeks list of prisoners aged

The Supreme Court Legal Aid Committee (SCLAC) has sought for the list of and the details about the prisoners aged more than 75 years from the authorities of five jails including Dhaka Central Jail.

The other four jails are Kashimpur-1, 2, 3

The SCLAC yesterday sent a letter to the senior superintendents of the jails, asking them to provide relevant updated information about the aged prisoners (under trial or convicts) so that it (SCLAC) can provide legal aid to them.

In the letter, the SCLAC said it has learnt from various sources that there are old persons aged more than 75 years in some jails in different cases.

The SCLAC has been working for ensuring legal aid service at the Supreme Court. It believes that the jail authorities' cooperation in establishing legal aid service will continue, Ripon Paul Sku, coordinator of SCLAC, told The Daily Star citing the letter.
