

Reinvestigate Manik Saha murder case

Demand journals

Journalists and well-wishers of slain journalist, rights activist and freedom fighter Manik Saha have urged the government to take initiatives to ensure capital punishment for the real culprits behind the murder.

They made the demand on Thursday in a letter sent to the attorney general seeking justice through a reinvestigation, and identifying the planners, financiers, patrons and killers. Tomorrow is the noted journalist's 14th death anniversary.

Copies of the letter, signed by ptbnews.com Chief Editor Ashis Kumar Dey, on behalf of the "Sangbadik Manik Saha Hatyar Bicharparthi Sangkhubdha Sangbadik Samaj", was also sent to the prime minister, law minister, home minister, president's secretary and registrar of the High Court division of the Supreme Court, says a press release received yesterday.

The letter said the November 30, 2016 verdict sentencing nine people to life-term imprisonment was based on an imprudent investigation and flawed charge sheet.

Also, the charge sheet did not include the planners, financiers and patrons of the murder.

Manik Saha, a stringer of BBBC Bangla Service and senior reporter of daily New Age and the Dainik Sangbad, was killed in a bomb attack on January 15, 2004 at Chhoto Mirzapur near Khulna Press Club.

Woman found dead at CU

Police yesterday recovered the body of a 60-year-old woman, who had been missing since January 9, from the Chittagong University campus.

Senoara Begum, wife of Bedarul Islam, of Raozan upazila's Gohira area, was not mentally stable, said Hathazari police, quoting her family.

Police sent the body, which did not bear any injury mark, to Chittagong Medical College Hospital morgue for autopsy. An unnatural death case was lodged.

Youth held over Facebook post

Narayanganj police yesterday arrested a youth allegedly over a Facebook post demeaning Islam.

Hasan-ul Islam, 29, was arrested in Meghna Ghat area of Sonargaon. He is the son of a brick kiln owner in Fatullah.

Md Shahjalal, inspector (investigation) of Fatullah Model Police Station, said some photos "demeaning Islam" was posted from Hasan's Facebook account.

Following the incident, agitated locals started gathering in front of a local mosque after the Juma prayers on Friday, demanding Hasan's arrest.

Police also detained Hasan's elder brother on that day for interrogation, he said. "We are looking into the matter and filing of a case is underway," said the inspector.

3 held with 494 turtles

The Forest Department and Rapid Action Battalion in a joint drive arrested three people with 494 turtles of rare species at Zero Point of the city early yesterday while those were being smuggled to India.

Madinul Ahsan, divisional forest officer of Wildlife Management and Nature Conservation Division, said they seized a pickup containing eight drums of the turtles with the help of Rab-6.

The turtles were being taken to Satkhira from Barisal to smuggle those to India, he said. The turtles will be released in Gazipur's Bhawal National Park.
