

STRUCTURES ON TURAG SC stays HC demolition order

The Supreme Court yesterday stayed a High Court order that earlier directed the authorities concerned to demolish the structures set up along the foreshore of the river Turag at different places in Gazipur. The Appellate Division of the SC also asked the HC bench led by Justice Moyeenul Islam Chowdhury to hear and dispose of the rule on this issue by February 28. The five-member bench of the Appellate Division headed by Justice Md. Abdul Wahhab Miah, who is performing functions of the chief justice, passed the order after hearing a petition filed by owners of 10

Clarification

United Hospital Limited has given a clarification on a report published in The Daily Star on January 12 under the headline "TK 21CR TAX DODGING: ACC sues United Hospital MD". In the clarification, United Hospital said it filed a writ petition with the High Court in 2012, claiming the holding tax amount to be illogical and exorbitant as the hospital was charged Tk 20 per sq ft for its basement and Tk 100 per sq ft for other floors. Prior to that, United Hospital had appealed to the city corporation quoting holding tax of a hospital (commercial land) where they were initially charged Tk 15 per sq ft for basement and Tk 50 per sq ft for other floors, which were brought down to Tk 5 and Tk 16 respectively upon their appeal, it mentions. Thereafter, the High Court issued an injunction on the matter in response to the writ petition filed by United Hospital and the issue is under the purview of the High Court and the decision about the holding tax is still pending, it added. Referring to the FIR on which basis the report mentioned that United Hospital has used different tricks to dodge the holding tax, the rejoinder said the hospital is pursuing the court to seek redress. It also mentioned that managing director of United Hospital Faridur Rahman Khan is a law-abiding, tax-paying citizen of the country.

like no seat plans, shortage of seats, use of mobile phones, starting the exam late and question paper leak. Sajjad Khan, a candidate in one of the two centres, said some of the exam halls were crammed with candidates. "Many examinees took cell phones inside the halls. It was total chaos." Another candidate, Saddam Hossain, said the authorities should retake the entire exam instead of rescheduling it for the candidates of the two centres. Earlier, the demonstrators gathered in front of the Bangladesh Bank around 10:00am to organise the rally, but they left the place following police action. Later, they formed a human chain and demonstrated in front of the press club. Afterwards, they brought out a procession in the Dhaka University area and continued the demonstration till 1:00pm. The candidates will also stage a sit-in protest at Shahbagh around 10:00am today. The recruitment test for the posts of senior officer, officer and cash officer was held at 61 designated exam centres in Dhaka to fill over 1,663 vacancies at the banks. Contacted, Mosharraf Hossain Khan, member secretary of the selection committee, said the demands made by the protestors were irrational. "What is the necessity of retaking the entire examination? It was a trial of the final written exam. Of the two lakh candidates, about 17,000 will be selected through the MCQ test for the final exam," he said. They [the protestors] want to file a case to halt the recruitment process, he alleged.

investigation officer of the case, handed over the probe report, statement of the potential prosecution witnesses and other documents to the Chief Prosecutor Office. Zahid Imam, conducting prosecutor of the case, said he filed a three-month time petition with the tribunal to scrutinise the documents and if satisfied with those, then they will press charges. Agency's co-coordinator Sanaul Huq said Musa was involved with Muslim League before the war but joined Jamaat and subsequently Razakar Bahini as the war broke out. Musa went into hiding, most provably in India, after the war but returned to Bangladesh after the political change-over in 1975, Sanaul said. The senior investigator said Musa tried to hide his original age and even gave false information about the ages of his children in a bid to shrug off the war crimes allegations. Meanwhile, the International Crimes Tribunal-1 directed its registrar office to publish advertisements in two national dailies asking a fugitive from Khulna to appear before it. As per the order, Nazrul Islam, one of the seven accused from Batighata upazila, has to appear before the tribunal by March 6, said Prosecutor Sabina Yesmin Khan Munnir. Prosecution on November 16 last year pressed four charges against seven persons in a case filed for allegedly committing war crimes. Other six accused -- Shahar Ali, Amzad Hossain Hawlader, Mozahar Ali Sheikh, Atiar Sheikh, Motasim Billah, and Kamal Uddin Goldar -- are in jail. The charges include killing, abduction, looting, arson and deportation, she said.
