TACKLING NCDS Deal inked with UK orgs

BSS, Dhaka

Aimed at helping Bangladesh tackle Non-Communicable Diseases (NCDs), several United Kingdom-based agencies yesterday signed an agreement with some local health organisations.

The UK-based agencies, under the Cambridge Programme to Assist Bangladesh in Lifestyle and Environmental Risk Reduction (CAPABLE), are University of Cambridge, University College London and University of Aberdeen.

The local institutes are Bangabandhu Sheikh Mujib Medical University (BSMMU), Institute of Epidemiology Disease Control and Research (IEDCR), International Centre for Diarrhoeal Disease Research (icddr), and National Heart Foundation Hospital and Research Institute (NHFH&RI).

The agreement, a five-year initiative, was signed at a hotel in the capital, with National Prof Brig (ret'd) Abdul Malik in the chair.

BSMMU Vice Chancellor Prof Dr Kamrul Hasan Khan, Dr John D Clemens and IEDCR Director Prof Meerjady Sabrina Flora were also present.

"The project would develop and evaluate practicable and effective interventions that expose major environmental and lifestyle risk factors against NCDs and promote health in the country in an acceptable, sustainable and cost-effective manner," said Dr ASM Alamgir, senior scientific officer of IEDCR.

HC verdict on death reference, appeals today

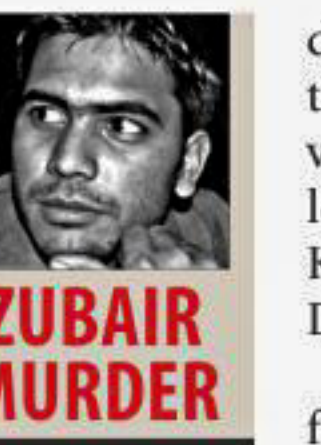

The High Court is set to deliver its verdict on the death reference and appeals in the sensational Zubair Ahmed murder case today.

The death reference and appeals have been included in today's cause list of the HC bench of Justice Bhabani Prasad Singha and Justice Mustafa Zaman Islam for the judgement.

If a lower court sentences any person to death in a case, its judgement is examined by the HC through hearing arguments for confirmation of the death sentence. The case documents and judgement reach as death reference to the HC from the lower court in seven days after the latter delivers the verdict.

The HC bench on January 9 fixed yesterday

day for delivering its verdict, but the bench did not announce the verdict, as Justice Mustafa was on leave, Deputy Attorney General KM Zahid Sarwar Kazal told The Daily Star yesterday.

Zubair Ahmed, an honours final-year student of English department at Jahangirnagar University, was tortured and stabbed allegedly by some Bangladesh Chhatra League activists on January 8, 2012. He succumbed to his injuries in a Dhaka hospital the following day.

A Dhaka court on February 8, 2015, sentenced five accused to death and six others to life imprisonment for the killing.

The convicts, who are now in jail, filed separate appeals with the HC challenging the trial court verdict.

Mother, daughter found hanging

A woman and her two-year-old daughter were found dead in their house at Sabujbagh in Dhaka yesterday morning.

The deceased were identified as Shantona Begum, 22, wife of Mamun, and her daughter Mahfuza, said Abul Kuddus Fakir, officer-in-charge of Sabujbagh Police Station.

Police primarily suspected that the mother committed suicide after killing her baby.

Shantona might have committed suicide as her husband eloped with her younger sister two days earlier, the OC quoted locals as saying.

The couple and their daughter lived in a tin-shed house in Sabujbagh since last five years, said their neighbour Monir Hossain.

The bodies were found hanging from the ceiling at around 7:30am yesterday, he added.

The Dhaka Medical College Hospital (DMCH) doctors declared them dead and sent the bodies to the morgue for autopsy.

Shantona's younger sister Swarna moved with them three months ago in search of a job at an RMG factory.

Mamun and the girl left the house on Sunday without informing anyone, Monir said, adding that Shantona was upset after her husband and sister eloped.

Meanwhile, the duo was arrested from the capital's Uttar Khan at 6:00pm, said Abul Kuddus Fakir, officer-in-charge of Sabujbagh Police Station.

"The duo has been taken into custody and are being interrogated" the OC said.

DB arrests 2 over killing of driver

Also recovers his stolen auto-rickshaw; arrests 4 others for BRTA documentation forgery

The Detective Branch (DB) of police yesterday arrested two people for allegedly killing a driver of a CNG-run auto-rickshaw and recovered the stolen vehicle from Mirpur area in the capital.

On January 13, the driver, Iskandar Ali Howlader, 40, was found dead in Khejur Bagan area of Sher-e-Bangla Nagar and his vehicle was stolen.

On information, police arrested the two -- Mohammad Liton, 45, and Mohammad Jashim, 28 -- in Shah Ali area and recovered the stolen auto-rickshaw from their possession, said Abdul Baten, joint commissioner of DB.

During primary interrogation, the arrestees admitted their involvement in the killing and theft, he said while addressing reporters at DMP media centre.

The arrestees said they hired the auto-rickshaw from the international trade fair site for Farmgate and after establishing a good rapport with Iskandar, they convinced him to join them for a cup of tea.

After reaching Farmgate, the arrestees gave Iskandar a cup of tea that had been secretly mixed with powerful sedative tablets.

As the driver lost consciousness, the two took him along in the same auto-rickshaw and left him near a drain in Khejur Bagan area, said the DB joint commissioner.

Golam Mostofa Rashed, additional deputy commissioner of DB, said the gang had been stealing CNG-run auto-rickshaws for the last three years. "We've got names of other members of the gang and we're conducting drives to arrest them."

In a separate raid, the DB arrested four people from Shahbagh area in the city for allegedly making fake documentation of Bangladesh Road Transport Authority (BRTA).

No evidence found against

accusing Khaleda Zia, her eldest son Tarique Rahman and four others for misappropriating over Tk 2.10 crore that the trust received as grant for orphans via a foreign bank.

Of the six accused, Khaleda, former BNP lawmaker Salimul Haq Kamal and businessman Sharfuddin Ahmed are on bail while the others, including Tarique, are absconding.

Besides, on August 8, 2011, the ACC filed the Zia Charitable Trust graft case with Tejgaon Police Station accusing four people, including Khaleda Zia, for abusing power in raising funds for the trust from unknown sources.

In his argument, Ahsan Ullah said in 2006, Sharfuddin Ahmed took Tk 2.10 crore as advance from Zia Orphanage Trust as part of a deal to sell his Ashulia land to the trust. The land however could not be sold to the trust after a caretaker government backed by the army took over power in 2007.

Ahsan Ullah also said in 2012, Sharfuddin returned the money, Tk 2.10 crore, in favour of Zia Orphanage Trust after he received a notice from a Dhaka court in this regard.

"Therefore, the allegations of embezzlement of money from the Zia Orphanage Trust fund is totally misconceived and has no iota of evidence," he argued.

Although the court yesterday exempted Khaleda Zia from personally appearing before the court, a close aide of the BNP chief told The Daily Star that she will appear before it today.
