The High Court yesterday granted anticipatory bail to writer, poet Farhad Mazhar and his wife Farida Akter for eight weeks in a case filed against them for "giving a false statement" to police and court.

The HC also directed them to surrender before the trial court eight weeks

The HC bench of Justice Obaidul Hassan and Justice Krishna Debnath passed the order after hearing a petition filed by Farhad and his wife.

Lawyer M Asaduzzaman stood on behalf of the

petitioners. On December 28 last year, Mahbubul Haque, inspector of the Detective Branch of police, lodged the case with Adabar Police

Station. The DB official also investigated an abduction case filed by Farhad's wife after he went missing on July 3 last year.

Mahbubul submitted a probe report before a Dhaka court on November 14, saying that Farhad had "staged the abduction".
