

Amid hunger strike 8 community health workers suspended

UNB, Dhaka

Eight community health care providers (CHCPs), including the convener and chief adviser to the central committee of Community Health Care Providers Association (CHCPA), were suspended on Saturday.

The order came as they remained absent from their duties while they were staging a hunger strike demanding nationalisation of their jobs.

Community Based Health Care (CBHC) Director Dr Abul Hashem Khan issued the suspension letters citing "long absence from work and influencing others" for strike as the reasons.

The suspended CHCPs are Sahidul Islam, working at Dohar as well as the convener of the central committee; Kamal Hossain Sarkar of Kapasia in Gazipur and chief adviser to the committee; Asad Uddin Liton, Mohiuddin, Salma Yesmin, Mokammel Haque, Sahin Sarkar and Mahmuda Khanam Shimu.

Sahidul Islam told the news agency that "this is the most heinous incident for the CHCPs of Bangladesh".

Meanwhile, the hunger strike of CHCPs stepped into its fourth day yesterday, asking for nationalisation of their jobs. The strike came in sequel to their five days' sit-in in front of Jatiya Press Club.

The agitating workers said they will continue the strike till their demand is met.

ICT fixes March 15 for probe report submission STAFF CORRESPONDENT

The International Crimes Tribunal-1 yesterday directed the prosecution to submit an investigation report, if any, on March 15 in a case filed against a Jessore man for allegedly committing crimes during the Liberation War in

Yesterday was fixed for submitting the report but Prosecutor Zead Al Malum sought three more months.

Accused Siddiqur Rahman Gazi, 68, from Harergati village in Jessore's Monirampur upazila, is now in jail.

Siddiqur, an alleged subcommander of Razakar Bahini under Monirampur Police Station, was shown arrested in the case on December 15, 2016. The probe against Siddiqur started on August 22, 2016 and the case's investigation officer already "found his involvement" in killing during the Liberation War. Siddigur's name was in a Razakar list prepared by the district administration, the

JUBO LEAGUE MAN HARUNUR MURDER

No visible progress in 2 months

Two months have passed since Jubo Dal leader Harunur Rashid Chowdhury was shot to death by a group of alleged Bangladesh Chhatra League (BCL) and Jubo League activists in Chittagong city on December 3 last year, but there is no significant progress in the case as of now.

Even the investigators are yet to recover the firearm used in the murder, much to the frustration of the family members.

Police said the investigation has been going on at a slow pace as they could not arrest the suspects -- the 10 suspects whose names were mentioned by family members during filing the murder case, have secured anticipatory bail from the High Court (HC).

Talking to The Daily Star, Officer-in-Charge (OC) of Sadarghat Police Station Mohammed Nezam Uddin said, "All the 10 suspects in Harunur murder case have secured anticipatory bail from the HC after the case was filed; therefore, police could not arrest

or interrogate them." "The firearm is yet to be traced out; however, we are investigating the case from a different angle to dig out the motive behind the murder and recover the firearm," said the OC.

Harunur's brother Humayun Chowdhury filed the murder case against 10 named and some unnamed persons with Sadarghat Police Station.

According to the case statement, the suspects are Md Alamgir, 30; Md Kaisar, 25; Md Nur Nabi, 34; Md Hridoy, 28; Mosharraf Hossain Liton, 28; Md Sarif, 35; Md Jasim, 29; Tanvir Hossain Shaon, 30; Towkir Hossain Sejan, 30; and Hazi Md Salauddin, 40. Of the suspects, Mosharraf Hossain

Liton is a resident of the city's Moriccha Para area and backed by expelled city BCL leader Saiful Alam Limon and local councillor Golam Mohammed Jobayer, said locals.

Police sources said Alamgir allegedly provided the firearm to be used in the killing mission. The others are involved with the politics of either BCL or Jubo League. After the murder, police arrested Jasim on December 17 in connection with the murder, but he later walked out from jail securing bail in the murder case.

Another person named Faisal was also detained from the city's Halishahar on December 31 in the murder case scrutinising the footage of the murder incident. But he was later released as his involvement was not

found, said police. Meanwhile, the family expressed discontent at the current status of the

Harunur's brother Humayun said, "Police did not record the First Information Report (FIR) the way we wanted -- specifying 10 people instead of filing the case against unnamed persons. This actually spoiled the merit of the sensational murder case."

"The former OC Morzina Akter of Sadarghat Police Station misled us during filing the case, paving the way for the accused to secure bail," he alleged, adding that the accused are now roaming free.

Inspector Morzina Akter has been transferred to Special Branch of Chittagong Metropolitan Police (CMP)

Contacted, she brushed aside the allegation. She said she had asked Harunur's family to include unnamed persons in the FIR so that police could widen their search and interrogate more people in the murder case.

On December 3 last year, Harunur was shot dead by six to seven youths from a tail of a procession organised by Sadarghat thana Jubo League and Awami League to celebrate the Unesco's recognition of the historic March 7 speech of the Father of the Nation.

After the murder, family members, co-workers and business leaders

Technology adding a new flavour

providing the readers with e-book facilities in this year's book fair.

Bengal Publication is one such publisher. They have an app called "Bengal e-Boi".

The app requires opening up an account. "With the account, anyone can read at least 200 e-books for free while some of the books require purchasing through bKash or banking system," said Mohammad Riyad, a volunteer at the stall.

However, many readers are still not accustomed to e-books.

"I use e-book when I travel... at times reading e-books hurt my eyes. So I still prefer physical books," said Sazia Afrin, a former student of Dhaka University. Suriya Jesmine, a private job holder, was

looking for books for a friend. "E-book is nice but you cannot gift an e-book to your friend. Besides, there's something special about holding a new book, the way it smells ... "

The e-book publishers are using various payment methods for the books while price range also varies.

For example, the app "Boi Ghar" is free to download with around a thousand books in their collection. The price of the books ranges

from Tk 10 to Tk 25. Payments can be made through Banglalink or Robi SIM cards.

Zakir Hasan of "Sheiboi" app said the

reason they had set up a stall at the book fair is to interact with the readers, especially the youth. Meanwhile, many publishers, who do

not have e-book services, have introduced online delivery facilities. One such is "Muktadhara", one of the oldest publication houses. They deliver books through Rokomari.com.

The government is also utilising technology for encouraging the youth to read.

In front of "Burdwan House", there is a stall of the government's a2i programme, promoting a website called "Kishor Batayan" -- dedicated to children where they can learn, play and share creative ideas.

Jalal Ahmed, member secretary of the book fair arrangement committee, said, "Technological advancement has added a new dimension to the fair."

"In near future, the book fair will adapt more technology. But it won't affect the spirit of the fair. We will always uphold our culture through the fair," said Jalal, also a director of Bangla Academy.

foreign labour markets for the Bangladeshis. Skilled and disciplined workers are in high demand


abroad and without increasing the number of workers, the country's earnings can be multiplied by sending skilled and experienced workers overseas, Gowher added.
